On 11/29/2021 narcotics officers were conducting surveillance on two individuals suspected of dealing drugs in Stokes County. The narcotics officers conducted a traffic stop at Andy's Market in Germanton, NC and through their investigation, found the individuals with drugs and stolen property from South Carolina. The narcotics officers contacted Captain Johnson with the Criminal Investigative Division (CID), who was able to obtain a search warrant for the suspects place of residence on Young Rd. Located at the residence was a quantity of methamphetamine, cocaine, marijuana, pills, and drug paraphernalia, along with additional stolen property from the State of Kentucky and Forsyth County, NC. Captain Johnson noted that many other potential construction type items were there, but unfortunately, without serial numbers or identification markings, it is extremely difficult to determine if the items are stolen and if so, from where. "We are always glad when we can help a victim get their property back", says Sheriff Joey Lemons. Sheriff Lemons goes on to say, "I encourage everyone to make sure you have noted the serial numbers, owner engraved information, and pictures of anything of value, just in case someone takes your property. Having those identifying numbers and pictures helps all law enforcement nationwide work together to get stolen property back to its owners." Both individuals have been charged with multiple drug offenses and charges related to being in possession of stolen property. On 11/30/2021 inquiry was made by the court about an attorney and their next court date is set for December 6th.
