During the month of January 2022, the Stokes County Sheriff's Office received reports of Breaking and Entering into to 2 local businesses in the Germanton and Walnut Cove areas of Stokes County. "Businesses are having a hard enough time right now and then this happens to them. The businesses in our county are working hard to provide a valuable service and we will continue to work hard to catch those that commit these crimes against them", says Sheriff Joey Lemons. Two of the three suspects, Harley D Shinault and Donald W McGee have been arrested in Forsyth County. Currently the Sheriff's Office is still looking for the third suspect, Bobby Joe Tilley. These break-ins had in excess of 20,000.00 dollars worth of damage and merchandise taken. A 3-month long investigation by the Sheriff's Office Criminal Investigative Division, working with the Winston Salem Police Department and the Forsyth County Sheriff's Office, has led to these 3 suspects being charged with the following offenses:
