The Department of Health and Human Services, Division of Health Benefits hereby provides notice of its intent to amend the Medicaid State Plan to apply to Dental procedure code D9230 (Inhalation of Nitrous Oxide/Analgesia, Anxiolysis). Effective May 12, 2023, the current temporary rate increase of 40% will be extended through June 30, 2023.
