Chairman McHugh called the meeting to order.

Commissioner Mabe delivered the invocation.

GENERAL GOVERNMENT-GOVERNING BODY-PLEDGE OF ALLEGIANCE

Chairman McHugh invited the citizens in attendance to join the Board with the Pledge of Allegiance.

GENERAL GOVERNMENT – GOVERNING BODY-APPROVAL OF MINUTES

GENERAL GOVERNMENT-GIS/MAPPING-AERIAL PHOTO/TOPO CONTRACT

GIS Administrator Jake Oakley requested the Board's approval/acceptance and authorization for final payment to Sanborn of Colorado for the completion of Color Aerial Photography Ortho's and Topographic Data. Administrator Oakley concluded that all phases of the contract have been successfully completed and all services delivered as stated in the contract. Director Tuttle noted that Homeland Security type grants were becoming available and a dedicated EOC location is an essential item in the application process. Mr. Tuttle requested the Board's approval to establish the 3rd floor of the Administrative Building as the Emergency Operations Center (EOC) for Stokes County.

GENERAL GOVERNMENT-INFORMATION SYSTEMS-UPDATE

Information Systems Coordinator Dianna Fulp presented an overview of the functions and responsibilities of the Information Systems Department.

Ms. Fulp noted future projects for the County Web Page: Permits for Planning and Health Departments and Update Web Page from Publisher to Front Page to enhance the Web Page.

Commissioner Joe Turpin suggested possibly using high schools students who were enrolled in Web Page classes to help with new enhancements to the Web Page in order to free up staff time.

Ms. Fulp updated the Board with Tax Office update concerning the Hewlett Packard 3000 MPE Unix Server. The support for this server will end December 2006. Ms. Fulp noted that this would be a very costly project.

Interim Tax Assessor Wren Carmichael noted that the 2005 Revaluation would have to be completed before any conversion could take place.

Vice Chairman John Turpin noted if there was a possibility that tax payers could be able view personal property accounts.

Finance Director Julia Edwards noted that this was being considered at the present time.

GENERAL GOVERNMENT-REGISTER OF DEEDS-UPDATE/WEB PAGE

Register of Deeds Kathy Young presented the Board with information concerning the new Register of Deeds Website that recently went live on February 3rd. (<u>www.stokescorod.org</u>)

Funding for this project is provided from the Automation Enhancement and Preservation Fund which was setup by the Legislature effective 1-1-2002. (10% of Register of Deeds Fees collected)

Ms. Young presented the Board with information detailing the amount of fees collected by the Register of Deeds and number of documents recorded since July 1, 1997.

Ms. Young requested the Board's approval to use Automation Enhancement and Preservation Funding to purchase a new computer for the Register of Deeds' office. As present, the computer is almost completed full, and constantly giving the Department problems.

Commissioner Inman suggested the possibility of establishing a second display at the original site selection which was the 2nd Floor Lobby of the Stokes County Government Center upon completion of the display in the Commissioners' Chambers and the possibility of raising the funding for the second display.

Chairman McHugh suggested finding out the total cost of the display, any problems from the judicial system in placing a duplicate display in the lobby of the Government Center, and the plan for acquiring the funding for a duplicate display after the completion of the display in the Commissioners' Chambers.

RESOLUTION BY THE BOARD OF COMMISSIONERS FOR THE COUNTY OF STOKES IN REGULAR SESSION ASSEMBLED FOR THE ESTABLISHMENT AND POSTING OF A DISPLAY OF HISTORICAL DOCUMENTS

WHEREAS, the Board of Commissioners for the County of Stokes (hereinafter the Board) desires to acknowledge the importance of those principles which were fundamental to the foundation of the legal codes and governmental systems for the United States of America, the State of North Carolina, and the County of Stokes; and;

WHEREAS, the Board further desires to recognize and affirm the historical importance of preserving these principles and the place which they have occupied in our national, state, and local heritage, and;

WHEREAS, the Board further desires to preserve and display for the education and benefits of the citizens of **Stokes County** a collection of documents embodying these principles and reflecting the heritage of our nation, state, and county;

NOW, THEREFORE, BE IT RESOLVED, that the Board does hereby authorize and direct the posting of the following historical display:

1. Declaration of Independence. The Declaration of Independence was signed on July 4, 1776, by fifty-six representatives of a new nation proclaiming itself to be the United States of America. Its publication not only announced its freedom from the "political bands" which had connected it to Great Britain, but, more importantly, set forth the fundamental proposition on which this nation was founded: "that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness — that to secure these Rights, Governments are instituted among Men, deriving their just Powers from the Consent of the Governed."

The document presented in this display is a facsimile of the original.

2. United States Constitution. Adopted in 1789, the Constitution of the United States replaced the Articles of Confederation that had governed our nation following the victory over the British in the American Revolution. The United States Constitution provided the Framework by which we chose to govern ourselves. From its preamble, which set forth the goals for which it was established — order, justice, and liberty — to the checks and balances of its three branches of government and its vesting of ultimate power in the people themselves, it remains to this day a time-honored blueprint for the greatest

form of government ever devised.

The document presented in this display is a facsimile of the original.

3. Bill of Rights. The first ten Amendments to the Constitution, known as the Bill of Rights, were ratified effective December 15, 1791 at the insistence

of many who felt that the Constitution itself did not adequately safeguard the rights of the people to be protected from the potential abuses of an all powerful

government as had been the case with the American Colonies under the rule of Great Britain. The rights established under the first ten Amendments which

have now been made applicable to the States through the 14th Amendment, embody many of those freedoms which we count today as fundamental to the American experience, including freedom of speech, freedom of religion, freedom from unreasonable searches and seizures, the right to trial by jury, and others.

The document presented in this display a facsimile of the original.

4. Magna Carta. The Magna Carta was signed in 1215 A.D. by King John of England, who agreed to the demands of his barons for guarantee of rights.

Through this he bound himself and "his heirs, for ever" to grant to the people of his kingdom the rights and liberties which they had demanded. As Churchill remarked, "Here is a law which is above the King and which even he must not break. This reaffirmation of a supreme law and its expression in a general

charter is the great work of Magna Carta; and this alone justifies the respect in which men have held it."

The document presented in this display is a facsimile of the original, which was in Latin. Among other things, it states:

John by the grace of God, King of England, Lord of Ireland, Duke of Normandy and Aquitane, and count of Anjou, to the archbishops, bishops, earls, barons, justiciars, foresters, sheriffs, stewards, servants, and to all his bailiffs and liege subjects, greetings.

In the first place we have granted to God, and by this present charter confirmed for us and our heirs for ever that the English church shall be free, and shall have her rights entire, and, liberties inviolate...

No freeman shall be taken or imprisoned or disseised or exiled or in anyway, destroyed, nor will we go upon him nor send upon him, except by lawful judgment of his peers or by the law of the land.

To no one will we refuse or delay, right or justice.

Moreover, all these aforesaid customs and liberties, the observance of which we have granted in our kingdom as far as pertains to us toward our men, shall be observed by all of our kingdom, as well clergy as laymen, as far as pertains to toward their men.

With Magna Carta, King John placed himself and England's future rulers within the rule of law. The rule of law places a restraint on the exercise of arbitrary power, and it places all people in civil government under law. This same precept was continued with the formation of the American government and legal code. The Bill of Rights itself flows in many respects from the liberties which were first recognized the Magna Carta.

5. Justinian Code. In 527 A.D. Emperor Justinian came to power in the city of Constantinople at the heart of the Eastern Roman Empire. At that time the law of the Eastern Empire consisted of statutes and the legal expositions of jurists. The law spanned the previous thirteen centuries of Roman civilization

and the massive volumes are often repetitious and contradictory. Justinian commissioned the lawyer Tribonian to undertake the work of systematizing this

mass of legal rules. The law was organized by subject matter. Important rules were to be placed first. The law was to be staled clearly. Contradictory or repetitious material was to be removed. The result was the Justinian Code, which formed the basis of the civil law of many continental European countries

for centuries thereafter, continuing to this day.

The impact of this work on all future Western legal systems, including that of the United States of America, was enormous. The Justinian Code proceeded

from first principle, clearly organizing and stating important rules of law so that the populace was not only apprized of their existence, but could clearly find

and understand them. The Code also established the importance of uniform application of one set of law.

The original Justinian Code was contained in multiple volumes and was in Latin. The text presented in this display contains excerpts, which show the nature

of the principles set forth in the Code. These principles were crucial to the code of law, which was established upon the foundation of this country.

6. Ten Commandments. The Ten Commandments have profoundly influenced the formation of Western legal thought and the formation of our country.

As one of the earliest examples of a set of laws designed to govern people and their moral obligations, they have served as a crucial part of the foundation for

the legal code of the United States of America and all 50 States, and indeed for Western civilization. This is perhaps symbolized best by the presence of Moses, the great law giver, whose image is engraved on the walls of the United States Supreme Court, holding the Ten Commandments.

The text presented in this display is from the King James version of the Bible, This is in keeping with the historical nature of the display, as it was the first great English translation and was widely disseminated at the time of the foundation of our country, state, and county. Although the Bible is certainly religious

in nature, the purpose of including the Ten Commandments in this display is to honor and respect the development of the American judicial system; to acknowledge that the Ten Commandments and the principles which they set forth were fundamental to the foundation of the legal code of our country, state,

and county, and indeed of Western civilization itself; and to recognize that, as with the Magna Carta and the Justinian Code, they are an integral part of our historical, societal, governmental, and judicial heritage.

7. The North Carolina Constitution. In our constitutional republic, each State has its own sovereign government and exercises all of those powers reserved to it under the 10th Amendment to the United States Constitution. The Constitution for the State of North Carolina establishes time framework for the governmental system of this State and also assures to the people most of the same privileges and immunities granted under the Bill of Rights. Our State Constitution has the added historical significance of having been first adopted in 1776, only a matter of months after the Declaration of Independence, and then having been adopted in an entirely new form in 1868 as a part of Reconstruction in the South, when the approval of new constitutions was a condition

of being re-admitted to the Union, The 1868 Constitution, among other things, outlawed slavery amid prohibited the State front ever again seceding. Though

revised and readopted in 1970, most of the provision of the Constitution of 1868 remain in effect today.

The document presented in this display is a facsimile copy of time original first and last pages of the 1868 Constitution, with explanatory text, as provided by the Division of Archives and History, North Carolina Department of Cultural Resources, in Raleigh, North Carolina.

8. Act Creating Stokes County. Stokes County was formed in 1789 from Surry. It was named in honor of Colonel John Stokes, a soldier of the Revolution,

who was desperately wounded at the Waxhow Massacre when Colonel Buford's regiment was cut to pieces by Tarleton. After the war, Washington appointed

him a judge of the United States district court of North Carolina. The documents in this display are a facsimile copy of the original provided by the Division of Archives and History, North Carolina Department of Cultural Resources, in Raleigh, North Carolina.

9. Stokes County Seal. Adopted by the Stokes County Board of Commissioners on

February 6, 1978. The Stokes Recreation Department along with the Stokes Arts Council held a design contest, which received 93 entries. Seven entries

were submitted to the Board. The entry submitted by Mr. R. Neil Maxey, Walnut Cove, NC was adopted. Mr. Maxey was given a \$50.00 savings bond. The

copy in this display is a facsimile of the seal used by Stokes County. The Seal portrays a building- Duke Power Steam Station, a tobacco leaf-a major crop, location within the State, and the date of creation-1789.

BE IF FURTHER RESOLVED, that a verbatim reproduction of this **Resolution** be posted together with the above documents, for the purpose of expressing

the intent of the Board in authorizing the display.

BE IT FURTHER RESOLVED, that this Display, including this Resolution, be posted in the Commissioners' Chambers of the Stokes County Administrative Building, Government Center Complex in Danbury, North Carolina.
