County Manager Rick Morris presented the following comments:

- Veteran Services
  - o Veteran Services Officer Larry Hunsucker is doing a very good job serving the Veterans of Stokes County
  - o Mr. Hunsucker is very interested in serving all the veterans in Stokes County
  - o It is a very dynamic environment currently serving the veterans and their survivors (lot of new benefits today that were not available years ago)

# Tony McGee

Re: Moores Springs

Mr. McGee presented and briefly discussed the following information (presented Board members with handouts):

- Appreciate the time to speak
- Would like to present the Board with information regarding the economic impact of mountain bike trails
- The Best Mountain Bike Trails in North Carolina
  - o Moores Springs Trail in Danbury is ranked #9 as best in North Carolina
  - Ranking is done by Singletracks.com which tracks trails all over the country and world
  - o Tsali Recreation Area (ranked #1) in Bryson City North Carolina is also ranked #1 in the world; Moore Springs is in its company
  - O Was ranked as high as #6 at one time
  - Others in the top ten (10) include areas around Wilkesboro, Black Mountain, Boone, Charlotte, and Greensboro
  - o Have the density to attract people to this area
  - Met a young man from Arkansas who came to North Carolina just to ride mountain bike trials and included the Trails at Moore Springs as one of his destination stops
- Wilkesboro Tourism Authority
  - O Provides a survey on a recent bicycle event held in Wilkesboro and the economic impact to the area
- Economic Benefits of Trail Tourism
  - Points out that one major benefit is that it is money spent in rural towns in more economically disadvantaged areas; many people traveling to a trail and spending a night or more in the area are economically well off and have significant discretionary income
  - o References trails at the Outer Banks, North Carolina and several trails in rural area around the country
- Active Outdoor Recreation Economy (North Carolina)
  - Has a helpful breakdown of North Carolinians' participation in active outdoor recreation (bicycling, camping, hiking, trails, etc.) with the percentage of the population
- Mountain Biking-Trail Development Study in the Midwest
  - Great study on the impact of land values and adjacent land values and the quality of life
- Appreciate the time

# Mr. Putnam presented the following comments:

- Owns Ken's Bike Shop on Reynolda Road in Winston Salem
- Been in the bike business for forty (40) years
- Want to volunteer to the Board of Commissioners to be a source of information regarding the economic impact that bicycling has had around the Winston Salem area
- Put on 20-30 bicycle events in Stokes County back during 1970-1980 (worked with the County Recreation Department)
- Brought the "Tour North Carolina" to Stokes County in 1984 which went around the state
- Did the Moratock Biathlon for approximately 15 years during 1980-1995
- Worked with Tony McGee and got sponsorship for events in the Walnut Cove area for a couple of years
- Worked with Dave Pyler in the late nineties developing a trail system at Tanglewood Park in Winston Salem; a few years later did a survey that revealed it had more participation than any other facility at Tanglewood at that time; no county funding
- Helped establish trails that bicyclists, horseback riders, and runners could all use around Salem Lake which has become a huge economic impact on the Winston Salem area
- Just wanted to say that you have a wonderful person in Tony McGee and what he has done to establish this mountain bike facility
- There is none like it anywhere around, and the potential here is unbelievable

- Come to this area to climb Moores Wall and Hanging Rock on a weekly basis
- In addition, I am a member of the Board of Directors of a nonprofit, Carolina Climbers Coalition
- The Coalition does two things primarily purchase/acquire lands for the purpose of securing accesses to rock climbing
- Bought Large Cliff, Cashiers Valley, NC, probably the biggest wall in the eastern United States (more than a 1,000 ft tall)
- Leases a boulder field south of Asheville
- Currently trying to secure rights to the cliff line of Sauratown Mountains from Camp Hanes for winter climbing
- Tony McGee and the campground has been an interest of the Coalition; people who come to climb, need a place to stay
- It is in our interest to support him and the group and the Board

- Have access to some funding and a lot of labor
- Also have the backing of a national nonprofit called *The Access Fund* which has orchestrated some quite large acquisitions such as campgrounds and trail improvements

## Ramona Timm

Ms. Timm read the following:

My concern is for Just Governance. Just Governance is essential to Freedom. America is known for its Freedom; from its Declaration of Independence upon the supremacy of the Laws of Nature's God over unjust governance; its National Anthem; to our soldier's hearth breath and last breath, for Freedom.

Fairness, equality, and need are buzz words for socialism. Freedom and Socialism are mutually exclusive. They do not mix. Socialism destroys individual freedom. Therefore, a people with a socialistic mindset are destructive of freedom.

You have many issues to decide on for our county's governance; and we must not forget there is a road to serfdom from socialism's deception. Its ever increasing lure as the only solution, its decline of morals, and its totalitarian nature, should be alarming as individual Rights are consumed for the collective by absolute power.

Nobel Prize-winning economist Friedrick Hayek wrote in his book: "The Road to Serfdom." Our generation has forgotten that the system of private property is the most important guarantee of freedom..... But when economic power is centralized as an instrument of political power, it creates a degree of dependence scarcely distinguishable from slavery...individualism in contrast to socialism and all other forms of totalitarianism, is based on the respect of Christianity for the individual and the belief that it is desirable that men should be free to develop their own individual gifts and bents. This philosophy, first fully developed during the Renaissance, grew and spread into what we know as Western Civilization."

Edwin Feulner, former President of The Heritage Foundation, wrote: "Milton Friedman...observed, Hayek's influence has been tremendous. His work is incorporated in the body of technical economic theory; it has had a major influence on economic history, political philosophy and political science; {and} it has affected students of the law, of scientific methodology, and even of psychology." But as Friedman rightly recognized, all of these achievements "are secondary to Hayek's influence in strengthening the moral and intellectual support for a free society".

I concur with Hayek, Friedman, Feulner, and Alexander Vinet who spoke: "Christianity is the immortal seed of freedom of the world".

Ms. Timm left each Commissioner an abridged edition of: *The Road to Serfdom*. Ms. Timm concluded:

- Doesn't seem to be any serious negative issues other than the ongoing NCFast
- Those in Raleigh, as mentioned by Commissioner Inman, tend to see things the way they want to see them instead of the way they really are
- Seems NCFast has been a challenge since the beginning
- Confirmed with Director Elmes that once the new system is in place, it will be much better and very beneficial to the staff and citizens
- Have had a challenging economy during the past few years, it has caused things to be stretched at times in your department, are we beginning to see any shift in the numbers to indicate that the worst is over?

# Tax Administrator Oakley reported the following:

- Advertising for the 2014 Listing will be in the Stokes News this week
- Will be sending out approximately 10,000 listing forms
- Real property is permanently listed
- Listing period, barring any bad weather, is January 1-31, 2014
- Anything after January 31, 2014 will be declared late listing on personal property
- Collection is very much on schedule, approximately 60% of the budget collected

Chairman Booth opened the floor for discussion.

Commissioner Inman confirmed with Tax Administrator Oakley that the current 60% collect rate is almost comparable to the same time last year, maybe 1% better.

#### Commissioner Walker commented:

• Questioned Tax Administrator Oakley if the revenues from the Revaluation have decreased approximately \$500,000 (approximately 4%) as previously estimated?

# Tax Administrator Oakley responded:

- Even though the County has lost approximately 4%, the County has gained in public utilities and motor vehicle collections
- Believe the rate of collections for motor vehicles will go up with the new state system
- The increase of revenues in public utilities and the increase in the collection of motor vehicle taxes has somewhat offset the 4% loss
- Next year will be more accurate

# Proposed Cell Tower for the Meadows Community

County Manager Rick Morris presented the following information regarding a proposed Cell Town in the Meadows Community:

- Ms. Susan Stancil from Juvo Telecom and Planning Director David Sudderth are in attendance to answer any questions regarding the request
- Juvo Telecom has selected three (3) sites to be considered in the Meadows area
- Two (2) of the three (3) sites are located on county property (map provided to the Board)
- The best site of the two (2) sites that are on county property is the old prison camp location
- The sites require a lease of space that is 100 x 100 feet, plus an access easement of 30 feet, where half of the 30 feet is usually improved
- The sites are fenced in, normally with a 60 x 60 foot print
- The decision for the BOCC is whether the BOCC wishes to approve a tower location on either of the county own sites; if not approved for county property, there is a third site located on private property
- If the BOCC approves county property, the tower company will then initiate the normal cell tower application process with the Planning Department
- The tower is for AT&T, but would be available for co-locations by other carriers
- Would respectfully request to move the item to today's Action Agenda as the funding for these towers is subject to re-appropriation to other towers if the approval process moves too slow

Chairman Booth opened the floor for discussion.

Vice Chairman Jones commented:

- Agree with the site selected former prison camp location
- Concerned about seeing a tower on the community college location
- Confirmed with Ms. Stancil that the tower would be visible from the community college

#### Ms. Stancil commented:

- Former prison camp location has the highest elevation of the three (3) properties
- It, in reality, would be the most visible because of where it sits to the intersection of the highways and the ground elevation

#### Commissioner Inman commented:

- County is trying to bring water and sewer to the Meadows area with the hopes to stimulate some economic growth in the area
- That makes the former prison camp location a prime piece of property
- How would placing a tower on the former prison camp location impact future development for the County?

# Ms. Stancil responded:

- The way the County's Ordinance is written, it demands looking at county owned property first
- Presented AT&T design engineers the two county owned parcels; they identified the former prison camp property as their first choice with the community college location as a backup
- In terms of future development, the County's Ordinance requires the setback of approximately 220 ft from any property line which is going to pull the tower into the property (former prison camp location) in some form or fashion
- Have approximately 100x100 ft square along with access; access is considered to be nonexclusive which can be moved later at the developer's expense (tower owner has to have 24/7 access to the tower)

Commissioner Inman confirmed with Ms. Stancil that the projected site on the map at the community college location could be moved somewhat.

Ms. Stancil noted that the tower, if located on the community college, would be visible as one pulls into the site.

#### Commissioner Lankford commented:

- Confirmed with Ms. Stancil that the projected site on the map at the former prison camp location could be moved as long as it is 220 ft from any other property
- The structure being proposed is a 195 ft mono pole structure which can be close to non-inhabited buildings
- Confirmed with Ms. Stancil that only the top portion of the tower would be visible at the community college location

#### Commissioner Walker commented:

- Confirmed with Ms. Stancil that the former prison camp location is the number one location due to elevation with the community college site being second and the private landowner as the third
- Looking at the map provided, there several residents in that area

- Confirmed with Ms. Stancil that the former prison camp location is the most visible due to the elevation
- Confirmed with Ms. Stancil that the private property site is tucked in behind a tree line which could be the least noticed (Ms. Stancil noted that her opinion is a subjective viewpoint from just driving in the area)
- When looking at running water and sewer to the area, one of the main motivations
  was to not have a water tower on the community college property; it would distract
  from the view
- My vision is to have agriculture and horticulture classes on the location; have quite a farming heritage in Stokes County
- Would like to see the farmers and those who like to make a living from the land have as much opportunity to do that in the future and one way to encourage that is to offer these community college classes
- If we in the future decided to clear a lot of the property for agriculture or horticulture uses, it could make the tower more visible

# Ms. Stancil responded:

- If the land was cleared, it could make the tower more visible
- Could not guarantee the property would stay a wooded tract

#### Commissioner Walker continued:

- Confirmed with Ms. Stancil, from a service prospective, that any of the three sites would be adequate
- Very encouraged to see more towers in the County to provide better cell services to the people in Stokes County

### Ms. Stancil responded:

- AT&T has put quite an investment in both North and South Carolina in the past couple of years bringing additional services to rural areas
- Receive a lot of positive feedback when placing towers in rural areas public safety and economic development reasons

#### Commissioner Walker continued:

- Owe it to the citizens to try to keep this beautiful county as natural as possible along with providing services
- Place a high value on providing the service in the least intrusive way as possible

#### Chairman Booth commented:

- The projected site for the tower at the community college location seems to be, per the provided map, not suitable for building, not sure even for clearing the property for agriculture
- If the projected site at the community college location could be moved to the right approximately 200 ft from the property line, it shouldn't impair any visibility of the mountains
- Will be hard press to meet the 200 ft setback at the former prison camp location

• Could go with either one, but could impair building on the former prison camp parcel in the future

# County Manager Morris commented:

• Reminded the Board that after a site is chosen, preferably today, the application process will then start from the beginning

#### Commissioner Inman commented:

- Am not ready to vote today until visits are made to all locations
- Confirmed with Manager Morris that even if a site is selected today, the entire application process would have to be done at which time the final decision would be that of the Board of Commissioners

# Planning Director David Sudderth responded:

- Original application was stopped due to the applicant did not follow the required guidelines
- This is where the decision will have to made by the Board additional revenue if placed on the county owned property along with the project benefiting the entire community
- If the BOCC decides on a county owned property today, the company then reapplies and start the process over; must have a balloon test, public information meeting, invitation to take a look at it, etc.
- Once the balloon is placed, this will give the Board the opportunity to see what the tower would supposedly look like
- Haven't see a master plan regarding the community college property
- With the placement in the wooded area at the community college location, the projected site looks good
- Cell towers are everywhere now, people don't pay them as much attention now
- Hanging Rock Advisory Board will be asked for input regarding the view once the application is received

Commissioner Inman confirmed with Director Sudderth that the process, after the balloon test, is the same.

#### Director Sudderth commented:

• American Tower Company (ATC) would own the tower and the County would receive funding from leasing the tower

Chairman Booth questioned if the balloon test could be done on both county owned properties at the same time?

Commissioner Inman stated that he would not vote for the former prison camp site.

Director Sudderth responded:

• Once the application is made, it is a formal process and can't ask the applicant to do balloon test for two sites

Commissioner Walker questioned Planning Director David Sudderth when are the surrounding property owners notified and a time decided?

Director Sudderth noted the County would receive the application and follow the normal requirements for advertising, posting, etc.

The Board had no issues moving the Agenda item to today's Action Agenda.

Chairman Booth, with full consensus of the Board, directed the Clerk to place the item on today's Action Agenda:

# <u>Animal Control - Proposed Lease for the Designated Property for the new Animal Adoption</u> Facility

County Manager Rick Morris presented the following proposed lease for the Designated

Property for the new Animal Adoption Facility for the Board's review and discussion:

This lease is made and entered into effective December 1, 2013 by and between the County of Stokes, North Carolina, a body politic and political subdivision of the State of North Carolina (hereinafter called the "County") and <u>The Friends of Stokes Shelter (FOSS)</u>, Inc., a non-profit corporation organized and existing under the laws of the State of North Carolina, having its principal office in the Town of Walnut Cove, North Carolina (hereinafter called The FOSS, Inc.)

Whereas, County is the owner of a tract of real property, located adjacent to the County's Animal Shelter, Stokes County, North Carolina, hereinafter described, known as the Stokes County Animal Control, more fully described by the physical address of 1999 Sizemore Rd., Germanton, N.C. 27019; and as more particularly described on the attached Exhibit A.

Whereas, the parties have agreed to enter into this lease agreement for the above described property based on the terms and conditions set forth below.

Now therefore, in consideration of the premises and other good and valuable consideration, the sufficiency of which the parties hereby acknowledge, the County hereby leases to The FOSS, Inc. the property described herein (see attachment) on the following terms and conditions:

1. **Leased Space**: The FOSS, Inc. will lease the designated land for construction and operation of an animal adoption facility located at 1999 Sizemore Rd., Germanton, N.C. 27019.

- 7. Term of Lease: This lease shall be effective on the date it is signed by both parties, and unless terminated as provided in this agreement, shall continue for a period of ten (10) years (the initial lease term).
  - a. Renewal -- Provided Lessee is in compliance with all terms of this lease. Lessee shall have the option of renewing their lease for three successive terms of five (5) years each commencing at the end of the initial term. The option to renew shall be exercised by Lessee giving written notice to the Lessor at least ninety (90) days prior to the end of the existing term.
- 3. Termination: During the period of this lease the Lessor may terminate this lease if the Lessee fails to meet the terms and conditions agreed to in all sections of the lease, by providing written notice of termination upon a date specified in such notice. The termination date shall be not less than thirty days after the date of such notice. The Lessee may terminate the agreement prior to expiration of the term by giving written notice to the Lessor of Lessee's intent to terminate for reason of the occurrence of one or more of the following events:
  - i. The Lessor fails in any material respect to fulfill or perform any duty.

    obligation or responsibility under this agreement and if such failure continues for a period of ninety days after written notice of such failure.
  - ii. This agreement is declared unenforceable or invalid by a court of competent jurisdiction.

**Lease Payments**: The FOSS, Inc. shall pay the County annual rent of \$1.00 (One Dollar) for the right to occupy the Leased Premises. Lease payment shall be due and payable the first day of July each year of the Lease term.

- 4. **County Responsibilities**: The County will maintain the adjacent exterior grounds of the leased property, which responsibilities will include, maintenance and repair of the grounds and the septic system that will serve the new building and the current animal shelter building. All maintenance and repairs shall be performed in a workmanlike manner. The FOSS, Inc. will also provide general day to day maintenance and custodial services in the building.
- FOSS, Inc. Responsibilities: Except for the County's obligations to maintain the Leased property as set forth in paragraph 4, the FOSS, Inc. agrees to maintain the property in good condition, normal wear and tear excepted. The FOSS, Inc. will properly secure the Leased property and will promptly notify the County of any damage or repairs needed on the adjacent grounds or sewer system.
  - The FOSS, Inc. will be responsible for comprehensive liability and hazard insurance in such amounts and against such hazards as may be necessary or desirable and will insure the Leased Premises against fire and windstorm for the use and benefit of the FOSS, Inc. as they see fit. If the building shall be damaged by fire or other casualty, and such damages are minor in nature, the same shall be repaired by The FOSS, Inc. directly, or from the proceeds of insurance coverage, as quickly as is reasonable possible. If the

property is damaged to such an extent as to render the same unfit for use or occupancy, this Lease shall terminate and the proceeds of insurance coverage shall be paid to the County for cleanup and restoration of the property, and the FOSS Inc. shall be relieved from further liability under the Lease.

FOSS, Inc. shall be responsible for providing insurance against fire, theft, water or other damage for its personal property, including fixtures installed on the property. The FOSS, Inc. shall also be responsible for providing insurance against fire, theft, water or other damage for the personal property of its employees, agents, invitees, and guests, including but not limited to all exhibits owned by third parties that The FOSS, Inc. may have located on the property.

The FOSS, Inc. shall be responsible for the payment of utility bills for electrical, heating/air, and telephone.

County shall lease and FOSS, Inc. accepts the property in its "As Is" condition. County makes no warranties or representations regarding the property and no warranties are implied. The FOSS, Inc. shall hold County harmless for any defects in the property created by The FOSS, Inc. during its tenancy.

The FOSS, Inc. shall not use or permit the use of the property in violation of any present or future applicable law of the United States or of the State of North Carolina, or in violation of any present or future applicable municipal ordinance or regulation.

The FOSS, Inc. shall have the ability to sublet office space within the property to non-profit/service organizations, with sublet revenue retained by the FOSS, Inc. in support of operational costs of leased property.

All revenue generated through the use of leased property, including but not limited to retail sales, admission charged programs, sublet of space, class instruction, and The FOSS Inc. organized programs, and shall be retained by the FOSS, Inc. in support of operational costs of leased property.

6. Indemnity: the Lessee agrees to indemnify the Lessor against any and all claims and losses arising out of the Lessees use of the property during the lease term.

County Manager Morris noted the following:

- Since the last meeting, met with Dr. Debbie Cowan regarding the proposed lease
- In conjunction with County Attorney Browder, all changes are in red and underlined
- Changes the entity to The Friends of Stokes Shelter, Inc. not Humane Society as previously presented
- Adds language about Exhibit A
- Adds new language about the Term of Lease and the Termination along with an indemnity statement
- The single issue that Dr. Cowan had was the renewal process
- Feel they may have some very serious contributors lined up, but their concern was that the County can change their mind and take the building away from them
- New language addresses that issue in regards to the Friends of Stokes Shelter and the County
- Have sent the revised lease back to Dr. Cowan for her comments
- Feels the lease is adequate for both parties

Chairman Booth opened the floor for discussion.

#### Commissioner Walker commented:

- Would envision this lease to protect the county's interest by having provisions that
  when the property ceases to be used for its primary purpose, it would revert to the
  county; but would have something in place to assure the Lessee, those going to all
  the efforts to raise the funding, that the facility is going to be in place and available
  for a good number of years
- Questioned Attorney Browder what has been missed from his observation?

#### County Attorney Browder responded:

- Agree with Commissioner Walker that a provision needs to be included that the facility reverts back to the County if it ceases to be operated as animal adoption center
- There is no provision at the end of 25 years, do not like to include automatic renewals after 25 years; 25 years is a long time

Commissioner Walker continued:

- Confirmed with County Attorney Browder there is not an opt out clause in the proposed lease
- Can't imagine a situation needed, but can never tell what could happen

County Attorney Browder continued:

- Can include an opt out clause if desired by the County, but don't feel it would be desirable from the Lessee
- One reason is that the Lessee is going to tie up a lot of funding for this project and major contributors may see that as a reason to not contribute if the building can be taken back at anytime

Commissioner Lankford, Commissioner Inman and Vice Chairman Jones had no issues with the proposed lease.

Dear Manager Collier:

Stokes County, North Carolina is currently in the process of finalizing the design and initiating construction of a sewer extension to the County's Meadows Community, businesses, residents, and community college campus, where construction of a new 20,000 sq. ft. permanent building is planned for Forsyth Tech Community College. The sewer project is being funded by five to seven granting agencies. The majority of the granting agencies have awarded funding for the project; however, the final decision from a couple of the agencies on the Stokes County project has not been finalized.

Since the project is scheduled to begin construction in early 2014 and the county is needing to move forward on all the funding commitments the Stokes County Board of County Commissioners has certified through formal Board action, that they will provide \$134,284 to project cost and should any other gaps/shortfalls in funding occur during the construction period, these gaps/shortfalls will be funded by the County of Stokes. This action includes gaps/shortfalls that might occur because of timing/cash flow issues with the granting agencies, or failure of the non-committed funders to provide the projected funds that were requested in the County's applications.

The Board of County Commissioners' assurance that they will fund any gaps/shortfalls that might occur will be reflected in the minutes of the Board Meeting where formal action was taken to make this guarantee. This letter should serve as the final funding instrument to assure all grantors to this project that the project is in fact fully funded.
