Vice Chairman Ernest Lankford called the meeting to order and welcomed those in attendance.

County Manager Rick Morris commented:

- EMS Director Greg Collins announced his retirement today with his last day being July 31, 2017 after thirty plus (30+) years of service to Stokes County
 - o Will start the internal advertising process for his replacement tomorrow
- Stokes County EMS has received the American Heart Association's Mission: Lifeline Gold Award for implementing quality improvement measures for the treatment of patients who experience severe heart attacks
 - o EMS has received two Silver Awards to date

- o Receiving a Gold Award is somewhat rare for a rural county
- County offices will be closed on Tuesday, July 4, 2017 in observance of the holiday
- The Arts Place of Stokes County will be opening its retail sales operation this Saturday, July 1, 2017
- Support Services Supervisor Danny Stovall is in the process of removing the fuel tank located on the Francisco School property funding from the sale of fuel in the tank will be used to help fund the project (Budget Amendment #88) with additional funding from the Francisco School Facility line item
 - o Hope to have the tank removed by the middle of July

The following spoke during Public Comments:

Sri Ananda Sarvasri

Re: Happiest, Healthiest, Greenest County in the Nation

Mr. Sarvasri presented the following comments to the Board of County Commissioners:

- Just want to talk about a new Renaissance in Stokes County
- Happy is not a luxury, it is a necessity
- When we are unhappy, we make bad decisions sometimes disastrous decisions
- Last time, I spoke about drug prevention for children and described how important it is for children to have access to positive activities
- Would like to describe a way to create a new Renaissance using internet technology
- For kids and teenagers to have more activities, we need a system
- How can parents create so many activities by themselves?
- It would be far more efficient if parents would connect with other parents locally
- Most of us do not even know most of our neighbors, much less, all the people that live within one mile from us
- We also do not know their talents and skills, so these skills and talents are going to waste when they could be enriching parents and children nearby through positive activities
- The same is true for economic development
- How do we find the people with the skills we need to start a new business the same problem exists
- We need to connect with people nearby
- This is the function of a Community Information Network or utility a data base on line that we can search for people and resources that we need
- The County IT Department could create an information resource on line to connect people and neighbors together to create Cultural Economic Renaissance (explained more in detail in the handout being provided to the Board tonight)
- The idea of the information utility would allow people to register their talents and skills that they would like share other people could find them on the Community Information Network such as someone who can play a musical instrument and teach a child who wants to learn to play a musical instrument
- The same is true in forming a business we may need skills that we do not have
- If we had a skills data base, people would be able to search to find a person with the skills they need
- Very powerful idea
- Hope we can create one in Stokes County

Mr. Sarvarsi provided the Board the following "A Community Information Network – To Create a Cultural and Economic Renaissance"

Turning Problems Into Opportunities

Can the current addiction crisis be turned into an opportunity? Could the opioid epidemic launch a new renaissance? The Italian Renaissance was a time of awakening – a flowering of art, science, and human potential. If we're creative, the present crisis of addiction could jumpstart a new renaissance. We could transform the population and awaken a new flowering of potential. Addiction is just a sign that people are seeking more. People want to be happy and avoid pain. We can achieve this high quality pain-free life without drugs by awakening greater human potential. For example, one ability we all have (that virtually no one knows about) is the human capacity to heal ourselves, even eliminate pain directly with mind power. It's a natural part of our human potential. With knowledge like this, we can turn the crisis of addiction into an opportunity for everyone to

reach their higher human potential. We all know that problems can also be opportunities. We can create cultural activities to promote and expand our human potential.

Think about what caused the Italian Renaissance and how we could reproduce it rapidly with existing information technology. The initial surge of awakening out of the dark ages was created by the invention of the Gutenberg press. It allowed books to be printed rapidly and distributed to a large population over a wide region. Newly literate readers were seeking a better life. Books vastly expanded knowledge of the arts and sciences, and directly awakened human potential. If we understand how to use it, Internet technology can create a new renaissance much more rapidly. First, let's look at what caused the original Renaissance.

What Caused the Italian Renaissance?

It's worthwhile understanding what led to the great Renaissance that produced the modern era.

- Widespread Availability of New Knowledge Through Books
- Abandonment of Dogma Hunger For New Ideas
- Focus On Creativity, Classical Beauty, and New Technologies In The Arts and Sciences
- Desire for Practical Inventions to Reduce Labor
- The Need For New Solutions in All Areas of Life
- Political Will and Economic Support
- Inspiration A New Mindset The Belief That Life Could Be Better
- Idea Sharing Through Salons An Italian Invention for the Exchange of Ideas

Our society is obviously off course in many ways. We have widespread depression, fear, and drug addiction. Yet, we also have the same opportunities today that existed at the start of the Renaissance. What we need is new inspiration, a new hope for a better world, plus practical ways to create a new renaissance. Unlike the Italian Renaissance era, we already have vast access to knowledge online via the Internet.

Opportunity for A Cultural Renaissance

Today, we need a cultural renaissance to reset our social agenda. In the past few years, we've learned important things about social change in connection with addiction. For one thing, kids and teenagers need positive activities. Without fun and interesting things to do, they tend to get into trouble. Children also need inspiration and ways to explore their creative potential. They want to learn about life and how to find their future path. Likewise, adults need inspiration and economic opportunities. During the Renaissance, inspiration, access to knowledge, and new technologies created jobs and economic abundance for more people than ever. We can do the same with Internet technology today. It all depends upon the connections of families with other families.

Families Helping Families

In many neighborhoods, people hardly know their neighbors. Certainly, none of us know all the people who live even just one mile away. We don't know what skills or talents they have. They may have artistic or musical talents that they could offer to other families nearby. They may have technical skills to offer. We just don't know. These talents and skills are going unused, wasted. Today's information technology can easily solve this problem. It can bring us all together. All we need is a database connected to the Internet. For cultural enrichment, families could share their skills and post creative activities for children online. Other families could copy these ideas or come together to spread the fun. Older adults would feel valued by contributing their wealth of knowledge accumulated over the years. It's just a matter of connections. The more activities and connections,

the faster a new renaissance takes place. We need a way to come together for mutual benefits. Everybody wins.

For instance, activities for kids and teenagers could be posted by zip code or neighborhood for easy access by both parents and children. It's all a matter of creativity. Parents could get together and brainstorm tons of ideas using the Internet as a resource. Children could post the kinds of things they might like to do. By accessing a local skills database, people to conduct these activities could be easily found. (The document "Preventing Drug Addiction" lists lots of ideas for positive activities.) We simply use Internet technology to connect 1) families 2) activities and 3) skilled neighbors. It's a way to easily organize social and cultural activities for mutual enrichment within the community. An online forum can serve the function of a salon where people get together and discuss possibilities and new ideas.

How A Community Information Network Brings Cultural Enrichment Here's how it works in practice.

• Parents and children come up with ideas for positive activities

• These activities are discussed on a local forum, the salon of the 21st century

• If parents have the skills, they post an activity for other families to participate in

• If a skill or talent is needed, the skills database is searched for people who can help

• Those people can then be contacted about sharing their talent or skill for the activity

• An activity is posted for community participation: **Activity-Time-Date-Location-Presenter** (A simple database)

The same thing can be done to foster economic development.

Opportunity for an Economic Renaissance

Community information networks can also create an economic resurgence. Consider what must be accomplished to achieve economic development: Basic resources such as materials, local skills, money, real estate, buildings, work space, natural resources, etc. must be identified, documented, categorized, quantified, and organized into a productive system. This information doesn't reside in any one person's head. It is the collective information of all the people and businesses in the community. A community information network can be a repository of this vital information. It takes planning to best utilize skills and resources. Effective community planning can be enormously facilitated through a community information network where ideas, plans, schedules, and material resources can be organized and accessed from any computer in the community. The Internet allows thousands of people to work together in new and powerful ways. In combination with a skills database, organizing power is multiplied manyfold. Basically, the idea is simple. We use an online database to store resources and a skills bank for the area. This allows anyone to find the resources and people-skills necessary to jumpstart new businesses. You can find what you need, whether resources or other people to help with business development.

The ability to utilize community resources is simply a set of databases tied to the Internet. For example:

Business Development Forums (a database of conversations on business development – a salon for business incubation)

- New Business Opportunities
- Technology Assessments
- Funding Options
- Other forums as required

Local Government Forums

- Community leaders can talk and listen to members of the community
- Conduct straw votes on issues of interest

Community Scheduling Calendar

- Local events planning and scheduling
- Community agendas and meetings for all aspects of the community

Information Databases

- Skills and Talents
- Job Posting and Locating System
- Community Resources Inventory
- Community News & Information
- Community Needs Assessment
- Document Storage & Retrieval

A community information network can pull together the diverse talents in any community and in an integrating system that will inspire the talents of the community to work together in an entrepreneurial community spirit to create jobs, effectively utilize local resources, protect and restore the environment, and revive community interests, cohesion, and lifestyle. A Twitter account could be assigned to the network and to county and municipal governments for rapid notifications of news and special events.

Summary

We need to use 21st-century technologies to create a new cultural and economic renaissance. Social and cultural activities can be posted for all to enjoy. A resource inventory and a skills database can be the basis for the incubation of hundreds of small businesses. The technology already exists. Local governments could have their IT staff create these databases and interfaces to jumpstart a cultural and economic renaissance.

Re: Russian Collusion

Mr. Timm presented and read the following comments to the Board of Commissioners:

Ramona and I are concerned with Russian Collusion.

Russian collusion has been going on with Americans in America and with others in many foreign countries to advance Communism for a very long time. Also, there appears to be collusion between the major media and leftist political leaders. That cooperation is becoming very obvious by the way the narrative of "News" and the politicians' statements complement each other on Globalism, Secularism, and Socialism (Communism's lower stage—Carl Marx).

The most notable exposure of Russian collusion was brought to light in the trial of Alger Hiss; remember? If not, google his name, and the Communist Party Member that was involved in espionage for the Russians, who turned witness against Alger Hiss, Whittaker Chambers (1949–1950).

Senator Joe McCarthy in the 1950's made many accusations of Communists working within the Federal Government, which provoked the Senate to censure him. Decades later we learned many of his accusations were correct, and larger than suspected.

In the 1950's Fidel Castro started his revolution in Cuba. The Press had asked him if he was a Communist, and he said he was a Freedom Fighter, so that is how he was identified in America. I remember riding home on the school bus and cheering with the rest of the children for Fidel the Freedom Fighter. Is it not strange the press did not investigate? Was our CIA and FBI unaware of Russian collusion with Fidel? Were we not aware of Russia brutally taking over the Eastern Block Countries? Is it not strange the Bay of Pigs Invasion was a horrific CIA debacle (with the wrong caliber ammunition given, and signals to the ships to bombard and the para-troopers to jump not happening)? My Cuban friends in Miami told me they were given instructions for the Invasion regarding the American Embassy and airport-nothing worked-they were caught and tortured. Another Cuban friend that I worked with came into work looking real bad; so I asked—what happened? He said, he was up all night crying and caring for his brother, who could not even feed himself. His brother was a basket case, since he had been tortured for over twenty years as a political prisoner. This was the time in the 1980's when Castro emptied out his prisons. The cruelty of the Communist Cuban soldier was revealed by a foreign report of Communist Angola using Cuban soldiers to secure an area of political prisoners called "The City of the Living Dead," where people looked like zombies (dead emotionally from atrocities).

Manning Johnson, a Black who should be recognized as a genuine American hero (was the Communist candidate for the U.S. House of Representatives in 1935, but later left the party) wrote *Color, Communism and Common Sense*; and testified before Congress' Committee on Un-American Activities more than once. In 1953 the Committee asked—"Was deceit a major policy of Communist propaganda and activity?" He answered, "Yes, it was. They made fine gestures and honeyed words to the church people which could be likened unto the song of the fabled sea nymphs luring millions to moral decay (spiritual death, and spiritual slavery). . . ." Some of the chapters in his book were "Subverting Negro Churches, Red Plot to Use Negroes, and Creating Hate." In his Farewell Address he questions "Has the NAACP helped the American Negro, or hindered him?" and spoke of "managed news and manipulated mass communications. . . ."

Re: Russian Collusion

Ms. Timm presented and read the following comments to the Board of Commissioners: (continued from Mr. Timm's comments)

Julia Brown (my favorite Black female Hero of the 1950's) joined the Communist Party believing it was a Civil Rights Movement. When she realized the Communists were out to harm America she went to the FBI, and became an undercover agent. In 1962, she testified before Congress—which considered whether those Communists' activity "... attacks the principle of the form of government

as guaranteed by our Constitution. . .;" which put eleven Communists behind bars. She testified of many other organizations connected to the Communist (a couple were "the Progressive Party" and "Protection for the Foreign Born"). (She wrote the book *I Testify*.)

Dr. Martin Luther King Jr. (in 1967) lead a crowd of 125,000 Vietnam War protesters in front of the United Nations building demanding "Stop the Bombing." Buddy was flying reconnaissance for those that did the bombing, and King did not help the American cause of stopping the spread of Communist aggression to conquer the free South (which SEATO was formed to prevent). Martin Luther King Jr. like Alger Hiss was not a Communist Party Member, yet he associated with many Communists. Martin Luther King Jr., John Kerry, and Jane Fonda clearly aided the enemy, and should be tried for treason. Fifty eight thousand lives were lost in that war, and that does not included those that lost limbs, like Buddy's brother who lost his leg from a land-mine explosion, nor is it realized—that the genocide of around a million freedom loving anticommunist Vietnamese happened—once America pulled out.

Buddy and I were frustrated with our government and News agencies in the eighties, as we sent many pictures and letters to our elected officials of innocent Blacks being burned alive in gas filled tires in order to get Blacks to follow the Communist Revolution lead by Mandela's ANC in South Africa. All that we heard in America was—the conflict was about Apartheid.

The Bible Proverb 27:19 reveals: "As in water face answers to face, so the heart of man to man." In other words—A man is known by the kind of friends he choses. (Words alone can be deceitful.)

Soviet collusion with others can be known by: their friends, what they do, and the principles and programs they espouse. - O Stokes Stomp Festival on the Dan River is the longest running Arts Council sponsored event in North Carolina brings in thousands of visitors each year
- o Enjoy working with David and Tory strategizing and maximizing our advertising dollars to bring tourists to Stokes County along with providing a better quality of life for Stokes County residents which is the primary purpose of the Arts Council

Vice Chairman Lankford opened the floor for discussion/questions/comments.

Commissioner Jones commented:

- o This was my request to have this information presented to the Board of Commissioners
- o Felt that everyone needed to hear the statistical data
- Amazing at what has been accomplished by this group of individuals working together
- o It is enriching the community, economic development, tourism, as well as, the cultural arts

Commissioner Booth commented:

- Would say "WOW" for the accomplishments that I have seen over the past two years by this group of individuals
- o Expressed appreciation to Director Sudderth for his leadership to make this happen
- Appreciate the work that Tory has done to put all this information on the app and website
- Appreciation to Director McGee and the Arts Council just look at what is happening in Danbury – The Arts Place is economic development along with other places within the County
- o Just look at 11% increase in visitation at Hanging Rock State Park
- o This is happening because of the leadership and what these individuals are doing to promote Stokes County
- Hanging Rock visitation is already up 5% this year
- o Appreciate and commend the work being done to market and promote Stokes County

Commissioner Mendenhall commented:

- Want to express a special thank you to all three of those presenting the information tonight – David, Eddy, & Tory
- Very good presentation tonight
- With their efforts, many more people know about Stokes County
- Appreciate the work and effort being done to promote Stokes County

Vice Chairman Lankford commented:

- Also want to express my appreciation
- o Naturally "three heads are better than one"
- O You three have worked together to "think outside the box" to market Stokes County
- All these new ideas to market Stokes County has produced results people visiting Stokes County
- o Those who live in Stokes County love Stokes County

Proposed Energy Programs Outreach Plan

County Manager Rick Morris presented the following information regarding the proposed Energy Programs Outreach Plan:

- o DSS Director Stacey Elmes requests the Board's approval for the FY 2017-18 Energy Programs Outreach Plan
- o The plan outlines the procedures for use of Fiscal Year 2017-18 Crisis Intervention Program (CIP) and Low-Income Energy Assistance Program (LIEAP) funding

- o CIP is a year-round program which runs from July 1, 2017 through June 30, 2018 statewide
- o LIEAP application taking will be from November 1, 2017 through March 31, 2018 annually statewide
- Proposed plan is presented to the Board of Commissioners for approval each fiscal year – no major changes in the plan
- o Request the item be placed on the June 26th Action Agenda

Vice Chairman Lankford opened the floor for discussion/questions/comments.

The Board had no issues with the Agenda item and agreed to place the item on the June 26^{th} Action Agenda.

Vice Chairman Lankford, with full consensus of the Board (Chairman Walker absent), directed the Clerk to place the item on the June 26th Action Agenda.

Francisco Elementary School Property - Our Communities of Northwest Stokes

Vice Chairman Lankford noted that Team Leader Texie Jessup would be presenting information to the Board regarding the Francisco Elementary School Property.

Team Leader Texie Jessup, Our Communities of Northwest Stokes (OC), read the following letter to the Board of County Commissioners: (executed copy presented to the Board of Commissioners)

June 26, 2017

Stokes County Board of Commissioners Administration Building 1014 Main Street Danbury, NC 27016

RE: Francisco School Repurposing Memorandum of Understanding

Dear Commissioners:

When the Francisco Elementary School closed in 2015, community members, under the umbrella of the Our Communities of Northwest Stokes initiative, started an effort to examine options for repurposing the facility. Our Communities' leaders held open meetings to engage the broader community in brainstorming sessions that generated ideas for potential uses of the School and grounds. In the spring of 2016, Our Communities reached an agreement of understanding with you that formalized terms of a collaborative effort with a goal of securing the transfer of Francisco

Elementary School from the county to the Our Communities of Northwest Stokes Foundation, a non-profit organization. The community's vision was of a vibrant regional center and public park that would further community and economic development, and provide a broad range of opportunities for Stokes residents and visitors.

In the months that followed, Our Communities' team leaders met regularly with you and other county representatives to discuss the progress of the research. We appreciate that during the period of the agreement the County provided financial support for upkeep of the building and grounds. The playground remained open to the community. Volunteers made repairs and improvements to the playground equipment, the baseball field, the basketball court, and the Ag Building. They created a walking trail, added an information kiosk and Little Free Library, and planted a garden. This work alone consumed more than 1,200 volunteer hours and was paid for entirely by private donations. We held two large, successful community events on the grounds, and throughout the year, area families enjoyed a beautiful place to meet and play. Despite the building being vacant, the School remained an asset.

During the June 15 Working Group meeting, it was agreed that the continued use of and public access to the playground (Francisco Community Park) would be discussed as an agenda item during this meeting. Specifically, OC requests that the BOCC approve continued public utilization of the FES playground (Francisco Community Park), in concert with OC, effective July 1, until such time as the FES property is disposed of by the county. OC suggests use of the same or similar terms as to outdoor uses as originally approved and effective under the MOU.

More than a year ago we embarked on an exploration of options for the repurposing that required thousands of volunteer hours and thousands of dollars. We reached out to local churches and organizations and to resource people in a wide variety of fields, from agriculture to the arts, to education, social services, law enforcement and construction. We worked with agencies and organizations at all levels in various ways. Here is just a sampling:

- Site Visits / Meetings: YVEDDI; Piedmont Triad Regional Council; U.S. Department of Agriculture; Preservation NC; Forsyth Tech; Stokes County Arts Council; NC Agricultural Extension; Stokes Partnership for Children; Seeds of Hope, and YMCA.
- Reuse Property Visits: Spencer-Penn Centre; L.H. Jones Resource Center; and Cedar Grove Park (Community Center).
- Forums: Construction Professionals Network Institute; State Library of North Carolina; NC Rural Economic Development Center.
- Consultations: UNC's Center for Community and Economic Development; NC Arts
 Council; Golden Leaf Foundation; NC Small Business & Technology Development Center;
 NC Department of Commerce; Appalachian Regional Commission; NC Department of
 Environmental Quality; NC Department of Natural and Cultural Resources.

While some OC leaders were looking for partners, possible tenants, grants and other funding opportunities, others were working with construction professionals to assess the building and capital needs and conduct tests that were critical in evaluating the viability of the project. A three-person task force collected and analyzed all the data and information, reported progress at monthly community meetings and issued a draft report in May. Two meetings were held to discuss the draft and gain consensus, and, finally, community members voted.

After our extensive investigation, the community has reached the painful conclusion that Our Communities, acting alone, will be unable to realize the communities' dream of making the Francisco Elementary School campus a center for economic development, recreation, community events, and continuing education. Without the continued active participation of County government, we cannot underwrite the high costs associated with the repurposing of the School. Thus, Our Communities respectfully declines the transfer of the property to Our Communities of Northwest Stokes Foundation.

You all have voiced appreciation for the central place the School has held in the Francisco area for almost a century. Community members have worked tirelessly these past several years to assure that, in a different way, it will hold a similar place far into the future. We trust that whatever plans you develop for the disposition of the property, you will honor the goals of the effort and we entreat you to seek a buyer who will invest in the community and develop an enterprise in an industry that will contribute to sustainable economic progress and the betterment of Northwest Stokes County.
