Ward/Hauser to adopt agenda moving consent agenda items 6g and 6e to the regular agenda. Carried.

Fett/Ward to approve the following bills - General Fund - \$4,454,259.27, Capital Fund - \$78,222.47, Cable TV - \$5,163.02, TID #2 - \$323.00, TID #4 - \$21,702.49, and Solid Waste Enterprise Fund - \$19,703.92 for a grand total of \$4,579,374.17. Roll call: All voted aye. Carried.

Introduced by Fett. Fett/Ward to adopt. Discussion took place regarding the original intent of the Council to have this marina to promote transient boaters, the difficulty the City has in managing a marina when no one is on site, that there are 21 total slips, that there is a waiting list for seasonal slips. Catarozoli/Hauser to amend the recommendation to allow for eight transient slips. Further discussion took place. Ward/Fett to call for the question. Carried. Vote on amendment: Amendment failed. Catarozoli/Allmann to include eight transient and overnight slips. After further discussion the motion and second was withdrawn. Catarozoli/Hauser to amend the motion to

dedicate four slips to transient or overnight and four slips to transient. Vote taken on the amendment: Amendment failed. Vote taken on original motion. Carried with Catarozoli voting no.

We, the Finance/Purchasing & Building Committee, hereby recommend to waive the bidding requirements as set forth in the City Purchasing Policy to allow for sole source purchasing and accept the proposal from Camera Corner in the amount of \$16,653.79 for the purchase and installation of video cameras and audio recording equipment for four interview rooms at City Hall.

Introduced by Fett. Fett/Hauser to adopt. Discussion took place regarding why Camera Corner was the sole bidder. It was explained that the current system that the City uses was installed by Camera Corner and at that time there were no other bidders, additionally staff has been trained on the system which is compatible with our IT capabilities. Allmann/Ward to amend the motion to read %bree rooms in the Police Department and one room in City Hall+. Carried. Voted taken on the original motion as amended. Carried.

RECOMMENDATION

We, the Community Protection & Services Committee, hereby recommend to release the available Combination Class B Beer/Liquor license.

COMMUNITY PROTECTION & SERVICES COMMITTEE By: Richard Wiesner, Chr.

Introduced by Wiesner. Catarozoli/Ward to adopt. Discussion took place regarding whether or not to hold the license for potential economic development or consider issuing the license. Carried with Wiesner and Vandertie voting no.

RECOMMENDATION

We, the Finance/Purchasing & Building Committee, hereby recommend to waive the bidding requirements as set forth in the City¢ Purchasing Policy to allow for sole source purchasing and accept the proposal from Camera Corner in the amount of \$26,157 for the installation of the door security system at Municipal Services with the additional funding needed in the amount of \$17,901 to be transferred from capital budget line item 10-400-000-59065 rubber tire loader, to 10-160-000-59040, security system upgrade and use the excess in the capital budget item from the City Hall door security system.
