Some city boards, commissions and committees require volunteers to be residents of the City of Janesville, while others allow non-residents to volunteer. Also, some citizen members are appointed by the Council President, while others are appointed by the City Manager.

Please use the table below to understand the residency requirements and appointing authority of each board, commission and committee.
