Re: Local Arts board Ordinance revision

Date: May 10, 2023

Item: Local Arts Board Ordinance Update

Discussion: The Local Arts Board presents a proposed revision to the organizational ordinance that created the Board (City of Sturgeon Bay, Wisconsin Code of Ordinances §1.166) to increase the number of members on the Board from five (5) to seven (7) to:

1. Allow a wider cross-section of the diverse arts offered in the community (painting, sculpture, architecture, literature, poetry, music, cinema, theatre, dance, etc.) to be represented on the Board.
2. Aid in creating a more comprehensive conversation to improve the level of support the Board can offer the City to achieve its goal in promoting all categories of public art.
3. Aid in establishing a quorum for Board meetings during what is the high season for the City's arts community (May through October).

Options:

1. Approve the updated Ordinance as drafted.
2. Refer the proposed Ordinance back to the Local Arts Board with recommendations for revision.
3. Choose not to approve the proposed revised ordinance as drafted and the Local Arts Board continues to function in accordance with the existing ordinance.

Recommendation: Joint Parks and Recreation Board and Committee approve the proposed revisions to the Local Arts Board's organizational ordinance as approved by the Local Arts Board at their meeting on May 5th, 2023 and forward to Common Council.

1.166 Local arts board.

- (1) *Purpose.* The purpose and tasks of the local arts board are to promote cultural and artistic enrichment and diversity within the city, to connect city residents and visitors through arts and culture, to enrich publicly owned spaces and buildings through arts and culture, to help facilitate arts and culture related communication and collaboration within the community, and to provide the structure through which artistic and cultural proposals involving public spaces and buildings may be considered. Cultural and artistic proposals may include, but are not limited to: music, dance, creative writing, visual art, performance art, installation, photography, theater, film, arts education and craftsmanship.
- (2) *Created; membership.*
 - (a) The local arts board of the City of Sturgeon Bay is hereby created.
 - (b) The local arts board will be appointed by the mayor subject to common council confirmation. It will be composed of representatives from the following constituencies:
 1. One (1) elected member/alder from the board of parks and recreation.
 2. Six (6) representatives of the local arts community to include artists and/or local arts community members.
 - (c) The term for each member shall be three years.
 - (d) Member's service shall be limited to three consecutive three-year terms. Members may be asked to serve again after being off the board for one term (three years).
- (3) *Powers and duties.*
 - (a) The local arts board shall evaluate any works of art or artifacts proposed for placement on city property. Said items may be submitted directly to the local arts board or submitted to the local arts board via the park and recreation committee. The local arts board shall, after discussion, consideration, and vote, make recommendations back to the park and recreation committee (and common council when appropriate) regarding:
 1. The appropriateness of the work of art proposed to be located on municipally owned property.
 2. The location for the placement of the art proposed to be located on municipally owned property.
 - (b) The local arts board shall serve in a design review capacity, upon referral by the park and recreation committee, for architectural structures placed on city property when the primary purpose of the structure is for cultural expression.
 - (c) The local arts board shall act upon any other similar or related request the park and recreation committee may delegate as it relates to the committee's expressed purpose under subsection (1).

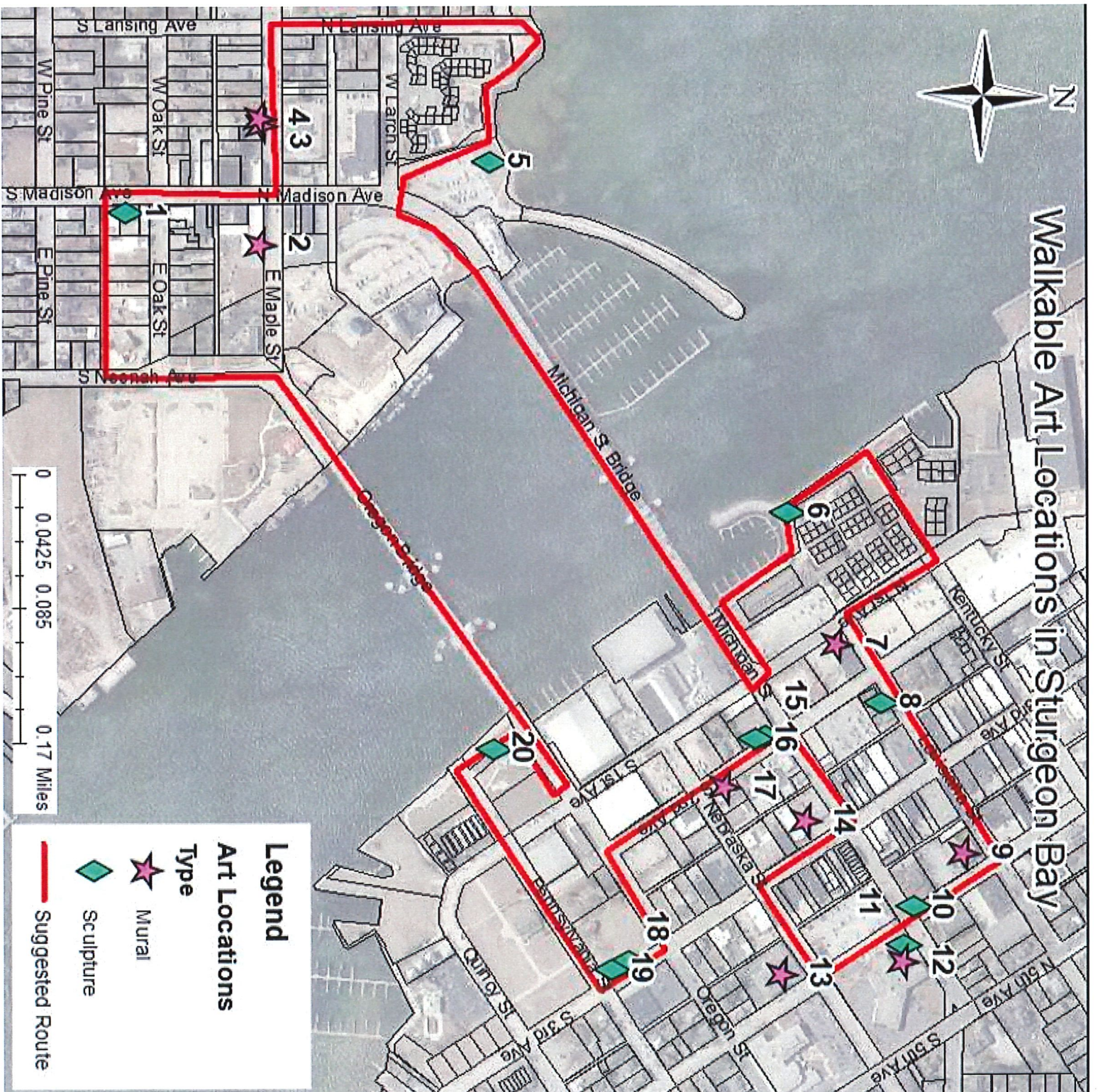

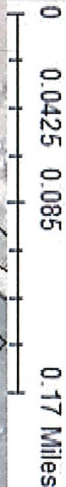
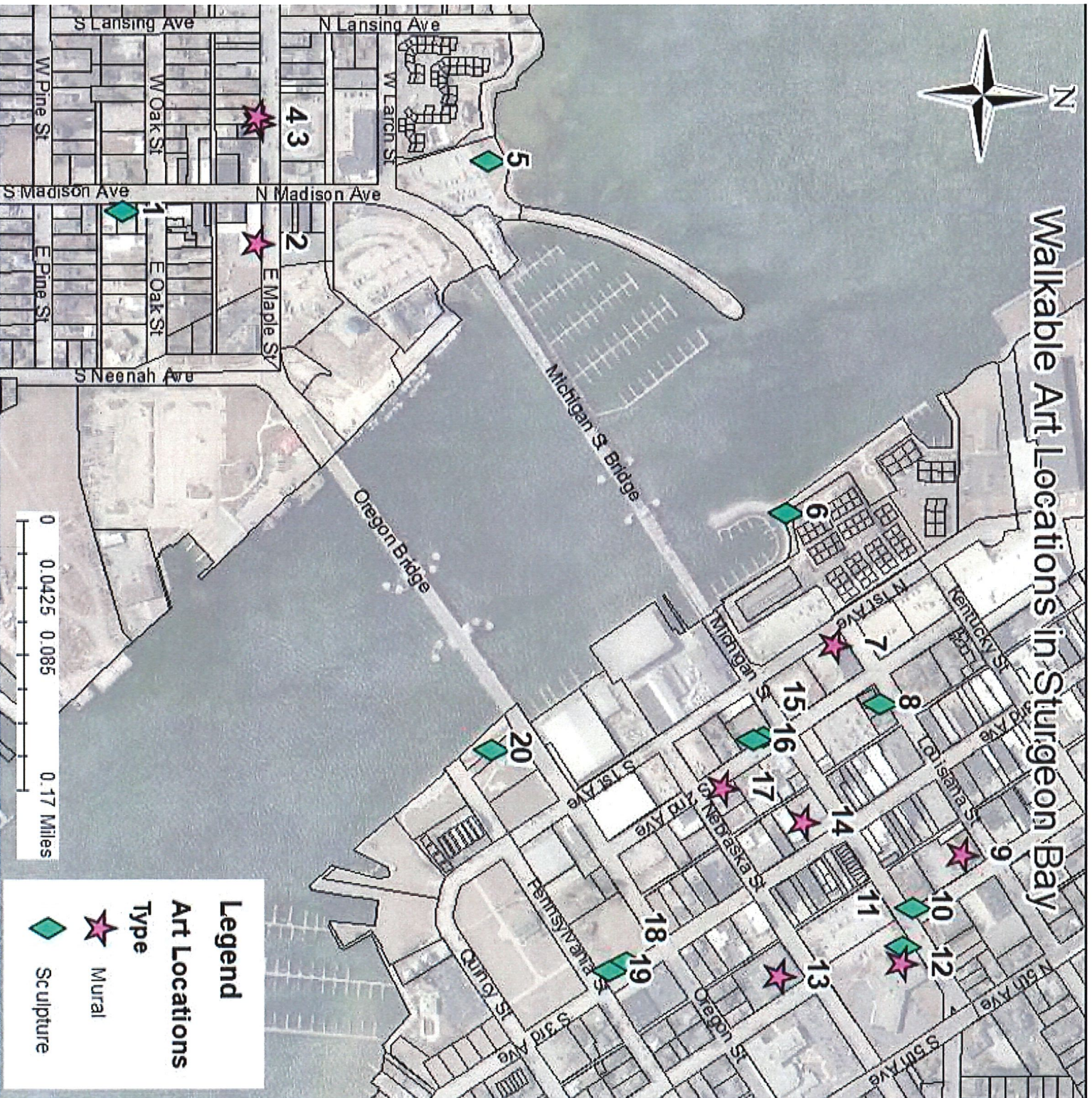

Walkable Art Locations in Sturgeon Bay



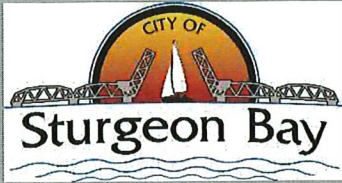

Sculptures & Murals

#1 - 120 South Madison Avenue.

This [Living Wall](#) was created by youth art campers participating in the United Way of Door County sponsored [2022 STRIDE Creative Summer Art Program](#) with local artist / art therapist [Jodi Rose Gonzales](#) as program and creative director. The Program's featured artist was Sister Bay fused glass artist [Gary Chaudoir](#) and also featured Door County woodworker [Joel McOlash](#). The installation enhances the south wall of the Jodi Rose Studios / Enclave by Jodi Rose Studios, 120 South Madison Avenue, and is easily viewed from the adjacent sidewalk and south-side parking lot.

#2 - 14 South Madison Avenue.

Wisconsin artist(s) [Erin LaBonte](#) in collaboration with [Don Krumpos](#), [Gabby Krumpos](#), and community volunteers created the [Paint by Number CommUNITY Mural](#) at Bayside Bargains, 14 South Madison Street, on the corner of Madison and Maple Streets. The mural was sponsored by the Sturgeon Bay Historical Society and [Door County Granary Project](#) through the generosity of a private donor to honor the historic Teweles & Brandeis Granary. The mural covers the north and west sides of the building and is best viewed from Maple Street.

#3 - 41 West Maple Street.

Sturgeon Bay native [Meg Lionel Murphy's](#) [*Catch and Release*](#) adorns the front of The Hours, 41 West Maple Street, a gallery just one block west of Madison Avenue in west Sturgeon Bay. Be sure to look around the corner of the building, as a second mural faces the alley to the west (see below).

#4 - 41 West Maple Street.

[*Tug*](#), also by Sturgeon Bay native [Meg Lionel Murphy](#), embellishes the west side of The Hours, 41 West Maple Street, and is best viewed from the alley off Maple Street to the west of the building.

#5 - 10 West Larch Street, Bay View Park.

[Carl Vanderheyden's](#) [*Woolly*](#) roams Bay View Park, 10 West Larch Street, along the Sturgeon Bay Segment of the [Ice Age National Scenic Trail](#) and was a generous gift to the City of Sturgeon Bay from local citizens and businesses. The 1,200-mile trail crosses Wisconsin following the southern reaches of the immense flow of glacial ice that sculpted the remarkable beauty of Wisconsin some 12,000 years ago. Sturgeon Bay, an [Ice Age Trail Community](#), is the home of the trail's eastern terminus and *Woolly* is the City's very own Ice Age Trail mascot.

#6 - 107 North First Avenue, East Waterfront Promenade
Green Bay, WI sculptor [Steven Haas's *Crosswind Approach*](#) is on display along the City's East Waterfront Promenade (in front of the Stone Harbor Resort) through the generosity of the artist as part of the City's [Revolving Sculpture Loan Program](#).

#7- 59 North Second Avenue.

[*Tambourine*](#) was designed by local musician [pat mAcDonald](#) and painted by Eau Claire, Wisconsin artists [Jason Anhorn](#) and [Steve Bateman](#). The mural was commissioned by the Holiday Music Motel for their Tambourine Collaboratory Building at 59 North Second Avenue. Though the building is located on the corner of Second Avenue and Louisiana Street, the mural covers the south and west sides of the building and is best viewed from First Avenue.

#8 - 221 Louisiana Street.

It's a ZOO out there! This collection of painted metal, animals and their pelican friend are displayed on the west lawn of a private home at 221 Louisiana Street. These unusual pieces are much loved by young and old alike, but as they are privately owned, please respect the homeowner's privacy and remain on the Louisiana Street sidewalk as you view them.

#9 - 359 Louisiana Street, Sturgeon Bay Post Office.

Wisconsin artist [Santos Zingale's](#) *[Fruits of Sturgeon Bay](#)* was commissioned during the nation's Great Depression by the U.S. Treasury Department's Section of Fine Arts for the U.S. Post Office, Sturgeon Bay. The full mural hangs in the post office lobby, 359 Louisiana Street, above the Postmaster's door. The post office is on the corner of Louisiana Street and Fourth Avenue. This piece was removed, restored by Wisconsin artist and conservationist [Anton Rajer](#) and reinstalled in 1984.

#10 - 354 Michigan Street.

Sturgeon Bay artist [Robert C. "RC" Anderson](#) created *[Garden Kaleidoscope](#)*. This piece is privately owned and displayed for public enjoyment by Stangel Accounting and Tax Office / MBE CPAs, 354 Michigan Street, on the corner of Michigan Street and Fourth Avenue. The owners graciously change the floral displays throughout the seasons. The kaleidoscopic views are even more amazing when one spins the bowl.

#11 - 421 Michigan Street, City Hall.

With design rendered by Wisconsin artist [Mark Mille](#) and casting by Domus Dei Sud foundry in Rome, Italy, the *[Bronze Eagle Monument](#)* sits atop the Veterans Memorial at Sturgeon Bay's City Hall, 421 Michigan Street. The eagle depicts [Old Abe](#), an icon in Wisconsin Civil War history. Old Abe was an American bald eagle who served with the Eighth Wisconsin Volunteer Infantry Regiment and participated in over 30 battles.

#12 - 421 Michigan Street, City Hall

Wisconsin artists [Erin LaBonte](#) and [Don Krumpos](#) created [***UW Sea Grant 50th Anniversary Mural***](#) through a commission by the [University of Wisconsin Sea Grant](#) in celebration of their 50th anniversary. The mural is displayed at City Hall, 421 Michigan Street.

#13 - 107 South Fourth Avenue.

Door County Native [Jessie Kalmbach Chase's Twin Murals](#) once flanked the stage of the old Sturgeon Bay High School auditorium. The murals are now under the care of the [Miller Art Museum](#) and are on display in the Sturgeon Bay Branch of the [Door County Library](#), 107 South Fourth Avenue, on the corner of South Fourth Avenue and Nebraska Street.

#14 - 253 Michigan Street.

Local artist and painter [Aaron Holland](#) created the mural [***North Pierhead Light, Sturgeon Bay Canal***](#) which adorns the east wall of the BP gas station, 253 Michigan Street, on the corner of Third Avenue and Michigan Street. The mural faces and is best viewed from Third Avenue.

#15 - 7 South Second Avenue.

[***Meadowlark***](#) by Milwaukee, WI sculptor [Dan Bresnahan](#) (formerly of Door County) is displayed in the [Steel Bridge Creative District](#) on the grounds of the Margaret Lockwood Gallery, 7 South Second Avenue on the corner of Second Avenue and Michigan Street. The sculpture faces and is best viewed from Second Avenue.

#16 - 7 South Second Avenue.

[September Shore](#) by Milwaukee, WI sculptor [Dan Bresnahan](#) (formerly of Door County) is displayed in the [Steel Bridge Creative District](#) on the grounds of the Margaret Lockwood Gallery, 7 South Second Avenue, on the corner of Second Avenue and Michigan Street. The sculpture faces and is best viewed from Second Avenue.

#17 - 64 South Second Avenue.

[Jacob Troglin's](#) graffiti-like [SB14](#) "tags" the front of the Popelka Trenchard Gallery & Glass Studio, 64 South Second Avenue, on the corner of Second Avenue and Nebraska Streets in the [Steel Bridge Creative District](#). Troglin is an Alabama native, now living in Pennsylvania, who, as a young artist working with graffiti and modern street art, was offered space on the gallery wall to experiment during a visit to Sturgeon Bay.

#18 - 207 So. Third Avenue, Martin Park.

[Cell-Owl](#) was created by Town of Oasis, WI carver [Garret Wendlandt](#). The piece was commissioned by the City of Sturgeon Bay and carved from the remains of an Ash tree removed from Martin Park, 207 So. Third Avenue. The cello fits the site perfectly as this park contains the City's bandstand and is home to the summer concert series ["Harmony by the Bay"](#).

#19 - 207 So. Third Avenue, Martin Park.

[Centennial Capsule](#). This piece, donated by the Fred Peterson Foundation, is made of Aluminum and was fabricated by the employees of the former Peterson Builders of Sturgeon Bay in 1976. It identifies the location of a time capsule buried on that spot in Martin Park, 207 So. Third Avenue, to commemorate the nation's bicentennial year. The capsule will be unearthed and its contents and history revealed by the City Administrator in 2076.

#20 - 10 Pennsylvania Street, Graham Park.

Designed by local sculptor [Robert L. Soukup](#), [Confluence](#) sails through the newly renovated Graham Park, 10 Pennsylvania Street, and was sponsored by [Destination Sturgeon Bay](#) through the generosity of private citizens and local businesses. This piece was fabricated entirely by the employees of Fincantieri Bay Shipbuilding in Sturgeon Bay and is the City's only sculptural fountain.

CALL FOR ART – 2023 SCULPTURE LOAN PROGRAM

The Local Arts Board of the City of Sturgeon Bay is seeking a 3D sculpture that will be displayed outdoors on the City's popular East Waterfront Promenade as part of our Sculpture Loan Program.

About our city:

Sturgeon Bay is a successful combination of recreational and commercial waterfront with a vibrant downtown. It is the county seat of beautiful Door County, Wisconsin. Ours is a vibrant coastal community spanning both sides of the waters of Sturgeon Bay. Two downtown bridges connect a public walking path along much of our bustling city-center waterfront. There are multiple viewing points to look at the beauty of bay and watch wildlife, sailboats, kayaks, recreational fishers, powerboats, and the massive Great Lakes commercial fleet.

Along our east waterfront, there is a large, landscaped display space that showcases one loaned sculpture on a 2-year rotation. This space is part of our highly trafficked East Waterfront Promenade and a very popular stop on the "Walkable Sturgeon Bay" route. We are seeking a sculpture for this location.

Location of the sculpture:

The location is along the public East Waterfront Promenade in front of the Stone Harbor Resort at 107 No. 1st Avenue. The photo below shows the installation of the current sculpture on display.



Selection Guidelines:

The piece will be selected by the Local Arts Board with approval by the City's Common Council. The selected artist will receive:

1. A one-time stipend of \$750.00
2. Press announcements, including local press and features on the City's website and Facebook page.
3. An artist's sign, including details regarding purchase of the piece, if it is for sale, and your contact information. You will provide this information and approve the sign before it is installed.
4. Exposure as your piece is viewed and enjoyed by tens of thousands of people each year.

How pieces will be evaluated:

Sculptures will be judged based on artistic excellence and workmanship, creativity, originality, the extent to which the piece enhances the location, and suitability for display in Sturgeon Bay.

Timeline:

June 1st, 2023 – Call for Art is open

July 31st, 2023 – Digital Submission and application due at City Hall, 421 Michigan St., Sturgeon Bay, WI 54235

September 6th, 2023– Finalist notified

September 7th - October 11th, 2023 – Contract negotiation

October 16 - November 17th, 2023– Sculpture installation

Submission Guidelines/Requirements:

- Please submit an artist's statement (max five hundred words) and a short statement about the piece and its relevance to this call. A downloadable form is attached.
- Include digital photos of the piece.
- All sculpture mediums are acceptable.
- Pieces must be ready to install.
- Please do not make any significant changes to the piece after submission
- Transport and installation of the piece will be the responsibility of the artist. However, assistance from the City's Department of Public Works may be available.
- The loan period is two years. If the piece is sold before the end of the first year on display, we ask that artist commit to keeping the piece in place for one-year following installation. If the piece is sold after the one-year mark, the artist is free to remove the piece at their expense. In either case, artist offer a second piece for consideration by the Local Arts Board.
- Artist understands a contract will be established between the City of Sturgeon Bay and the artist.
