SEPTEMBER 5, 2013

The City Council of the City of Temple, Texas conducted a Special Meeting on Thursday, September 5, 2013, at 3:30 PM, at the Municipal Building, 2 North Main Street, in the 3rd Floor Conference Room.

1. Discuss, as may be needed, Regular Meeting agenda items for the meeting posted for Thursday, September 5, 2013.

Regular Agenda Item #5 (Z-FY-13-26) - Mayor Dunn inquired on the cell tower and who the applicant is.

Ms. Lyerly stated that Verizon is the applicant for this item.

Councilmember Schneider asked about the abutting property behind the site?

Ms. Lyerly stated that a small portion of the slab would be taken.

Regular Agenda Item #6 (Preliminary Plat Brayson Crossing) - Mr. Blackburn stated there was a meeting with staff and County Officials. County expressed their concerns with the preliminary plat and that they had no authority. They also expressed concerns over the standards for which the streets would be built.

Mr. Graham stated County does not allow for private street or roads; but the City does. We, the City will have platting authority and have addressed some of County's concerns in this process and County will do the final inspection per the agreement.

Councilmember Schneider asked which authority would approve the cross sections and curbs? And why are we involved in this as it is in the ETJ?

Mr. Graham stated this was discussed with Commissioner Cortez, and the applicant will build with exception to width, to County standards. The only reason you are considering this plat is due to the fact that the applicant is

asking for exceptions.

Ms. Lyerly stated they are asking for an exception to the Fire Code and Park Fees.

Councilmember Cloud asked the applicant why she is requesting a private road.

The applicant stated that she wishes to make this a gated community and the County does not allow for gated communities.

Ms. Foutz stated there are letters on file from the supporting first responders and jurisdictions that they are 'ok' with this width of the gated opening.

Consent Agenda Item #4(O),(P); and (Q) related to annual contracts - Mr. Blackburn pointed out to the Council this item will approve 49 different contract over \$4 million.

Ms. Mattke, gave a brief explanation of item 4(P4) related to water meters. This is to recommend the 2nd lowest bidder as the lowest bidder, Zinner Performance Meters. There were concerns by staff for the quality of the meters and were unable to get samples.

Consent Agenda Item 4(C) - Demo Contracts - Ms. Myers stated the address of 813 East Avenue N was listed twice by mistake. 813 East Avenue N is to be listed only once and needed to add 1309 South 37th Street. The bid tabs were correct as submitted.

Consent Agenda Items 4(K) and 4(L) - Panda - Mr. Blackburn wanted to point out these two items as they are related to Panda and the Effluent line in south and southeast Temple.

 2013-4611: FIRST READING - PUBLIC HEARING - Z-FY-13-26: Consider adopting an ordinance authorizing a Conditional Use Permit to allow a freestanding personal wireless cell tower in an existing Commercial District, located on 0.02 ± acres out of Lot 2, Block 1, Glendale Park, Section VI at 2615 South 37th Street and Tract A, Block 3, Glendale Park Section III, at 2707 South 37th Street.

Tammy Lyerly, City Planner, presented this case to Council. This is a request for a freestanding personal wireless cell tower. The City requires there to be a conditional use permit for any freestanding wireless cell tower. This use is allowed in the property's existing Commercial District, but only for a collocation, per UDC Section 5.4.

Ms. Lyerly noted this request is due to Verizon Wireless network capacity failures within and around the Scott and White Hospital; and the inability to collocate. The proposal is for a 120 foot high monopole cell tower with equipment shelter. The FFA has determined there to no hazard to air navigation. Ms. Lyerly then reviewed the Design Standards within the UDC Section 5.4.5.

Staff recommends approval of the requested Conditional Use Permit for the following reasons: (1) the request complies with the Future Land Use and Character Map; (2) the request complies with the Thoroughfare Plan; (3) Public facilities are available to the subject property; and (4) the applicant has demonstrated compliance with the design standards in Section 5.4.5 of the UDC. Planning and Zoning heard this case at it's August 5, 2013 meeting and approved with a 7/0 vote to allow as requested.

Mayor Dunn declared the Public Hearing open with regards to Agenda Item 5 and asked if anyone wished to address this item.

Andy Camp, KGI Wireless was present on behalf of Verizon Wireless and available for questions. He requested favorable consideration from the council.

There being no further comments, Mayor Dunn declared the Public Hearing closed.

Councilmember Schneider inquired on the abutting property to the North and whether this will cause issues for access.

Ms. Lyerly stated there shouldn't be any issues for first responders; and that this had been reviewed by the Fire Marshal.

Motion by Mayor Pro Tem Judy Morales adopt Ordinance as presented, with second and final reading set for September 19, 2013. seconded by Councilmember Russell Schneider.

Motion passed unanimously.

RESOLUTIONS

 2013-7025-R: P-FY-13-30: Consider adopting a resolution approving the Preliminary Plat of Brayson Crossing, a 6.008 ± acres, 9-lot, 1-block residential subdivision with a requested exception to Unified Development Code related to Park Land Dedication; and Fire Apparatus Access Roads, located in the western E.T.J., at the northeast corner of FM 439 and Sparta Loop.

Tammy Lyerly, City Planner, presented this case to Council. Ms.

Lyerly noted this is for a preliminary plat and the applicant is Mitchell & Associates for JRBC Investments, LLC. DRC deemed this administratively complete on June 26, 2013. There are no zoning regulations in the E.T.J. Ms. Lyerly also noted that water will be provided through a proposed 6-inch and 8-inch water line; and the development will be serviced by septic system. She also mentioned that tract A consists of two private streets with 20-foot rights-of-way widths and 20-foot pavement widths. The developer's proposed entrance islands at FM 439 do not meet the minimum requirements of Chapter 12 of the Code of Ordinance.

Ms. Lyerly then reviewed the exception, which is to propose a private apparatus access road with a combined pavement and concrete ribbon curb width of no less than 14 feet on both sides of the island instead of the required 18-feet. The other exception is for the required park fees in the sum of \$2,025 (\$225 per dwelling) per the UDC. Ms. Lyerly stated the City has not set forth any plans to annex the area proposed for development in the City's Municipal Annexation Plan.

Staff recommends approval of the Preliminary Plat of Brayson Crossing with the developer's requested exception to the UDC Section 8.3.C, and subject to meeting the minimum required 18-foot pavement width on both sides of an entrance island, per Chapter 12, Section 10 of the Code of Ordinance, Fire Apparatus Access Roads; as well as the revised drainage easement to be shown as private as presented. Staff also recommends consideration of Bell County's request that the development's private roads be built to Bell County's Street Construction Standards.

Planning and Zoning Commission hear this case at it's july 15, 2013, meeting and voted 8/0 to recommend approval of the preliminary plat of Brayson Crossing with devleoper's requested exceptions to the UDC Section 8.3.C, and Chapter 12, Section 10 of the Code of Ordinances, Fire Apparatus Access Roads.

Motion by Councilmember Russell Schneider adopt Resolution. seconded by Mayor Pro Tem Judy Morales.

1. Discuss, as may be needed, Regular Meeting agenda items for the meeting posted for Thursday, September 19, 2013.

Councilmember Schnieder stated that he would abstain from item #8.

2. Discuss the Mobility 2035 Metropolitan Transportation Plan.

Mr. Blackburn introduced this item. He stated this document is used as a starting point for prioritizing projects and allocating funds; and that if a project is listed it isn't necessarily going to be funded. The deadline to file with KTMPO is September 30, 2013. The MTP is updated every five years.

Phillip Melton, Intern in Planning presented this item to the Council. He noted the MPO is required in every urbanized area with more than 50,000 people. He also stated the MTP is a 25 year plan while the TIP is a 4 year plan. The MPT (Metropolitan Transportation Plan) is updated every 5 years and considers impacts of national and local travel trends in the Killeen-Temple area; and identifies areas of investment. It also establishes regional priorities for funding. Temple currently has 63 projects on the list; with the top project to be the widening of i-35 between North Loop 363 and South Loop 363; the Outer Loop (new road); Kegley Road (widening); Prairie View (extend and widen); and Poison Oak (extend and widen). The TCIP Projects added are, Westfield Boulevard (extension); Aven U & 13th/ 17th connector (extend and widen); Hogan Road (widen); South Pea Ridge (widen); and North Pea Ridge (widen).

Next Mr. Melton reviewed the RZ Projects added - 1st Street; Loop 363 and 1st Street intersection; Realignment of 1st Street to 5th Street south of

Loop 363; and 5th Street Trail. There are also Tail and Bike Projects, as well as others to include SH 317 widening from FM 2305 to Oak Hills Drive; and the West Outer Loop from North IH-35 to South IH-35.

Mr. Melton also noted there were two project removed from the list due to construction being completed, Wendland Road and Waters Dairy Road.

At this time, approximately 3:58 pm, Mayor Dunn stated that the Temple City Council would enter into an executive session with possible action item on the regular.

- 5. 2013-4606: THIRD AND FINAL READING PUBLIC HEARING: Consider adopting an ordinance authorizing a five year franchise with Acadian Ambulance Service, Inc., to provide non-emergency ambulance transfer services within the City.
- 6. 2013-4607: THIRD AND FINAL READING PUBLIC HEARING: Consider adopting an ordinance authorizing a five year franchise with Scott & White EMS, Inc., to provide non-emergency ambulance transfer services within the City.

Jonathan Graham, City Attorney, presented this item to Council. He noted that both items 5 and 6 are renewals for franchise services within the City. First he discussed item 6 - and stated that Scott and White has been providing non-emergency ambulance transfer service in the City for several years and the current agreement will expires on November 7, 2013. This renewal is for an additional 5 years. Scott and White will pay to the City 3-1/2% of the total amount billed for nonemergency services per year.

Next, Mr. Graham reviewed item 5 - the franchise agreement with Acadian. He noted that in 2011 Council approved an assignment of the Central Texas Regional EMS's franchise to Acadian. The current franchise agreement with the City expires on November 7, 2013. Acadian would like to renew the franchise for an additional 5-years; and will pay to the City 3-1/2% of the total amount billed for non-emergency services per year.

Mayor Dunn declared the Public Hearing open with regards to Agenda Items 5 and 6 and asked if anyone wished to address either item. There being none, Mayor Dunn declared the Public Hearing closed.

Motion by Councilmember Timothy Davis adopt Ordinances (5 and 6) as presented, on third and final reading. seconded by Councilmember Russell Schneider.

Denny Hainley, Benefits Specialist / Acting Civil Service Director, presented this item to Council. She noted that this is brought forward as per Chapter 143. This is to bring the Police Department up to the same standards of the Fire and Police Departments within the community.

Mayor Dunn declared the Public Hearing open with regards to Agenda Item 7 and asked if anyone wished to address this item. There being none, Mayor Dunn declared the Public Hearing closed.

Motion by Councilmember Russell Schneider adopt Ordinance as presented, with second and final reading set for October 3, 2013. seconded by Councilmember Perry Cloud.

Motion passed unanimously.

 2013-4613: FIRST READING - PUBLIC HEARING - Z-FY-13-30: Consider adopting an Ordinance authorizing a zone change from Agricultural District (AG) to General Retail District (GR) on 21.59 ± acres, part of the Nancy Chance Survey, Abstract No. 5, Bell County, Texas, located on the west side of Old Waco Road and the east side of South Pea Ridge Road, east of Westwood Estates.

Tammy Lyerly, Planner, presented this case to Council. Ms. Lyerly noted the applicant for this request is John Martin for Jack Hilliard Jr. The subject property is surrounded by existing and future residential uses, as well as future offices to the north. The Land Use and Character map has a split recommendation for this property. Ms. Lyerly reviewed both the allowed and prohibited uses in GR for both residential and nonresidential. Per the Development Standards, the requested GR District is the standard retail district and allows most retail uses, except apartments. The GR District should be located at the intersection of major arterials and should provide total on-site traffic maneuvering such that traffic entering and exiting the facility should have room to turn, stack and park within the confines of the retail facility. Ms. Lyerly noted, that adjoining zoning districts should be carefully selected to reduce environmental conflicts.

Ms. Lyerly then provided a visual for the Council to understand the split use. She also noted that Old Waco Road requires right-of-way dedication through the platting process, per UDC Section 8.2.1. UDC Section 8.2.3 (Sidewalks) defines South Pea Ridge Road, as a collector, and requires a 4-foot wide sidewalk; defines Old Waco Road, as a major arterial (Outer Loop), and requires a 6-foot wide sidewalk; and since a 10-foot wide spine trail is required along Old Waco Road, the required 6-foot wide sidewalk will need to be upsized to a 10-foot width, with a City oversized participation agreement for the additional 4 feet.

Ms. Lyerly stated there were seven notices mailed out with one returned in favor and one in opposition. Staff recommends denial of the requested zone change from AG to GR for the following reasons: (1) the west half of the property does not comply with the Future Land Use and Character Map; and does not offer sufficient buffering between residential uses and retail uses; (2) although the arterial classification of Old Waco Road complies with the Thoroughfare Plan; Old Waco Road is not built to arterial standards and requires right-of-way dedication and widening; and (3) the existing street facilities are insufficient to support 21 acres of General Retail development; and Water and Wastewater facilities are available to subject property.

Planning and Zoning heard this case at its August 19, 2013, meeting and voted 7/1 to recommend approval of the zone change as requested. Commissioner Magana voted in opposition.

Mayor Dunn declared the Public Hearing open with regards to Agenda Item 8 and asked if anyone wished to address this item.

John Martin, the applicant was available for questions. He asked the Council for favorable consideration of this request.

There being none, Mayor Dunn declared the Public Hearing closed.

This will allow for the developer to complete his due diligence and set up the financing. At that time, we will bring forward a 380 agreement. The developer will ask that the City convey the Hawn Property; intersection improvements; a 10 year tax abatement on the increased property value; assistant with some clean up; for permit fees to be waived; that the city condos and a performing arts area.

Ms. Tanya Reed, Architectural Edge was available for questions. She noted that this project will be for high-end condos and mixed use; and the arcadia building for performing arts activities. But asked the Council for favorable consideration so that the developer could complete the due diligence.

ITEM DESCRIPTION: Consider adopting a resolution authorizing amendment No. 2 to the Interlocal Agreement with the Temple Independent School District providing for one additional Temple Police Department School Resource Officer, made and entered on July 16, 2009.

STAFF RECOMMENDATION: Adopt the resolution as presented in item description.

ITEM SUMMARY: The TISD and the Police Department wish to continue the agreement mentioned in the item description. Under the agreement, the City will bill TISD monthly for the officer's salary, benefits and mileage reimbursement. During the period this agreement remains in effect, the City agrees to furnish an equipped police vehicle and all other training that is required for a peace officer in the State of Texas.

The previous version of the agreement had a specific termination date due to funding considerations by the TISD. At this time, the TISD desires to continue the agreement, which will be effective upon execution by the parties, and then will renew automatically for one-year periods, unless either party gives notice of termination under the provisions in the agreement.

FISCAL IMPACT: TISD will pay salary and benefits for a Police Officer with 30 or less years in with the City of Temple, plus his mileage. The estimated reimbursement from TISD will be \$89,700.

ITEM DESCRIPTION: Consider adopting a resolution authorizing a construction contract with Matous Construction, LTD. of Belton for the replacement of the backwash actuators and valve project at the water treatment plant in the amount of \$148,000.

STAFF RECOMMENDATION: Adopt a resolution as presented in item description.

ITEM SUMMARY: The Conventional Water Treatment Plant utilizes mixed media gravity filters as the final treatment process when producing potable water. The eight (8) mixed filters have multiple pipes and electric actuated valves that allow for proper operation of the filter. The valves and piping compose the effluent, backwash and surface wash systems. The valves allow certain sections of the piping to be used for more than one system (switch from effluent to backwash for cleaning purposes) while maintaining the separation between the finished filter water and the backwash water. Proper operation of these valves and actuators is essential to producing quality drinking water.

The surface wash and effluent valves and actuators were replaced in 2004 along with the backwash valves. However, at that time the existing backwash actuators were retro-fitted and installed on the new valves. The backwash actuators on Filters 1, 2, 4, 5, 6, 7, & 8 are due for replacement. The filter effluent valve on Filter No. 3 does not fully close. Site observations indicate that the valve disc is rubbing on the interior of the adjacent piping. The noted "rubbing" could damage the seat which would lead to the valve body not being able to fully seat and seal the pipe. This project will replace the valve and install a flange filler to allow the new operation without contacting the adjacent pipe.

Also included in this project is the replacement of two electric actuators on the High Service Pump Station (Pumps P-16 and P-18) discharge piping. The referenced actuators are automated and allow the discharge butterfly to open and close slowly, thereby protecting the pump and piping from surges. Once the extent and complexity of the nature of work was fully realized, engineered drawings and contractor bids were solicited, resulting in overall increased costs from the original budget.

On September 17, 2013, two bids were received for the construction work. Per the attached bid tabulation Matous Construction, LTD. submitted the low bid In the amount of \$148,000. Matous Construction has completed several projects of similar scope at the City's Water Treatment Plant in the past and has the experience necessary to complete this work.

FISCAL IMPACT: Currently, the available funds for this project is \$19,683 in account 520-5122-535-6310, project 100912. The original budget for this project was \$49,550. A budget adjustment is being presented to Council in the amount of \$128,317 to fund the additional monies needed for this construction contract. The budget adjustment will appropriate money from the Water & Sewer Unreserved Retained Earnings, account 520-0000-373-0411 to Capital Building & Grounds, account 520-5122-535-6310, project 100912.

On September 17, 2013, the City of Temple received competitive bids from two (2) contractors for the WTP Actuator and Valve Project. A Bid Tabulation is provided for your reference.

The attached Bid Tabulation shows Matous Construction, Ltd. of Belton, Texas as the low bidder with a total bid of \$148,000.00. The bids ranged from this low bid to \$170,300.00. Our final opinion of probable construction (OPC) cost was \$115,600. Review of the low bid versus the OPC shows that Bid Item 3 (Replacement Actuators on Backwash Valves) is the main difference in the bid and the estimate. The summation of Bid Items 1,2, 4, 5 and 6 for the OPC and Matous Bid were \$45,600 and \$43,000, respectively. The OPC used \$10,000 per replacement actuator (Bid Item 3) while the actual bid received was \$15,000 per each (Second low bidder had a unit cost of \$17,800). The total differential in this bid item is \$35,000, which is generally the differential between the OPC and the low bid. It is often difficult to estimate the premium that a contractor will apply while bidding a relatively small, specialized rehabilitation project. In this case, the OPC underestimated the installation cost of the referenced actuators.

Matous Construction has completed several projects of similar scope at the City's Water Treatment Plant in the past and has the experience necessary to complete this work. Therefore, we recommend that a contract be awarded to Matous Construction, Ltd. for the WTP Actuator and Valve Project in the amount of \$148,00.00.

ITEM DESCRIPTION: Consider adopting a resolution authorizing a construction contract with A&M Construction and Utilities, Inc. of Rowlett for construction activities required to rehabilitate the water treatment plant elevated backwash storage tank in an amount not to exceed \$179,400.

STAFF RECOMMENDATION: Adopt resolution as presented in item discussion.

ITEM SUMMARY: The City owns and operates an elevated 150,000-gallon backwash storage tank at the water treatment plant in southwest Temple (Map attached). The tank is in need of rehabilitation, including interior and exterior recoating. This project implements the rehabilitation to maintain potable water quality and compliance with TCEQ regulations.

On August 15, 2013, Council authorized a professional services agreement with Kasberg, Patrick & Associates, LP, (KPA) for engineering services required to implement the rehabilitation in an amount not to exceed \$62,600.

Construction services authorized under this contract will rehabilitate the interior and exterior surfaces of a 150,000-gallon elevated storage tank, including miscellaneous repairs and recoating. Base bids ranged from \$169,400 to \$275,220, and total bids including the add alternate for early completion ranged from \$179,400 to \$295,220 (see attached Bid Tab). AMCU was the low bidder for both the base bid and total bid.

AMCU's bid contained discrepancies between the written and numerical amounts for four bid items: Item 1 read "forty-five thousand" vs. the correct numerical amount of "35,000", Item 2 read "eighty-five thousand" vs. the correct "70,000", Item 4 read "sixteen thousand" vs. the correct "14,000", and Item 8 read "one thousand" vs. the correct "25". The bidder confirmed with the Purchasing Department that the numerical amounts are correct and that the total bid price is \$179,400, which is the sum of bid items using the numerical amounts.


The engineer's OPC for this project was \$269,000. KPA recommends awarding the contract to the low bidder, AMCU, for the total bid in the amount of \$179,400 (Recommendation attached).

The 90 days allotted for construction time under the base bid will be shortened so that construction will be completed by December 18, 2013.

FISCAL IMPACT: The cost of this construction contract is \$179,400. Funding in the amount of \$387,214 is available in account 561-5100-535-6904, project 100988.

On September 10, 2013, the City of Temple received competitive bids from eight (8) contractors for the Rehabilitation of the WTP Backwash Tank. The Base Bid for the project allotted 90 days for the construction period. The Add Alternate was for additional cost associated with expedited completion by December 18, 2013. A Bid Tabulation is provided for your reference.

The attached Bid Tabulation shows A&M Construction and Utilities, Inc. of Rowlett, Texas as the low bidder at \$169,400.00 for the Base Bid and also for the Total including the Add Alternate at \$179,400.00. The bids ranged from this low bid to \$295,220.00. Our final opinion of probable construction cost was \$269,000.

A&M Construction and Utilities, Inc. is currently the contractor for the rehabilitation of two elevated storage tanks in the City of Belton and we have found their performance to be satisfactory. During our review of their qualifications for the Belton project, we spoke with numerous references which confirmed A&M Construction and Utilities, Inc.'s ability and qualifications to perform this type of work.

Therefore, we recommend that a contract be awarded to A&M Construction and Utilities, Inc. for the Rehabilitation of the Water Treatment Plant Backwash Tank in the amount of \$179,400.00.

In order to renew the contract, the vendor must agree to hold their prices firm for an additional year, which they are willing to do.

Staff has evaluated the pricing and believes that the pricing as noted in the item description is still a good value.

Staff is pleased with the services provided by APAC TX – Wheeler Company and recommends that Council authorize an extension to the contract. This will be the first renewal available under this contract, with three years remaining.

FISCAL IMPACT: Funding in the amount of \$280,000 is available in account 365-3400-531-6527, project 100955. This is a continuation of the overlay project funded in the TCIP program.

\$350,000 is available in account 795-9800-531-6869, project 101007. This is Reinvestment Zone No. 1 funding that will be used to overlay Lorraine Drive and Panda Drive when PANDA completes the roads. ITEM DESCRIPTION: Consider adopting a resolution authorizing the purchase of playground equipment for South Temple Park, Freedom Park and Northwest Hills Park utilizing a BuyBoard contract with We Build Fun, Inc. of Allen in the amount of \$125,381.29.

STAFF RECOMMENDATION: Adopt resolution as presented in item description.

ITEM SUMMARY: Playgrounds are one of the most requested park amenities ask for in our park system. The Parks and Leisure Services Department is requesting authorization to purchase playground equipment for three playgrounds in Temple:

- South Temple Park \$57,864.49
- Northwest Hills Park \$38,725.48
- Freedom Park -\$28,791.32

South Temple Park and Freedom Park are both in need of playgrounds to add recreational activity for residences living around these parks as neither park does not currently have a playground. Northwest Hills has an old, out-of-date, playground that needs to be replaced. The proposed new playground equipment for each park is shown in the attached drawings.

Staff is recommending the purchase the playground equipment utilizing a BuyBoard cooperative contract. The BuyBoard contract is competitively procured, and as such, satisfies the competitive bidding requirements.

Parks Department staff will be installing all three play units. Materials delivered will include the play units, fibar fall safe mulch, border timbers and free standing safety sign and ADA access ramp. It is expected that the playground equipment installations will be complete by spring 2014.

FISCAL IMPACT: The total cost for the purchase of the playground equipment at South Temple Park, Northwest Hills Park, and Freedom Park is \$125,381.29. A budget adjustment is being presented to Council to appropriate funding from Developer Fees, account 110-0000-461-0830 in the amount of \$86,657 to Park Fee Expenditures, account 110-3500-552-6332 for South Temple Park, project 101099 and Freedom Park, project 101103.

Funding in the amount of \$30,430 for the Northwest Hills Park playground equipment is currently available in account 110-5935-552-6310, project 101042. The budget adjustment being presented to Council also includes an appropriation of funds in the amount of \$8,296 for the Northwest Hills Park playground equipment from 351-3500-552-2311, project 350009 to 351-3500-552-6310, project 101042.

ITEM DESCRIPTION: Consider adopting a resolution authorizing the purchase and installation of playground shade structures at South Temple Park, Northwest Hills Park and Freedom Park from We Build Fun, Inc. of Allen in the total amount of \$70,628.84.

STAFF RECOMMENDATION: Adopt resolution as presented in item description.

ITEM SUMMARY: The Parks and Leisure Services Department and the Parks and Leisure Services Advisory Board are recommending that shade structures over playgrounds be installed at all new playgrounds and retrofitted over existing playgrounds as funds become available. Based on the availability of funds, staff is recommending the purchase of shade structures for South Temple Park, Freedom Park, and Northwest Hills Park.

Shade structures for these three park playgrounds are needed as South Temple Park and Freedom Park are currently void of older shade trees in the proposed playground locations. While Northwest Hills does have some older tree growth, they will not provide the shade needed over the proposed playground location.

Staff is recommending the purchase and installation of the shade structures utilizing a BuyBoard cooperative contract. The BuyBoard contract is competitively procured, and as such, satisfies the competitive bidding requirements. A 5% buy board discount will be applied to the shade structures with installation cost - the costs associated are as follows:

 South Temple (52'x 45'x15') Multi-Color Shade w/ installation 	\$29,451.46
 Freedom Park (40'x30'x 17') Multi-Color Shade w/ installation 	\$17,532.05
• Northwest Hills Park (40 x30 x 17') Multi-Color Shade w/installation	\$17,532.05
 Payment and Performance Bonds, Freight and Engineering 	\$ 6,113.28

It is expected that the shade structure installations will be complete by spring 2014.

FISCAL IMPACT: The total cost for three shade structures with installation is \$70,628.84. A budget adjustment is being presented to Council to appropriate funding from Developer Fees, account 110-0000-461-0830 in the amount of \$51,060 to Park Fee Expenditures account 110-3500-552-6332 for South Temple Park, project 101099 and Freedom Park, project 101103. Funding for the Northwest Hills Park is available in account 110-5935-552-6310, project 101042.

ITEM SUMMARY: In August 2013, an order for purchase of 15,900 green curbside recycling containers was placed (authorized by Council on July 18, 2013) with first delivery (1 truck load) received on September 19th. Delivered containers were a much darker shade of green, and very near black. To resolve the issue, Toter has offered to sell the City these nearly black containers for use in Temple's regular garbage collection system, while proceeding to manufacture and ship the correct color of recyclable containers for recyclable use. Five truck loads (3,180 containers) have been manufactured, and are available for purchase with the City's logo already embossed on the containers. Manufacturer of the correct color of recycling containers is already underway, with the first shipment to occur in early October. This schedule will not impact the start date of city-wide curbside recycling collections, scheduled to begin in early January 2014.

Each year, the Solid Waste Division purchases new 96-gallon residential refuse containers both for new service and for regular container replacement. As such, staff is recommending that Council accept Toter's offer to purchase the 3,180 dark green containers.

The pricing offered for these containers by Toter through the National IPA contract is \$45.15 per container, plus \$4,478.80 for freight. This pricing is consistent with the recycling container purchase authorized by Council on July 18, 2013, and staff deems this pricing to be a good value based on the increased commodity pricing of resin over the last six (6) months.

The City has done business with Toter, Inc. and finds them to be a responsible vendor. Utilizing this contract through the National IPA cooperative purchasing organization satisfies competitive bid requirements.

ITEM DESCRIPTION: Consider adopting a resolution authorizing participation in the Texas Municipal League, Intergovernmental Risk Pool to provide property, liability and worker's compensation coverage for the City.

STAFF RECOMMENDATION: Adopt resolution as presented in item description.

ITEM SUMMARY: The City of Temple has participated in the Texas Municipal League Intergovernmental Risk Pool (TML-IRP) (a risk pool formed by Texas cities to provide insurance-like coverage of potential claims) since approximately 1981. Our experience with TML-IRP has been very positive.

The proposed resolution authorized the City's participation in TML-IRP for the FY2013-2014 at an estimated annual amount of \$401,725 for property and liability insurance and an estimated annual amount of \$658,000 for workers compensation insurance. We have received a proposal from TML-IRP to continue our participation in the risk pool in the following areas:

- General Liability
- Real & Personal Property
- Automobile Liability
- Law Enforcement Liability
- Errors & Omissions Liability
- Dishonestly/Crime
- Workers Compensation (to include volunteers and elected officials)

FISCAL IMPACT: The FY 13-14 budget appropriated approximately \$401,725 for property and liability insurance and approximately \$658,000 for workers compensation insurance.

ITEM DESCRIPTION: Consider adopting a resolution authorizing the receipt of grant funds from the Texas Department of Transportation, Safe Routes to School grant program; to be used for change order #3 on the construction contract with Patin Construction, LLC of Taylor to address the need to connect existing features to the trail project at Lakewood Elementary School in an amount not to exceed \$6,222.

STAFF RECOMMENDATION: Adopt resolution as presented in item description.

ITEM SUMMARY: During the final construction phase of the project TxDOT instructed City staff, BSP Engineers, Inc and Patin Construction, LLC that a certain amount of overruns was acceptable in order to connect a project to existing features (sidewalks, curb and gutter, and street intersections). The overruns are grant eligible and these additional funds need to be accepted from TxDOT as part of the Safe Routes to School grant program.

Approval of the resolution will allow the City to make final actions necessary to secure the funds and to execute the final projects intended by the grant.

FISCAL IMPACT: The City was awarded \$496,725 for the line item construction for this project. A construction contract in the amount of \$458,498 was awarded to Patin Construction which left \$38,227 for additional construction funds available for the project.

Council approved Change Order #1 in the amount of \$47,180 in December 2012. This resulted in a net increase of grant funds awarded to the City in the amount of \$8,953 bringing the total of grant funds awarded for construction to \$505,678. After approval of Change Order #3 the City will recognize additional grant revenue and expenditure in the amount of \$6,222 which increase the total grant funds awarded for construction to \$511,900. The Advance Funding Agreement for this project states in section 13, Local Project Sources and Uses of Funds part C that over run funding of up to fifteen percent (15%) in excess of the approved project construction cost may be approved by the State. The State has approved the additional funding needed of \$6,222.

A budget adjustment is attached for Council's approval appropriating \$6,222 for the additional grant expenditures to 260-3400-531-63-15, project # 100690.

ITEM DESCRIPTION: FIRST READING - PUBLIC HEARING - Z-FY-13-32: Consider adopting an ordinance authorizing a zone change from Agricultural District (AG) to Single-Family Dwelling 2 District (SF-2) on 25.83 ± acres, being part of the Baldwin Robertson Survey, Abstract 17, Bell County, Texas, generally located northeast of Poison Oak Road and east of Carriage House Drive.

PLANNING & ZONING COMMISSION RECOMMENDATION: At its September 3, 2013, the Planning and Zoning Commission voted 5 to 0 to recommend approval of the zone change from General Agriculture (AG) to Single Family Dwelling 2 (SF-2) for the above described property.

<u>STAFF RECOMMENDATION</u>: Conduct public hearing and adopt ordinance as presented in item description on first reading, and schedule a second reading and final adoption for October 17, 2013.

Based on the following discussion, staff recommends approval for a zone change from AG to SF-2 for the following reasons:

- 1. The proposed zoning is consistent with the Future Land Use Map which identifies this area as Suburban Residential;
- 2. The request complies with the Thoroughfare Plan;
- 3. The proposed zoning is compatible with the surrounding uses; and
- 4. Public facilities are available to serve the subject property.

ITEM SUMMARY: According to the City of Temple Comprehensive Plan / Future Land Use Plan (FLUP), the subject property is within the designated Suburban Residential District. The Suburban Residential District is for mid-size single family lots, allowing for greater separation between dwellings and more emphasis on green spaces versus the streets and driveways that predominate in an autourban setting. The request to a Single Family Dwelling 2 zoning district (SF-2) complies with the FLUP. In addition, the SF-2 zoning designation is compatible with the adjacent land use and will continue the suburban pattern of development. The subject property is anticipated to be combined with $34.48 \pm acres (60.31 \pm acres in total)$ for development as a multi-phased subdivision. The $34.48 \pm acre portion$ currently has SF-2 zoning in place. A preliminary plat is being reviewed by the DRC but cannot proceed until after the 2nd reading of this zone change ordinance by City Council.

It should be noted that since the Planning and Zoning Commission's review of the zone change, neighborhood concern about increased traffic and circulation has been brought to staff's attention. Staff has noted that cumulatively, the existing residential development, the subdivisions of Oak Hills, Crest, Carriage House Village Amended and the Oaks at Westwood consists of approximately 560 existing lots and are served by 7 access points. This area is bordered by Hogan Road on the north, Poison Oak Road on the south, State Highway 317 on the west and Woodcreek and Carriage House Drives on the east. Based on 560 lots with 7 access points, the existing area averages 1 access point per 80 lots with all 7 access points connecting to arterial or collector streets. This is consistent with the Thoroughfare Plan and meets the spirit of the Residential Subdivision Entrance / Access Design Standards which requires 1 access point per 75 lots.

The proposed preliminary plat will extend residential development approximately 1400' east of Carriage House Drive and add 194 lots, 754 lots in total to the area described in the previous paragraph. The proposed preliminary plat does not propose any collector streets and the additional lots are all feeding into <u>local</u> streets and could result in increased traffic and circulation issues. Although these issues are addressed at the platting stage of review, it is noteworthy that per UDC Section 8.2.4.D, <u>an additional access connection point</u> will be needed on the southern boundary of the proposed subdivision to connect to a future proposed minor arterial (Poison Oak Road). Staff is actively working with the applicant and their engineer on the specific details and location of the additional access point.

Although it is anticipated the property will be developed with detached single-family residences, there are a number of uses that are permitted by right. Those uses include but are not limited to:

Residential uses Family or Group Home Industrialized Housing <u>Nonresidential uses</u> Farm or Ranch Gas line Regulating Station Fire Station

Prohibited uses include HUD-Code manufactured homes and land lease communities, duplexes and apartments. All commercial and industrial uses are prohibited, except these uses allowed by an approved conditional use permit (temporary asphalt concrete batching plants, a petroleum or gas well or a cemetery, crematory or mausoleum).

Localized Area of Thoroughfare Plan



(Applicant: Jason Carothers)

Mr. Mark Baker, Planner, stated this item would go to City Council for first reading on October 3rd and a second reading for October 17, 2013.

The Future Land Use and Character Map designate this property as Suburban-Residential. There is an eight-inch water line and a six-inch sewer line available in Carriage House Drive and a 24-inch sewer line available on the eastern side of the property.

The zone change is needed for a multi-phase subdivision plat, approximately $60.30 \pm acres$ and 194 lots. The zone change portion consists of approximately $25.83 \pm acres$ of those 60 acres. The preliminary plat cannot proceed until after the second City Council reading of the zone change which is October 17th, based on the current timeline, the plat, if ready, could be before the P&Z Commission as early as October 21st meeting.

Surrounding properties consist of undeveloped land and scattered single family residences to the south and east, undeveloped land and Oaks at Westwood and Southern Draw Subdivisions to the north, and Carriage House Villages Subdivision to the west.

The property is identified as Suburban-Residential district primarily for mid-sized single-family lots. The SF-2 zoning requires a minimum of 5,000 square feet per lot and is the third largest single family lot sized designation. The SF-2 zoning does comply with the Future Land Use and Character Map.

Single Family-Two (SF-2) allowed and prohibited uses are cited.

A comparison of the Development Regulations is shown for Agricultural (AG) and SF-2.

Sidewalks are required along collector streets per Unified Development Code (UDC) Section 8.2.3. Oak Hills Drive and Carriage House Drive are functioning and being designed to meet collector standards.

Five notices were mailed out and zero were returned in favor or opposition.

Staff recommends approval of the request for a zone change from "AG" to "SF-2" for the following reasons:

1. The proposed zoning is consistent with the Future Land Use Map which identifies this area as Suburban Residential;

- 2. The request complies with the Thoroughfare Plan;
- 3. The proposed zoning is compatible with the surrounding uses; and

ITEM DESCRIPTION: FIRST READING – PUBLIC HEARING – A-FY-13-21: Consider adopting an ordinance authorizing abandonment and conveyance of a portion of Shallow Ford West Road, being a .514<u>+</u> acre tract of land out of the George Given Survey, Abstract No. 345, Bell County, Texas and as described in the plat approved by City Council on April 5, 2012, resolution #2012-6594-R; located south of Midway Drive, near the southeast corner of South General Bruce Drive and Midway Drive.

<u>STAFF RECOMMENDATION</u>: Conduct a public hearing and consider the ordinance as presented, on first reading, and schedule second reading and final consideration for October 17, 2013.

ITEM SUMMARY: The applicant, Garlyn Shelton, has submitted a request on behalf of GS Diamond S Holdings LP, to abandon a portion of Shallow Ford West Road, approximately a .514 acre tract for the development of a proposed car dealership.

The portion of Shallow Ford West Road being abandoned will be re-routed to a new location via an access and utility easement. The access and utility easement has already been recorded. A plat was approved by Council on April 5, 2012 that accomplishes this realignment. Please see the attached plat and site plan for the new alignment. Council granted the following exceptions to the city's development standards for the new section:

- Right-of-way width from 55' to 40'
- 25' wide paved section with 2' ribbon curb in lieu of the 36' requirement

In addition, the easement has one 90 degree turn and another that is just larger than 90 degrees around the addition for connection from Shallow Ford West Road to Midway.

Public utility providers servicing the area have been notified; however responses have not yet been received. Staff will provide an update to City Council regarding outside utilities at Second Reading of the ordinance. City water and wastewater lines run parallel with and perpendicular to Shallow Ford West Road at Midway Drive. These utility easements have been retained in the ordinance authorizing abandonment. There are no other utility lines present in this section of Shallow Ford West Road. Property owner notifications were not necessary since the applicant owns the property on both sides of the right-of-way.

FISCAL IMPACT: If approved, the applicant will be allowed to purchase the abandoned roadway section at fair market value. A broker's opinion of value is currently underway. The applicant is the only owner eligible to purchase this portion of the right-of-way since the applicant owns both of the abutting properties.



<u>**Part 2**</u>: The City Council reserves a public utility easement in the entire abandoned roadway to protect existing public utility lines.

<u>**Part 3**</u>: The City Council authorizes the Mayor of the City of Temple, Texas, to execute a Deed Without Warranty conveying the rights and interests of the City of Temple, Texas, to the abutting property owner, which when done, shall be and become a binding act and deed of the City of Temple.

<u>**Part4**</u>: If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

<u>**Part 5**</u>: It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

ITEM DESCRIPTION: FIRST READING – PUBLIC HEARING: Consider adopting an Ordinance authorizing a negotiated settlement between Atmos Cities Steering Committee and Atmos Energy Corp., Mid-Tex Division regarding the Company's 2013 Annual Rate Review Mechanism filing in all Cities exercising original jurisdiction.

<u>STAFF RECOMMENDATION</u>: Conduct public hearing and adopt ordinance as presented in item description on first reading, and schedule a second reading and final adoption for October 17, 2013.

ITEM SUMMARY: The City of Temple is a gas utility customer of Atmos Energy Corporation, Mid-Tex Division and a regulatory authority with an interest in the rates and changes of Atmos Mid-Tex. The City is a member of the Atmos Cities Steering Committee (ACSC), a coalition of approximately 164 similarly situated cities served by Atmos Mid-Tex that have joined together to facilitate the review of and response to natural gas issues affecting rates charged in the Atmos Mid-Tex service area.

Pursuant to the terms of the agreement settling the Company's 2007 Statement of Intent to increase rates, ACSC Cities and the Company worked collaboratively to develop a Rate Review Mechanism ("RRM") tariff that allows for an expedited rate review process controlled in a three-year experiment by ACSC Cities as a substitute to the current Gas Reliability Infrastructure Program ("GRIP") process instituted by the Legislature. The City took action in 2008 to approve a Settlement Agreement with Atmos Mid-Tex resolving the Company's 2007 rate case and authorizing the RRM tariff and in 2013 ACSC and the Company negotiated a renewal of the RRM tariff process for an additional five years.

The RRM renewal tariff contemplates reimbursement of ACSC Cities' reasonable expenses associated with RRM applications. On or about July 15, 2013, the Company filed with the City its first annual RRM filing under the renewed RRM tariff, requesting to increase natural gas base rates by \$22.7 million. ACSC coordinated its review of Atmos Mid-Tex's RRM filing through its Executive Committee, assisted by ACSC attorneys and consultants, to resolve issues identified by ACSC in the Company's RRM filing.

The ACSC Executive Committee, as well as ACSC's counsel and consultants, recommend that ACSC Cities approve the attached rate tariffs ("Attachment A" to this Ordinance), which will increase the Company's revenues by \$16.6 million.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, APPROVING AND ADOPTING A NEGOTIATED SETTLEMENT BETWEEN ATMOS CITIES STEERING COMMITTEE AND ATMOS ENERGY CORP., MID-TEX DIVISION REGARDING THE COMPANY'S 2013 ANNUAL RATE REVIEW MECHANISM FILING IN ALL CITIES EXERCISING ORIGINAL JURISDICTION; ADOPTING A SAVINGS CLAUSE; DETERMINING THAT THIS ORDINANCE WAS PASSED IN ACCORDANCE WITH THE REQUIREMENTS OF THE TEXAS OPEN MEETINGS ACT; DECLARING AN EFFECTIVE DATE.

Whereas, the City of Temple, Texas ("City") is a gas utility customer of Atmos Energy Corp., Mid-Tex Division ("Atmos Mid-Tex" or "the Company"), and a regulatory authority with an interest in the rates and charges of Atmos Mid-Tex;

Whereas, the City is a member of the Atmos Cities Steering Committee ("ACSC"), a coalition of approximately 164 similarly situated cities served by Atmos Mid-Tex that have joined together to facilitate the review of and response to natural gas issues affecting rates charged in the Atmos Mid-Tex service area;

Whereas, pursuant to the terms of the agreement settling the Company's 2007 Statement of Intent to increase rates, ACSC Cities and the Company worked collaboratively to develop a Rate Review Mechanism ("RRM") tariff that allows for an expedited rate review process controlled in a three-year experiment by ACSC Cities as a substitute to the current Gas Reliability Infrastructure Program ("GRIP") process instituted by the Legislature. The City took action in 2008 to approve a Settlement Agreement with Atmos Mid-Tex resolving the Company's 2007 rate case and authorizing the RRM tariff and in 2013 ACSC and the Company negotiated a renewal of the RRM tariff process for an additional five years

Whereas, the RRM renewal tariff contemplates reimbursement of ACSC Cities' reasonable expenses associated with RRM applications. On or about July 15, 2013, the Company filed with the City its first annual RRM filing under the renewed RRM tariff, requesting to increase natural gas base rates by \$22.7 million. ACSC coordinated its review of Atmos Mid-Tex's RRM filing through its Executive Committee, assisted by ACSC attorneys and consultants, to resolve issues identified by ACSC in the Company's RRM filing;

Whereas, the ACSC Executive Committee, as well as ACSC's counsel and consultants, recommend that ACSC Cities approve the attached rate tariffs ("Attachment A" to this Ordinance), which will increase the Company's revenues by \$16.6 million; and

Whereas, the City Council has considered the matter and deems it in the public interest to approve this action.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

<u>Part 1:</u> That the findings set forth in this Ordinance are hereby in all things approved.

<u>**Part 2:**</u> That the City Council finds the existing rates for natural gas service provided by Atmos Mid-Tex are unreasonable and new tariffs which are attached hereto and incorporated herein as Attachment A, are just and reasonable and are hereby adopted.

<u>**Part 3:**</u> That Atmos Mid-Tex shall reimburse the reasonable ratemaking expenses of the ACSC Cities in processing the Company's RRM application.

<u>**Part 4:**</u> That to the extent any resolution or ordinance previously adopted by the Council is inconsistent with this Ordinance, it is hereby repealed.

<u>**Part 5:**</u> That the meeting at which this Ordinance was approved was in all things conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.

Part 6: That if any one or more sections or clauses of this Ordinance is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this Ordinance and the remaining provisions of the Ordinance shall be interpreted as if the offending section or clause never existed.

Part 7: That if ACSC determines any rates, revenues, terms and conditions, or benefits resulting from a Final Order or subsequent negotiated settlement approved in any proceeding addressing the issues raised in Atmos' 2013 RRM filing would be more beneficial to the ACSC Cities than the terms of the attached tariffs, then the more favorable rates, revenues, terms and conditions, or benefits shall additionally and automatically accrue to the ACSC Cities, including the City, without the need for City to take any further action. If this automatic adjustment occurs, Atmos Mid-Tex shall promptly thereafter file with the City an amended tariff documenting the adjustment to rates.

Part 8: That this Ordinance shall become effective from and after its passage with rates authorized by attached tariffs to be effective for bills rendered on or after November 1, 2013.

Part 9: That a copy of this Ordinance shall be sent to Atmos Mid-Tex, care of Chris Felan, Manager of Rates and Regulatory Affairs, at Atmos Energy Corporation, 5420 LBJ Freeway, Suite 1862, Dallas, Texas 75240, and to Geoffrey Gay, General Counsel to ACSC, at Lloyd Gosselink Rochelle & Townsend, P.C., P.O. Box 1725, Austin, Texas 78767-1725.

ITEM DESCRIPTION: FIRST READING – PUBLIC HEARING: Consider adopting an ordinance setting out the civil service classifications and setting the number of positions in each classification in the Temple Police Department.

<u>STAFF RECOMMENDATION</u>: Conduct public hearing and adopt ordinance as presented in item description on first reading, and schedule a second reading and final adoption for October 17, 2013.

ITEM SUMMARY: Chapter 143 of the Local Government Code requires that the Council establish, by ordinance, the number of positions in each classification in the Temple Fire Department and the Temple Police Department.

At the July 11, 2013 meeting, Council approved an Interlocal Agreement with the Belton Independent School District (BISD) to add one (1) School Resource Officer (SRO) to the Temple Police Department. FY 2014 budget includes staffing an additional two (2) Police Officers. To accommodate this change, Council must authorize three (3) additional Police Officer positions be added to the ordinance.

FISCAL IMPACT: The FY 2014 Adopted Budget includes funding in the amount of \$114,020 for the two Police Officers. BISD agreed to provide a 70% reimbursement [\$47,313] for the SRO. The FY 2014 Adopted Budget included the reimbursement revenue in the amount of \$47,313, but did not include the additional expense or position for the BISD SRO. A budget adjustment will be presented with the second reading of the ordinance to fund 100% of personnel expenses associated with the BISD Officer.

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, SETTING THE NUMBER OF POSITIONS IN EACH CIVIL SERVICE CLASSIFICATION FOR THE TEMPLE POLICE DEPARTMENT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, Chapter 143 of the Local Government Code requires that the City Council establish, by ordinance, the number of positions in each classification for the Temple Police Department;

Whereas, at the July 11, 2013 meeting, Council approved an interlocal agreement with the Belton Independent School District (BISD) to add one (1) School Resource Officer to the Temple Police Department and the fiscal year 2014 budget includes staffing two (2) additional Police Officers;

Whereas, to accommodate these additions, Council must authorize three (3) additional Police Officer positions be added to this ordinance;

Whereas, funding has been appropriated in the FY13-14 budget for two of the three Police Officers – BISD will provide 70% reimbursement (\$47,313) for the School Resource Officer; and

Whereas, the City Council has considered these matters and deems it in the public interest to authorize these actions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

<u>**Part 1:**</u> The City Council authorizes the staffing of three (3) additional police officers to enhance the Temple Police Department.

<u>Part 2:</u> To accommodate these changes, Council authorizes three (3) additional police officer positions be added to the Ordinance, as outlined in the FY13-14 budget. Council establishes the following Classifications and the Number of Positions of Certified Police Officers for civil service positions in the Police Department:

CLASSIFICATIONS AND POSITIONS OF CERTIFIED POLICE OFFICERS

I. UNCLASSIFIED POSITIONS

A. *POLICE CHIEF* – 1 Position

The Police Chief is appointed by the City Manager. No person shall be eligible for appointment as the Chief of the Police Department who is not eligible for certification by the Commission on Law Enforcement Standards and Education at the intermediate level or its equivalent as determined by that Commission or who has not served as a bona fide law enforcement officer for at least 5 years.

B. *DEPUTY CHIEF* – 2 Positions

No person shall be eligible for appointment as a Deputy Chief who has not served as a Lieutenant or continuously served for a minimum of 2 years as a Sergeant in the Department.

II. CLASSIFIED POSITIONS

A. *LIEUTENANT* – 5 Positions

No person shall be eligible for appointment as a Lieutenant who has not served continuously as a Sergeant in the Department for at least 2 years. In addition to base pay, every Lieutenant having more than 5, 8, 12, 16 or 20 years of service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

B. SERGEANT – 16 Positions

No person shall be eligible for appointment as a Sergeant who has not served continuously as a Corporal in the Department for at least 2 years. In addition to base pay, every Sergeant having more than 3, 6, 10, 15 or 20 years of service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

C. CORPORAL – 16 Positions

No person shall be eligible for appointment as a Corporal who has not served continuously as a Police Officer in the Department for at least 2 years. In addition to base pay, every Corporal having more than 3, 6, 10, 15 or 20 years of

service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

D. *POLICE OFFICER* – 98 Positions

No person shall be eligible for appointment as a Probationary Police Officer who has not met the basic requirements for entrance into the Department. No person shall be eligible for a permanent appointment as a Police Officer who has not completed 1 year of satisfactory performance in the Department. In addition to base pay, every Police Officer who has 1, 3, 6, 10, 15 or 20 years of service in the Department shall receive the amount shown on the attached compensation pan for such increments of seniority.

<u>**Part 3:**</u> If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Part 4: This ordinance shall take effect October 17, 2013.

<u>**Part 5:**</u> It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

Please see the attached board member list.

We recommend the Council designate one member of the board to serve as Chair to fill the unexpired term through December 31, 2013.

(B) The City Council adopted a resolution in June, 2003, establishing policies governing the appointment and training of citizens to City boards.
