# **TEMPLE CITY COUNCIL**

### OCTOBER 3, 2013

The City Council of the City of Temple, Texas conducted a Special Meeting on Thursday, October 3, 2013, at 4:00 PM, at the Municipal Building, 2 North Main Street, in the 3rd Floor Conference Room.

# 1. Discuss, as may be needed, Regular Meeting agenda items for the meeting posted for Thursday, October 3, 2013.

Councilmember Schneider stated he'd like to discuss item 9 related to Board Appointments. The Council discussed this item and recommendations will be made at the Regular Session of the Meeting.

Jonathan Graham, City Attorney reviewed item 7 related to settlement between Atmos Cities Steering Committee and Atmos Energy Corp.

Mayor Pro Tem Morales asked what this means for the residential customers.

Mr. Graham stated it is about a 74-cent monthly increase.

### 2. Receive briefing on NW Loop project.

Mr. Bill Hick, Lochner gave Council a project overview. He noted the NW Loop 363 Project was awarded in June 2012 to James Construction Group, LLC in the amount of \$39,883,619. Work began October 2, 2012; and is currently 34.3% complete as of August 31, 2013, and has been invoiced \$13,688,149. Mr. Hick noted the utility adjustments. City water / wastewater is complete along with Atoms, AT&T; Centrovision; Oncor Delivery; TWC; and Windstream. Mr. Hicks provided several photos of different areas of the project.

Mr. Hick also reviewed the payment structure. TxDOT reimburses \$20 million (which is up front); and through the PTF, TxDOT will reimburse \$15 million at annual payments of \$752k - \$1.5m depending on traffic counts. This payback will span from 11 to 20 years. He also noted the upcoming events and activities related to the project such as grading, drainage;

intersections (Wendland/ Nugent open in November/ December); paving; bridges; and traffic switches to the new lane which is anticipated to occur in November/ December. He noted there will be public meetings in November prior to the switch. Mr. Hicks also noted that the Wilsonart parcel for right-of-way has not yet closed. He mentioned the audit process for this project.

# 3. Receive a City Council continuing education briefing on Water / Sewer Utilities.

Nicole Torralva, Director of Public Works provided Council with part of the Water/ Sewer Utilities presentation. She began by giving some history and background on how Temple came to have its own water utility. She spoke about the different components and each plant, along with water distribution. Ms. Torralva noted there are approximately 600 miles of transmission/ distribution lines throughout the system.

 2013-4614: FIRST READING - PUBLIC HEARING - Z-FY-13-32: Consider adopting an ordinance authorizing a zone change from Agricultural District (AG) to Single-Family Dwelling 2 District (SF-2) on 25.83 ± acres, being part of the Baldwin Robertson Survey, Abstract 17, Bell County, Texas, generally located northeast of Poison Oak Road and east of Carriage House Drive.

Kim Foutz, Assistant City Manager/ Acting Director of Planning, presented this case to Council. Ms. Foutz stated the applicant for this case if Jason Carothers. The City's Comprehensive Plan/ Future Land Use Plan identifies this property as Suburban Residential District. There is an 8" water line and 6" sewer line available on Carriage House Drive; and a 24" sewer line to the eastern side of the property. Ms. Foutz then noted the surrounding uses and zonings. She also reviewed both allowed and prohibited uses as well as the Development Regulations. There were five notices mailed out with one returned in favor and zero in opposition. It is Staff's recommendation to approve as proposed. Planning and Zoning Commission heard this case on September 3, 2013 and voted 5/0 to approve per staff's recommendation.

Mayor Dunn declared the Public Hearing open with regards to Agenda Item 5 and asked if anyone wished to address this item. There being none, Mayor Dunn delcared the Public Hearing closed.

Motion by Councilmember Timothy Davis adopt Ordinance as presented, with second and final reading set for October 17, 2013. seconded by Councilmember Perry Cloud.

Motion passed unanimously.

 2013-4615: FIRST READING - PUBLIC HEARING - A-FY-13-21: Consider adopting an ordinance authorizing abandonment and conveyance of a portion of Shallow Ford West Road, being a .514+ acre tract of land out of the George Given Survey, Abstract No. 345, Bell County, Texas and as described in the plat approved by City Council on April 5, 2012, resolution #2012-6594-R; located south of Midway Drive, near the southeast corner of South General Bruce Drive and Midway Drive. Kim Foutz, Assistant City Manger / Acting Planning Director, presented this case to Council. Ms. Foutz noted the applicant is Garlyn Shelton on behalf of GS Diamond S Holdings, LP. The applicant is requesting a portion of Shallow Ford West (.514 acre tract) be abandoned for the development of a car dealership. The portion of Shallow Ford West Road will be rerouted to a new location via an access and utility easement; of which has already been recorded. A plat was approved by Council on April 5, 2012 that accomplishes this realignment. Ms. Foutz stated the public utilities providers servicing the area have been notified; no responses have yet been received. The City water and wastewater lines run parallel with and perpendicular to Shallow Ford West Road at Midway Drive. These utility easement have been retained in the ordinance authorizing abandonment. Ms. Foutz noted there are no other utility lines present in this section of Shallow Ford West Road. Property owner notices were not necessary since the applicant owns the property on both sides of the right-of-way. If approved, the applicant will be allowed to purchase the abandoned roadway section at fair market value; a broker's opinion of value is currently underway. It is Staff's recommendation to approve the ordinance as presented.

Mayor Dunn declared the Public Hearing open with regards to Agenda Item 6 and asked if anyone wished to address this item. There being none, Mayor Dunn delcared the Public Hearing closed.

Motion by Councilmember Perry Cloud adopt Ordinance as presented, with second and final reading set for October 17, 2013. seconded by Mayor Pro Tem Judy Morales.

There being none, Mayor Dunn delcared the Public Hearing closed.

**ITEM DESCRIPTION:** Consider adopting a resolution authorizing a construction contract with Majestic Services, Inc of Austin for a renovation of the Fleet Services building in the amount of \$150,000.

**STAFF RECOMMENDATION:** Adopt resolution as presented in item description.

**ITEM SUMMARY:** In an effort to properly service the 450 plus City-owned vehicles and equipment maintained by Fleet Services, the renovation of an exterior storage bay to a usable service bay is needed. Staff is recommending enclosing the existing 2,300 sf covered and fenced storage area on the north end of the facility located at 3210 E. Avenue H for use as an additional service bay. Construction will involve the replication of the existing cast-in-place tilt-up concrete walls, so the façade of the new area will match the existing fleet building.

As shown on the attached bid tabulation, on October 3, 2013, two (2) bids were received for the project designed by Architectural Edge, Inc. Since the City nor Architectural Edge have any experience in working with the low bidder, Majestic Services, Inc., references were checked by Architectural Edge and the feedback received indicates that they will be a responsible contractor.

This project is the first phase of a two-phase project to update the Fleet Services building. Phase two will address mechanical and electrical upgrades required to service Natural Gas vehicles, as well as more renovations to the building for the purpose of improving operations. Staff will be presenting phase two to Council within the coming months.

**FISCAL IMPACT:** Funding in the amount of \$640,000 was allocated to account 361-2400-519-6807, project 100999 for CNG improvements for Fleet Services. Currently, \$604,120 is available to fund the construction costs needed to enclose the service bay in the amount of \$150,000.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING A CONSTRUCTION CONTRACT WITH MAJESTIC SERVICES, INC. OF AUSTIN, TEXAS FOR RENOVATIONS OF THE FLEET SERVICES BUILDING, IN THE AMOUNT OF \$150,000; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, in an effort to properly service the 450 plus City-owned vehicles and equipment maintained by Fleet Services, the renovation of an exterior storage bay to a usable service bay is needed;

**Whereas,** staff recommends enclosing an existing 2,300 square feet of covered and fenced storage area on the north end of the facility, located at 3210 East Avenue H, for use as an additional service bay – construction will involve the replication of the existing case-in-place tilt-up concrete walls, so the façade of the new area will match the existing fleet building;

**Whereas,** this project is the first phase of a two-phase project to update the Fleet Services building – phase two will address mechanical and electrical upgrades required to service Natural Gas vehicles, as well as more renovations to the building for the purpose of improving operations;

**Whereas**, funds are available for these renovations in Account No. 361-2400-519-6807, Project 100999; and

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

Now, Therefore, Be it Resolved by the City Council of the City of Temple, Texas, That:

**Part 1:** The City Council authorizes the City Manager, or his designee, to execute a construction contract with Majestic Services, Inc. of Austin, Texas, after approval as to form by the City Attorney, for renovation at the Fleet Services building, in the amount of \$150,000.

**ITEM SUMMARY:** On May 16, 2013 Council adopted a resolution approving the construction of a CNG fueling station. Natural gas will be provided from an existing Atmos Distribution line near the station. A commodity charge is required as part of the utility service of receiving natural gas.

Staff desires to engage Choice! Energy Services of Houston to assist in the procurement of natural gas service to the CNG fueling station. Choice! Energy Services was established in 1994 and has experience in procuring natural gas specifically for CNG fueling stations. Choice! provides comprehensive risk assessment and long-term energy knowledge. Under this agreement Choice! Energy Services will complete the following:

- 1. Collect data, analyze and distribute to third party natural gas suppliers;
- 2. Review prices and contracts / negotiate contract terms and conditions;
- 3. Provide results of pricing effort and make recommendations to the City; and
- 4. Assist in contract execution and contract management.

Choice! Energy Services proposed fee is \$0.15 per MMBtu (approximately \$0.02 per gallon). This fee will be paid by the retail provider to Choice!.

With guidance from Choice!, with respect to timing of the bidding, staff is requesting that Council authorize the bidding process to secure pricing for the City. Bids will be requested for periods ranging from as low as 12 and up to 36months; however, the consultant is anticipating that the City will achieve the best value with the initial contract being a 12-month variable rate contract until public demand for the CNG can be better defined. With a variable rate contract, there are two components to the rate: (1) the commodity rate, which will fluctuate monthly based on the market and (2) the overhead and profit rate, which will be a fixed component of the rate.

The pricing of this commodity is typically only valid for a few days after the bids close. Accordingly, it is necessary to obtain pre-authorization from Council to enter into a contract with a vendor. Based on the bidding results, staff is requesting that Council give the City Manager or the Director of Finance the flexibility to negotiate a price and term that is most advantageous to the City.

**FISCAL IMPACT:** Choice! Energy Services consulting fee will be paid by the contract retail provider directly to Choice!. Based on an annual natural gas usage of approximately 10,274 MMBtu (75,000 gallons), this calculates out to an annual embedded fee of approximately \$1,541.

The consulting fee and the commodity of natural gas are considered part of the cost components that are factored into Solid Waste's FY 2014 fuel budget, account 110-2330-540-2115, account 110-2350-540-2115, account 110-2360-540-2115, and account 110-2370-540-2115.

With the completion of the station, continual maintenance and safety inspections will need to be performed on a monthly basis, to ensure proper operation of the station. The agreement includes the following maintenance and safety inspection practices:

- Preventative Maintenance: included in monthly service costs
- Scheduled Maintenance: included in monthly service costs
- Repair Maintenance: \$89/hour
- Emergency Maintenance: \$128/hour

ZeitEnergy, in partnership with Freese & Nichols, are designing and constructing the CNG fueling station. Based on ZeitEnergy's familiarity with the construction of the station and the equipment being utilized, staff is recommending that ZeitEnergy perform the monthly maintenance and safety inspections. ZeitEnergy has in-house certified technicians that will perform the maintenance and safety inspections.

The proposed agreement is for one (1) year commencing on the first day of operation of the station. The agreement will have the option for four (4) one-year renewals if agreeable to the City and ZeitEnergy.

**FISCAL IMPACT:** A budget adjustment in the amount of \$31,500 is being presented to Council appropriating funds from the Contingency Fund, account 110-1500-515-6532 to Other Contracted Services in the Fleet Department, account 110-3810-519-2623. Contract will be pro-rated for November 2013 at \$1,500 with remaining ten (10) months of FY 2014 priced at \$3,000 per month.

At the request of the City of Temple, we are submitting this proposal for the above referenced project. The project consists of improvements of 23<sup>rd</sup> Street from 25<sup>th</sup> Street to the current property line of the Temple Independent School District (TISD). A preliminary layout of the project is depicted on the attached Exhibit. Improvements include paving, curb and gutter, drainage, grading, sidewalk and other miscellaneous items. The project will develop 100% final design, bid and provide construction phase services for the project. The final product will be plans, specifications and estimates ready for bidding through the City of Temple Purchasing Department with bidding and construction phase services to follow. The intent is to develop this project such that it can be bid with the Avenue R Project to achieve an economy of scale. The design phases for the project can be completed in forty-five days from the notice to proceed. Our preliminary opinion of probable construction cost for this project is \$300,000.

The work to be performed by KPA under this contract consists of providing engineering services for design of the project described above to include 100% design and preparation of plans, specifications, estimates, bidding and construction phase services. All of the improvements proposed are currently in both City of Temple rights-of-way and Temple Independent School District (TISD) property. The areas in TISD property will become City of Temple rights-of-way through this project. Metes and bounds will be developed for use by the City of Temple to acquire the right-of-way from TISD.

KPA will perform quality control and quality assurance (QA/QC) on all deliverables associated with the project.

The following services will be performed:

### I. Design Surveys

- A. Data Collection Obtain and review any existing data from the City and other entities that may have record documents and are allowed to release the information. i.e. Atmos, AT&T, Oncor, etc.
- B. Coordinate survey elements and tie into data points both horizontally and vertically for the Project.
- C. Conduct detailed surveys for the Project. All features will be surveyed and documented.

### II. Civil Design

- A. Prepare layout for the project in accordance with City of Temple standards. Alignment for the project has been preliminarily established by KPA and reviewed by the City of Temple and the stakeholders.
- B. Geometric Design Develop geometric design for the proposed roadway. Geometric design will include horizontal and vertical design with connections to the existing 23<sup>rd</sup> Street infrastructure, future Ralph Wilson Youth Club (RWYC) infrastructure and 25<sup>th</sup> Street. Design shall be in accordance to AASHTO standards.
- C. Street Design Develop a section design for the street to meet the standards of the City of Temple. The street section will utilize a two (2) foot extension of the pavement section behind the back of curb as defined by City of Temple Standards.
- D. Sidewalk Design Develop a section for the sidewalk to be constructed on one side of the proposed roadway. Sidewalk improvements will be designed to meet ADA standards. Our scope for design does not include TMED Standards for lighting, landscape and irrigation. A separate proposal will be submitted for the TMED's Standards if requested at a later date.
- E. Drainage Develop hydrology and hydraulics for the project to create positive drainage to existing conveyance systems. Drainage improvements will be designed to collect storm water from the roadway infrastructure and convey to existing systems. It is unknown at this time if this will be achieved with overland flow or if a channel conveyance will be required. If channel conveyance from the roadway limits to the current conveyance to the east is required, an easement will be needed. This proposal does not include design for detention of storm water. A location for area storm water detention has been identified on the site to accommodate drainage from 23<sup>rd</sup> Street and site drainage from the future RWYC Complex and TISD Improvements.
- F. Details and Standards Develop details and standards for bidding of the project to meet City of Temple standards.

### III. Rights-of-Way

A. Develop metes and bounds for the project to be delivered to the City of Temple for acquisition. Services for acquisition of rights-of-way are not a part of this proposal.

### IV. Bidding

- A. Prepare and submit a signed and sealed Opinion of Probable Construction Cost to the City of Temple. This OPC will be itemized by typical units of construction.
- B. After the project publically advertises, solicit contractors to bid the project.

- F. Attend the City Council for award of the project.

- C. Perform construction administration to include site visits, meeting with the contractor and answer questions and holding progress meetings as required.



**ITEM DESCRIPTION:** SECOND READING - Z-FY-13-32: Consider adopting an ordinance authorizing a zone change from Agricultural District (AG) to Single-Family Dwelling 2 District (SF-2) on 25.83 ± acres, being part of the Baldwin Robertson Survey, Abstract 17, Bell County, Texas, generally located northeast of Poison Oak Road and east of Carriage House Drive.

**PLANNING & ZONING COMMISSION RECOMMENDATION:** At its September 3, 2013, the Planning and Zoning Commission voted 5 to 0 to recommend approval of the zone change from General Agriculture (AG) to Single Family Dwelling 2 (SF-2) for the above described property.

**<u>STAFF RECOMMENDATION</u>**: Adopt ordinance as presented in item description, on second and final reading.

Based on the following discussion, staff recommends approval for a zone change from AG to SF-2 for the following reasons:

- 1. The proposed zoning is consistent with the Future Land Use Map which identifies this area as Suburban Residential;
- 2. The request complies with the Thoroughfare Plan;
- 3. The proposed zoning is compatible with the surrounding uses; and
- 4. Public facilities are available to serve the subject property.

**ITEM SUMMARY:** According to the City of Temple Comprehensive Plan / Future Land Use Plan (FLUP), the subject property is within the designated Suburban Residential District. The Suburban Residential District is for mid-size single family lots, allowing for greater separation between dwellings and more emphasis on green spaces versus the streets and driveways that predominate in an autourban setting. The request to a Single Family Dwelling 2 zoning district (SF-2) complies with the FLUP. In addition, the SF-2 zoning designation is compatible with the adjacent land use and will continue the suburban pattern of development.

The subject property is anticipated to be combined with  $34.48 \pm \text{acres}$  (60.31  $\pm \text{acres}$  in total) for development as a multi-phased subdivision. The  $34.48 \pm \text{acre}$  portion currently has SF-2 zoning in place. A preliminary plat is being reviewed by the DRC but cannot proceed until after the 2<sup>nd</sup> reading of this zone change ordinance by City Council.

It should be noted that since the Planning and Zoning Commission's review of the zone change, neighborhood concern about increased traffic and circulation has been brought to staff's attention. Staff has noted that cumulatively, the existing residential development, the subdivisions of Oak Hills, Crest, Carriage House Village Amended and the Oaks at Westwood consists of approximately 560 existing lots and are served by 7 access points. This area is bordered by Hogan Road on the north, Poison Oak Road on the south, State Highway 317 on the west and Woodcreek and Carriage House Drives on the east. Based on 560 lots with 7 access points, the existing area averages 1 access point per 80 lots with all 7 access points connecting to arterial or collector streets. This is consistent with the Thoroughfare Plan and meets the spirit of the Residential Subdivision Entrance / Access Design Standards which requires 1 access point per 75 lots.

The proposed preliminary plat will extend residential development approximately 1400' east of Carriage House Drive and add 194 lots, 754 lots in total to the area described in the previous paragraph. The proposed preliminary plat does not propose any collector streets and the additional lots are all feeding into <u>local</u> streets and could result in increased traffic and circulation issues. Although these issues are addressed at the platting stage of review, it is noteworthy that per UDC Section 8.2.4.D, <u>an additional access connection point</u> will be needed on the southern boundary of the proposed subdivision to connect to a future proposed minor arterial (Poison Oak Road). Staff is actively working with the applicant and their engineer on the specific details and location of the additional access point.

Although it is anticipated the property will be developed with detached single-family residences, there are a number of uses that are permitted by right. Those uses include but are not limited to:

Residential uses
Family or Group Home
Industrialized Housing

<u>Nonresidential uses</u> Farm or Ranch Gas line Regulating Station Fire Station

**Prohibited uses** include HUD-Code manufactured homes and land lease communities, duplexes and apartments. All commercial and industrial uses are prohibited, except these uses allowed by an approved conditional use permit (temporary asphalt concrete batching plants, a petroleum or gas well or a cemetery, crematory or mausoleum).

# Localized Area of Thoroughfare Plan



**Item 2:** <u>Z-FY-13-32</u>: Hold a public hearing to consider and recommend action on a zone change from Agricultural District (AG) to Single-Family Dwelling 2 District (SF-2) on 25.83 ± acres, being part of the Baldwin Robertson Survey, Abstract 17, Bell County, Texas, generally located northeast of Poison Oak Road and east of Carriage House Drive. (Applicant: Jason Carothers)

Mr. Mark Baker, Planner, stated this item would go to City Council for first reading on October 3rd and a second reading for October 17, 2013.

The Future Land Use and Character Map designate this property as Suburban-Residential. There is an eight-inch water line and a six-inch sewer line available in Carriage House Drive and a 24-inch sewer line available on the eastern side of the property.

The zone change is needed for a multi-phase subdivision plat, approximately  $60.30 \pm acres$  and 194 lots. The zone change portion consists of approximately  $25.83 \pm acres$  of those 60 acres. The preliminary plat cannot proceed until after the second City Council reading of the zone change which is October 17th, based on the current timeline, the plat, if ready, could be before the P&Z Commission as early as October 21st meeting.

Surrounding properties consist of undeveloped land and scattered single family residences to the south and east, undeveloped land and Oaks at Westwood and Southern Draw Subdivisions to the north, and Carriage House Villages Subdivision to the west.

The property is identified as Suburban-Residential district primarily for mid-sized single-family lots. The SF-2 zoning requires a minimum of 5,000 square feet per lot and is the third largest single family lot sized designation. The SF-2 zoning does comply with the Future Land Use and Character Map.

Single Family-Two (SF-2) allowed and prohibited uses are cited.

A comparison of the Development Regulations is shown for Agricultural (AG) and SF-2.

Sidewalks are required along collector streets per Unified Development Code (UDC) Section 8.2.3. Oak Hills Drive and Carriage House Drive are functioning and being designed to meet collector standards.

Five notices were mailed out and zero were returned in favor or opposition.

Staff recommends approval of the request for a zone change from "AG" to "SF-2" for the following reasons:

1. The proposed zoning is consistent with the Future Land Use Map which identifies this area as Suburban Residential;

- 2. The request complies with the Thoroughfare Plan;
- 3. The proposed zoning is compatible with the surrounding uses; and

**ITEM DESCRIPTION:** SECOND READING – A-FY-13-21: Consider adopting an ordinance authorizing abandonment and conveyance of a portion of Shallow Ford West Road, being a .514<u>+</u> acre tract of land out of the George Given Survey, Abstract No. 345, Bell County, Texas and as described in the plat approved by City Council on April 5, 2012, resolution #2012-6594-R. The property is located south of Midway Drive, near the southeast corner of South General Bruce Drive and Midway Drive.

**<u>STAFF RECOMMENDATION</u>**: Adopt ordinance as presented in item description, on second and final reading.

**ITEM SUMMARY:** The applicant, Garlyn Shelton, has submitted a request on behalf of GS Diamond S Holdings LP, to abandon a portion of Shallow Ford West Road, approximately a .514 acre tract for the development of a proposed car dealership.

The portion of Shallow Ford West Road being abandoned will be re-routed to a new location via an access and utility easement. The access and utility easement has already been recorded. A plat was approved by Council on April 5, 2012 that accomplishes this realignment. Please see the attached plat and site plan for the new alignment. Council granted the following exceptions to the city's development standards for the new section:

- Right-of-way width from 55' to 40'
- 25' wide paved section with 2' ribbon curb in lieu of the 36' requirement

In addition, the easement has one 90 degree turn and another that is just larger than 90 degrees around the addition for connection from Shallow Ford West Road to Midway.

Public utility providers servicing the area have been notified; however responses have not yet been received. Staff will provide an update to City Council regarding outside utilities at Second Reading of the ordinance. City water and wastewater lines run parallel with and perpendicular to Shallow Ford West Road at Midway Drive. These utility easements have been retained in the ordinance authorizing abandonment. There are no other utility lines present in this section of Shallow Ford West Road. Property owner notifications were not necessary since the applicant owns the property on both sides of the right-of-way.

**FISCAL IMPACT:** If approved, the applicant will be allowed to purchase the abandoned roadway section at fair market value. A broker's opinion of value is currently underway. The applicant is the only owner eligible to purchase this portion of the right-of-way since the applicant owns both of the abutting properties.



AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, AUTHORIZING ABANDONMENT AND CONVEYANCE OF A PORTION OF SHALLOW FORD WEST ROAD, BEING AN APPROXIMATELY .514 ACRE TRACT OF LAND OUT OF THE GEORGE GIVEN SURVEY, ABSTRACT NO. 345, BELL COUNTY, AND LOCATED SOUTH OF MIDWAY DRIVE, NEAR THE SOUTHEAST CORNER OF SOUTH GENERAL BRUCE DRIVE AND MIDWAY DRIVE; DECLARING FINDINGS OF FACT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; AND PROVIDING AN OPEN MEETINGS CLAUSE.

**Whereas**, the City has a request to abandon a portion of Shallow Ford West Road, being an approximately .514 acre tract of land out of the George Given Survey, Abstract No. 345, Bell County, Texas and described in the plat approved by City Council on April 5, 2013 (Resolution No. 2012-6594-R), and located south of Midway Drive, near the southeast corner of South General Bruce Drive and Midway Drive;

Whereas, the applicant, G S Diamond S Holdings, LP, has submitted a request to abandon a portion of Shallow Ford West Road, an approximately .514 acre tract of land for the development of a proposed car dealership;

Whereas, City water and wastewater lines run parallel with and perpendicular to Shallow Ford West Road at Midway Drive and these utility easements have been retained in this ordinance authorizing abandonment - there are no other utility lines present in this section of Shallow Ford West Road; and

Whereas, the City Council has considered the matter and deems it in the public interest to declare approve this action.

Now, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

<u>Part 1</u>: The City Council abandons a portion of Shallow Ford West Road, being an approximately .514 acre tract of land out of the George Given Survey, Abstract No. 345, Bell County, Texas and described in the plat approved by City Council on April 5, 2013 (Resolution No. 2012-6594-R), and located south of Midway Drive, near the southeast corner of South General Bruce Drive and Midway Drive, more fully described in Exhibit A, attached hereto and incorporated herein for all purposes.

<u>**Part 2**</u>: The City Council reserves a public utility easement in the entire abandoned roadway to protect existing public utility lines.

<u>**Part 3**</u>: The City Council <del>a</del>uthorizes the Mayor of the City of Temple, Texas, to execute a Deed Without Warranty conveying the rights and interests of the City of Temple, Texas, to the abutting property owner, which when done, shall be and become a binding act and deed of the City of Temple.

<u>**Part4**</u>: If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

<u>**Part 5**</u>: It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

**ITEM DESCRIPTION:** SECOND READING: Consider adopting an Ordinance authorizing a negotiated settlement between Atmos Cities Steering Committee and Atmos Energy Corp., Mid-Tex Division regarding the Company's 2013 Annual Rate Review Mechanism filing in all Cities exercising original jurisdiction.

**<u>STAFF RECOMMENDATION</u>**: Adopt ordinance as presented in item description, on second and final reading.

**ITEM SUMMARY:** The City of Temple is a gas utility customer of Atmos Energy Corporation, Mid-Tex Division and a regulatory authority with an interest in the rates and changes of Atmos Mid-Tex. The City is a member of the Atmos Cities Steering Committee (ACSC), a coalition of approximately 164 similarly situated cities served by Atmos Mid-Tex that have joined together to facilitate the review of and response to natural gas issues affecting rates charged in the Atmos Mid-Tex service area.

Pursuant to the terms of the agreement settling the Company's 2007 Statement of Intent to increase rates, ACSC Cities and the Company worked collaboratively to develop a Rate Review Mechanism ("RRM") tariff that allows for an expedited rate review process controlled in a three-year experiment by ACSC Cities as a substitute to the current Gas Reliability Infrastructure Program ("GRIP") process instituted by the Legislature. The City took action in 2008 to approve a Settlement Agreement with Atmos Mid-Tex resolving the Company's 2007 rate case and authorizing the RRM tariff and in 2013 ACSC and the Company negotiated a renewal of the RRM tariff process for an additional five years.

The RRM renewal tariff contemplates reimbursement of ACSC Cities' reasonable expenses associated with RRM applications. On or about July 15, 2013, the Company filed with the City its first annual RRM filing under the renewed RRM tariff, requesting to increase natural gas base rates by \$22.7 million. ACSC coordinated its review of Atmos Mid-Tex's RRM filing through its Executive Committee, assisted by ACSC attorneys and consultants, to resolve issues identified by ACSC in the Company's RRM filing.

The ACSC Executive Committee, as well as ACSC's counsel and consultants, recommend that ACSC Cities approve the attached rate tariffs ("Attachment A" to this Ordinance), which will increase the Company's revenues by \$16.6 million.

Whereas, the City of Temple, Texas ("City") is a gas utility customer of Atmos Energy Corp., Mid-Tex Division ("Atmos Mid-Tex" or "the Company"), and a regulatory authority with an interest in the rates and charges of Atmos Mid-Tex;

Whereas, the City is a member of the Atmos Cities Steering Committee ("ACSC"), a coalition of approximately 164 similarly situated cities served by Atmos Mid-Tex that have joined together to facilitate the review of and response to natural gas issues affecting rates charged in the Atmos Mid-Tex service area;

Whereas, the City Council has considered the matter and deems it in the public interest to approve this action.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

**<u>Part 1:</u>** That the findings set forth in this Ordinance are hereby in all things approved.

<u>**Part 2:**</u> That the City Council finds the existing rates for natural gas service provided by Atmos Mid-Tex are unreasonable and new tariffs which are attached hereto and incorporated herein as Attachment A, are just and reasonable and are hereby adopted.

<u>**Part 3:**</u> That Atmos Mid-Tex shall reimburse the reasonable ratemaking expenses of the ACSC Cities in processing the Company's RRM application.

<u>**Part 4:**</u> That to the extent any resolution or ordinance previously adopted by the Council is inconsistent with this Ordinance, it is hereby repealed.

<u>**Part 5:**</u> That the meeting at which this Ordinance was approved was in all things conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.

**Part 6:** That if any one or more sections or clauses of this Ordinance is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this Ordinance and the remaining provisions of the Ordinance shall be interpreted as if the offending section or clause never existed.

**Part 7:** That if ACSC determines any rates, revenues, terms and conditions, or benefits resulting from a Final Order or subsequent negotiated settlement approved in any proceeding addressing the issues raised in Atmos' 2013 RRM filing would be more beneficial to the ACSC Cities than the terms of the attached tariffs, then the more favorable rates, revenues, terms and conditions, or benefits shall additionally and automatically accrue to the ACSC Cities, including the City, without the need for City to take any further action. If this automatic adjustment occurs, Atmos Mid-Tex shall promptly thereafter file with the City an amended tariff documenting the adjustment to rates.

**<u>Part 8:</u>** That this Ordinance shall become effective from and after its passage with rates authorized by attached tariffs to be effective for bills rendered on or after November 1, 2013.

**Part 9:** That a copy of this Ordinance shall be sent to Atmos Mid-Tex, care of Chris Felan, Manager of Rates and Regulatory Affairs, at Atmos Energy Corporation, 5420 LBJ Freeway, Suite 1862, Dallas, Texas 75240, and to Geoffrey Gay, General Counsel to ACSC, at Lloyd Gosselink Rochelle & Townsend, P.C., P.O. Box 1725, Austin, Texas 78767-1725.

**<u>STAFF RECOMMENDATION</u>**: Adopt ordinance as presented in item description, on second and final reading.

**ITEM SUMMARY:** Chapter 143 of the Local Government Code requires that the Council establish, by ordinance, the number of positions in each classification in the Temple Fire Department and the Temple Police Department.

At the July 11, 2013 meeting, Council approved an Interlocal Agreement with the Belton Independent School District (BISD) to add one (1) School Resource Officer (SRO) to the Temple Police Department. FY 2014 budget includes staffing an additional two (2) Police Officers. To accommodate this change, Council must authorize three (3) additional Police Officer positions be added to the ordinance.

**FISCAL IMPACT:** The FY 2014 Adopted Budget includes funding in the amount of \$114,020 for the two Police Officers. BISD agreed to provide a 70% reimbursement [\$47,313] for the SRO. The FY 2014 Adopted Budget included the reimbursement revenue in the amount of \$47,313, but did not include the additional expense or position for the BISD SRO. A budget adjustment is presented for Council's approval to fund 100% of personnel expenses associated with the BISD Officer.

### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, SETTING THE NUMBER OF POSITIONS IN EACH CIVIL SERVICE CLASSIFICATION FOR THE TEMPLE POLICE DEPARTMENT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, Chapter 143 of the Local Government Code requires that the City Council establish, by ordinance, the number of positions in each classification for the Temple Police Department;

Whereas, at the July 11, 2013 meeting, Council approved an interlocal agreement with the Belton Independent School District (BISD) to add one (1) School Resource Officer to the Temple Police Department and the fiscal year 2014 budget includes staffing two (2) additional Police Officers;

**Whereas,** to accommodate these additions, Council must authorize three (3) additional Police Officer positions be added to this ordinance;

**Whereas,** funding has been appropriated in the FY13-14 budget for two of the three Police Officers – BISD will provide 70% reimbursement (\$47,313) for the School Resource Officer;

Whereas, a budget amendment is presented for Council's approval to fund 100% of personnel expenses associated with the BISD School Resource Officer; and

Whereas, the City Council has considered these matters and deems it in the public interest to authorize these actions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TEMPLE, TEXAS, THAT:

<u>**Part 1:**</u> The City Council authorizes the staffing of three (3) additional police officers to enhance the Temple Police Department.

<u>**Part 2:**</u> The City Council authorizes an amendment to the fiscal year 2013-2014 budget, substantially in the form of the copy attached hereto as Exhibit A.

<u>**Part 3:**</u> To accommodate these changes, Council authorizes three (3) additional police officer positions be added to the Ordinance, as outlined in the FY13-14 budget. Council establishes the following Classifications and the Number of Positions of Certified Police Officers for civil service positions in the Police Department:

### CLASSIFICATIONS AND POSITIONS OF CERTIFIED POLICE OFFICERS

### I. UNCLASSIFIED POSITIONS

### A. *POLICE CHIEF* – 1 Position

The Police Chief is appointed by the City Manager. No person shall be eligible for appointment as the Chief of the Police Department who is not eligible for certification by the Commission on Law Enforcement Standards and Education at the intermediate level or its equivalent as determined by that Commission or who has not served as a bona fide law enforcement officer for at least 5 years.

### B. *DEPUTY CHIEF* – 2 Positions

No person shall be eligible for appointment as a Deputy Chief who has not served as a Lieutenant or continuously served for a minimum of 2 years as a Sergeant in the Department.

### II. CLASSIFIED POSITIONS

### A. *LIEUTENANT* – 5 Positions

No person shall be eligible for appointment as a Lieutenant who has not served continuously as a Sergeant in the Department for at least 2 years. In addition to base pay, every Lieutenant having more than 5, 8, 12, 16 or 20 years of service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

### B. SERGEANT – 16 Positions

No person shall be eligible for appointment as a Sergeant who has not served continuously as a Corporal in the Department for at least 2 years. In addition to base pay, every Sergeant having more than 3, 6, 10, 15 or 20 years of service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

### C. CORPORAL – 16 Positions

No person shall be eligible for appointment as a Corporal who has not served continuously as a Police Officer in the Department for at least 2 years. In addition to base pay, every Corporal having more than 3, 6, 10, 15 or 20 years of

service in the Department shall receive the amount shown on the attached compensation plan for such increments of seniority.

### D. *POLICE OFFICER* – 98 Positions

No person shall be eligible for appointment as a Probationary Police Officer who has not met the basic requirements for entrance into the Department. No person shall be eligible for a permanent appointment as a Police Officer who has not completed 1 year of satisfactory performance in the Department. In addition to base pay, every Police Officer who has 1, 3, 6, 10, 15 or 20 years of service in the Department shall receive the amount shown on the attached compensation pan for such increments of seniority.

<u>**Part 3:**</u> If any provision of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Part 4: This ordinance shall take effect October 17, 2013.

<u>**Part 5:**</u> It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

**ITEM DESCRIPTION:** FIRST READING - PUBLIC HEARING - Z-FY-13-31: Consider adopting an ordinance authorizing an amendment to Ordinance 2008-4230, the *Choices '08*, City of Temple Comprehensive Plan, Chapter 5, to amend the Thoroughfare Plan Map.

**<u>P&Z COMMISSION RECOMMENDATION</u>**: At its September 16, 2013 meeting, the Planning and Zoning Commission voted 8/0 in accordance with staff recommendation to recommend approval of the amendment to *Choices '08*, City of Temple Comprehensive Plan, Chapter 5, to amend the Thoroughfare Plan Map.

**<u>STAFF RECOMMENDATION:</u>** Conduct public hearing and adopt ordinance as presented in item description on first reading, and schedule a second reading and final adoption for November 7, 2013.

**ITEM SUMMARY:** On September 4, 2008, the City of Temple adopted the *Choices '08*, City of Temple Comprehensive Plan. With that plan, the City adopted a Thoroughfare Plan Map, a companion document to Chapter 5 which addressed transportation. The Thoroughfare Plan Map is intended as a guide for roadway network expansion and improvement. Care was taken in the development of the plan to ensure that designated routes follow existing roadway alignments, parcel boundaries, and topography as much as possible. Nevertheless, available funding, changing development patterns, city growth, right-of-way availability, and subsequent roadway realignments necessitate occasional revisions to ensure the map reflects current and projected transportation patterns and connectivity. Planning staff has worked closely with Public Works staff and area stakeholders to identify changes which impact the overall transportation network. In developing these recommendations staff reviewed the following:

- The city's Transportation Capital Improvement Plan project list;
- the Reinvestment Zone Number One Master Plan; and
- Local development activity.

Thank you for the overview you provided regarding the Temple Thoroughfare Plan (Map) to our group. You made it clear that the current Map is somewhat dated and needs to be updated to bring it in line with what is currently on the ground.

We are glad to be able to help you outside our normal vetting practice on this issue as we believe that the changes that you are making are necessary and will do no harm to the local building community. Therefore, on behalf of the subcommittee that met with you today including TABA President Will Sears, Mike Pilkington, John Kiella, Jason Carothers, David Patterson, and myself; TABA would like to provide you with this letter supporting your efforts to complete the Map update before you end your career with the City of Temple.

Further, we propose that updates to the Map occur on a more frequent basis. An annual update is what we would recommend until a process can be developed to allow for maps to be updated as road projects are completed or reclassified.

During our discussion, it seemed that there may also be a need to explore the addition of a new designation to the types of roads that are classified as part of the Thoroughfare Plan. TABA would be amenable to working with the City to explore the possibility of adding a classification to bridge the gap between a "collector" road and an "arterial" road. During the discussion, it seemed some "collector" roads in the City are carrying traffic more suited to "arterials". We offer our assistance in working with the City to figure out how to resolve this issue.

#### ACTION ITEMS

Item 3: <u>Z-FY-13-31</u>: Hold a public hearing to discuss and recommend action on an amendment to Ordinance 2008-4230, the Choice '08, City of Temple Comprehensive Plan, Chapter 5, to amend the Thoroughfare Plan.

Mr. Phillip Melton, Planning Intern, stated Staff was proposing amendments to the Thoroughfare Plan related to the Transportation Capital Improvement Plan (TCIP) and Reinvestment Zone (RZ) No. 1 Master Plan.

The current Thoroughfare Plan was adopted as part of the Comprehensive Plan in 2008 and last submitted in October 2012.

There are 15 proposed changes:

The first four are not yet improved to their respective classifications and are shown as existing on the current Thoroughfare Plan. These will be shown as proposed rather than existing thoroughfares. These include sections of North Pea Ridge Road, Prairie View Road and Hogan Road.

The next three thoroughfares are not currently functioning nor planned to function as currently classified. Proposed updates would reduce their classification to a lower classification. These include Mouser Road, Case Road and McLane Parkway.

Segments 8 through 10 are currently shown as proposed thoroughfares but have been constructed since the last Thoroughfare Plan update. Proposed updates reclassify these as existing rather than proposed thoroughfares. These include Hilliard Road, Westfield, and Central Pointe Parkway.

Segments 11 through 13 are thoroughfares that have been upgraded or downgraded in classification. These changes were adopted as part of RZ No. 1 Master Plan. Proposed updates reflect these changes into the Thoroughfare Plan. These include Avenue U, 13th and 17th Streets and Scott and White Boulevard.

Segments 14 and 15 are new thoroughfare segments that would be added to the Thoroughfare Plan in accordance with RZ No. 1 Master Plan. Segment 14 connects Old Howard Parkway to McLane Parkway and Segment 15 connects Old Howard Road to Wendland Road.

Staff recommends approval of the Thoroughfare Plan and also recommends annual review of the Thoroughfare Plan to ensure it represents current and projected transportation needs.

Chair Sears opened the public hearing.

Mr. John Kiella, 11122 Whiterock Drive, Temple, Texas, stated on the RZ one, Segment 15, they were working with HEB and they had that as a proposed collector; HEB might want that as a private road.

Ms. Kim Foutz, Acting Director of Planning and Assistant City Manager, suggested that if there were any question about it that that portion was not passed right now. This can always come back and be added at a later time. Staff would rather it not be added until at such time the issue is more secured.

Mr. Kiella stated the homebuilders were behind all the other changes but requested Segment 15 be pulled for now.

There being no further speakers, Chair Sears closed the public hearing.

Commissioner Jones made a motion to approve Item 3, Z-FY-13-31, with the exclusion of Segment 15, and Commissioner Johnson made a second.

<u>Part 5</u>: It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such phrase, clause, sentence, paragraph or section.

<u>**Part 6**</u>: This ordinance shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Temple, Texas, and it is accordingly so ordained.

<u>**Part 7**</u>: It is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

**ITEM DESCRIPTION:** Consider adopting a resolution authorizing the East Temple Redevelopment Plan.

**STAFF RECOMMENDATION:** Adopt resolution as presented in item description.

**ITEM SUMMARY:** The East Temple Redevelopment Plan was established to engage residents, businesses, and the larger community in building a thriving East Temple that is characterized by neighborhood, vitality, and civic pride and contributes to the overall economic vitality and life of the City.

This process began in the fall of 2012 with several meetings and discussions with stakeholders and workshops presented to City Council.

The process produced a draft East Temple Redevelopment Plan identified 6 Focus Areas, 17 Goals, and 49 Objectives. The Focus Areas are:

- Existing Residential Redevelopment;
- Residential, Commercial, & Mixed Used Infill Development;
- Workforce Development;
- Existing Commercial/ Industrial Redevelopment;
- Greenfield Residential Development; and
- Streetscape, Public Realm, & Parks.

The East Temple Redevelopment Plan also prioritized the approach to the focus areas, goals and objectives by categorizing them into one of three timelines: short-term (1-5 years), mid-term (5-10 years), or long term (10+ years).

While the East Temple Redevelopment Plan should be viewed as significant and important as a planning guide for the City Council, City staff and the community, it should not be viewed as a resource allocation document. The East Temple Redevelopment Plan should be utilized for what it is... a planning tool. As a planning tool, it should be reviewed and utilized each year during the development of the annual budget. Staff would anticipate that the Plan will change and be modified as time and budgets will influence such.

Above noted, the FY2014 Budget has included several program areas and initiatives that are in concert with this draft East Temple Redevelopment Plan. An example of one of the program areas and initiatives included in the FY2014 Budget is an additional code enforcement officer (approximately \$70,000) to help coordinate multiple goals and objectives listed in Focus Area 1 (Existing Residential Redevelopment). Another example is Focus Area 5, Greenfield Residential Development...where \$500,000 has been appropriated for incentivizing a greenfield residential development.

**FISCAL IMPACT:** As mentioned in the item narrative, the FY 2014 budget includes appropriations in the amount of \$687,420 for the following program areas:

- Neighborhood Improvement and Clean up: \$20,000
- Public Infrastructure Assistance : \$500,000
- Commercial/Industrial Redevelopment: \$100,000 (All SIZ Corridors)
- Proactive Code Enforcement: \$67,420

Future fiscal impacts relating to this Plan will be dependent upon annual budget authorizations and appropriations.
