The current zoning is R-6 High Density Residential District – This district is defined as medium to high density residential areas where single-family and multifamily dwellings are commingled and certain open areas where similar residential development will likely occur. The uses permitted in this district are designed to stabilize and protect the essential characteristics of the area and prohibit all activities of a commercial nature except certain home occupations controlled by specific limitations.

The proposed zoning is C-4 Central Commercial District - This district is defined as certain land and structures that provide personal services, retailing and business services of all kinds for local and regional commerce. The area is located in the heart of the city where major streets and highways converge. The regulations are designed to permit a concentrated development of permitted facilities and to protect the district itself from over intensive development and congestion.

The 2035 Land Development Plan indicates the areas that have not identified for development or redevelopment are suitable for infill development that is consistent with the existing surrounding land uses. 



1. <u>Call to Order</u> – Mayor York called the meeting of the Thomasville City Council to order and welcomed everyone in person and online.

2. Additions and Deletions to the Agenda

Upon request of Council Member Thrift, City Manager Michael Brandt requested that Council move item 5.H. <u>Consideration of Amendment to Thomasville Special Event Permit Policy and Farmers Market Policy to Address the Sale of Alcohol at Special Events</u> from the Consent Agenda to item 6.E. on the Regular Agenda.

Mayor Raleigh York, Jr. added item 8. Closed Session – Attorney/Client.

Council Member Thrift moved to approve the agenda as amended. Council Member Hunt seconded. Motion unanimously approved 6 – 0.

- 3. Public Forum No one came forward to speak.
- 4. <u>Public Hearing</u> <u>Consideration of an Ordinance to Close an Unopened Portion of</u> Kahler Street

Planning Director Chuck George said this property is the back third of the property at 710 Salem Street, near the billboards. There is no access to it from Doak Street or any other adjacent property. The owners want to close this portion of Kahler Street to use the property for further development.

Mayor York opened the public hearing. Nobody spoke for or against this issue. Mayor York closed the public hearing.

Council Member Hunt moved to approve the ordinance. Council Member Shell seconded. Motion unanimously approved 6-0.

This is a revision to the City's Purchasing Policies/Procedures Manual to increase the p-card transaction limit from \$500 to \$3,000.

The Finance Department is responsible for reviewing/approving all p-card transactions daily. There is no change to the purchasing process. This adjustment will just allow departments to purchase from Amazon or in the community easier than if they were using purchase orders.

E. <u>Consideration of Approval of Revision to Personnel Manual Appendix A and to Approve New Job Descriptions in Finance Department</u>

Due to the upcoming retirement of the Lead Accounting Clerk (A/P) in the Finance Department, staff is recommending restructuring the position into a "Purchasing Officer" who will provide central oversight of all city purchasing functions, in addition to the A/P accounting functions previously performed by the Lead Billing Clerk. The position will continue be a Grade 26.

The position of Accounting Clerk II will be replaced with a position of "Accountant," which provides broader duties assigned to what was the Accounting Clerk II position. This will also remain the same Grade 24.

Staffing levels will remain the same. We're not adding any additional staff.

F. Consideration of Amendment to City Ordinance Chapter 2, Article 4, Division 3, Section 2-152 Membership; Terms of Office, Vacancies of Historic Preservation Commission

Due to difficulties in finding qualified candidates to serve on the Historic Preservation Commission, Council is modifying the terms of office to allow individuals to serve longer than two 3-year terms.

G. <u>Consideration of Approval of Extension of Resolution Amending the Thomasville Police Personnel Policy</u>

In April, 2023, the City Council approved a series of short-term policies to allow officers to be paid to cover shifts on an on-call basis. It also allowed reserve officers and/or Thomasville Police retirees to be paid to help with manpower

shortages. The Police Department is requesting that this policy be extended through December 31, 2023.

H. Consideration of Amendment to Thomasville Special Event Permit Policy and Farmers Market Policy to Address the Sale of Alcohol at Special Events (Moved to item 6. E.)

Assistant City Manager Eddie Bowling spoke briefly about each of these items:

This Resolution is for the acceptance of grant funding in the amount of \$400,000 for examination of existing and new data to analyze and identify sources of inflow and infiltration in the sanitary sewer system for elimination.

M.L. Consideration of Light Up the Holidays Road Closure Ordinance

This event is scheduled for November 18, 2023, the Saturday before Thanksgiving and will run from 2:00 P.M. – 9:00 P.M

- c. <u>Quality</u>, <u>Effective Service</u> Through teamwork by supporting and empowering staff to serve the community every day. We continually raise standards and drive our teams to deliver high quality services and processes.
- d. <u>Honesty & Integrity</u> is the foundation for everything we do. We expect everyone to do the right thing even when no one is watching.

Additionally, he advised that six strategic priorities were identified:

- Sustainable Growth and Development We will promote responsible and sustainable development that balances the needs of our residents with the protection of our natural environment.
- Infrastructure Renewal We will invest in our infrastructure to ensure that it is safe, reliable, and efficient, and meets the needs of our growing community.
- Economic Development We will encourage economic growth and diversification by attracting new businesses and industries, supporting existing businesses, and creating employment opportunities for our residents.

- 4. <u>Community Safety and Well-being</u> We will work to create a safe and inclusive community that promotes the health and well-being of all residents.
- 5. <u>Environmental Stewardship</u> We will protect and enhance our natural environment by promoting sustainable practices and reducing our carbon footprint.
- 6. <u>Effective Governance and Leadership</u> We will provide transparent and accountable governance, and foster a culture of innovation and collaboration within our municipal organization.

Council Member Hunt moved to approve the Thomasville City Strategic Plan. Council Member Sellars seconded. Motion unanimously approved 6 – 0.

The Strategic Plan is available on the City website.

B. Consideration for Approval of Bid to Demolish 207 Brown Street and 306 Martin Luther King Drive

Planning Director Chuck George said Council previously condemned both of these homes, which were burned beyond repair. The lowest bids that he received to demo these structures were both from Kennedy Ditching and Trucking. The 207 Brown Street bid was for \$3,500. The 306 Martin Luther King Drive bid was \$2,200.

He said, "Mr. Kennedy has done work for us in the past and done outstanding work for us. So we recommend him for each of these projects."

Council Member Sellars moved to approve the bid from Kennedy Ditching and Trucking to demolish 207 Brown Street and 306 Martin Luther King Drive. Council Member Shell seconded. Motion unanimously approved 6-0.

C. <u>Consideration of Approval of Resolution of Acceptance of a Loan and Grant for</u> Rains Road Pump Station Improvements

City Manager Brandt asked Council to approve this Resolution to accept a loan and grant from the NC the North Carolina Department of Environmental Quality Clean Water State Revolving Fund Loan in the amount of \$1,000,000, as well as American Rescue Plan funding in the amount of \$4,000,000 for the construction of the Rains Road Pump Station Upgrades and installation of approximately 4,800 linear feet of 16-inch force main.

Council Member Sellars moved to approve this resolution. Council Member Hunt seconded. Motion unanimously approved 6 – 0.

D. <u>Consideration of Approval of Resolution of Acceptance of State ARPA Earmark</u> Funds for Waterline Improvements

City Manager Brandt advised that the North Carolina Department of Environmental Quality has offered a State Grant in the amount of \$1,000,000 for the construction of approximately 3,150 LF of 6-inch diameter ductile iron (DI) waterlines to replace existing 2-inch diameter galvanized waterlines along Cramer Street, Ingram Street, Montlieu Street, School Drive, and Willowbrook Drive within the City of Thomasville. The project also involves the transfer of existing water services connected to the existing 2-inch diameter galvanized waterline to the new 6-inch diameter DI waterline.

Council Member Sellars moved to approve this resolution. Council Member Williams seconded. Motion unanimously approved 6-0.

E. <u>Consideration of Amendment to Thomasville Special Event Permit Policy and</u> Farmers Market Policy to Address the Sale of Alcohol at Special Events

City Manager Brandt explained that this new Special Event Permit Policy and Farmers Market Policy would provide clarity as to the approval process and sale of alcohol at events at Pace Park, the Farmers Market, and the Downtown Social District during Special Events.

He said the key difference is that 3rd-party breweries and wineries may serve their own alcoholic beverages, if they hold the proper license. Non Profit Organizations are only allowed to host events that serve alcohol. The sale, distribution, possession and consumption of beer, wine and other alcoholic beverages within the public area shall be in full compliance with all state and local laws governing such matters. For reference on serving alcohol please refer to GS § 18B-1114.5 and the 2022 Festival Participation & Event Permitting Guidelines issued by the NC ABC Commission.

Wristbands must be provided to those approved to consume alcohol. A limit of two beverages per transaction for individuals is required. All sales must end one hour prior to the time listed as end time of the event. This time should be posted at the event.

Council Member Hunt moved to approve this policy amendment. Council Member Williams seconded. Motion approved 5-1 with Council Member Shepherd voting against it.

7. <u>Committee Reports and Appointments, Mayor's Report and Appointments, City Manager's Report, City Attorney's Report</u>

Mayor Pro Tem Williams advised that people will need to have a valid ID to vote in this year's election. She said you can get a free ID at the DMV. Call the Davidson County Board of Elections for further information. She said, "Start figuring that out

now, so you're not caught in November without a picture ID, because everybody needs to vote. Make sure you're registered. It's super important."

<u>Council Member Sellars</u> reminded everyone that school would be back in session soon, and she asked everyone to be extra cautious on the roads. She also suggested that people with time could volunteer at one of our city schools.

<u>Council Member Thrift</u> wished a successful school year to all of the administrators, teachers and students.

<u>Council Member Hunt</u> wished a speedy recovery to fellow Council Member Ron Bratton.

<u>Mayor York</u> attended the funeral of Carolyn Bennett, former Mayor Joe Bennett's wife. He asked that everyone remember that family at this time.

He advised that the 7 West Guilford Street Committee had finished their work and given their recommendations to the City Council about the potential uses for the old police department building. City Council will be in discussions about this matter.

The Davidson County Commissioners have created a new Economic Development Commission. Due to his 8 years of experience on the former EDC, Mayor York appointed himself to the new Board as the voting member from Thomasville. He appointed Council Member Thrift as the alternate, effective through the installation of the new City Council following the upcoming election.

City Manager Michael Brandt reported that the City held a joint training Emergency Operations Event last week focused on preparing for the possibility of a Downtown train derailment event, since Thomasville has over 38 trains passing through the City every day. All City departments, as well as representatives from Davidson Emergency County Operations, Center. 911 Greensboro Response/Hazardous Materials Team, staff from the State Emergency Operations, NCDOT, and Norfolk Southern met for almost 6 hours to walk-through a train derailment. They even heard from the Fire Chief of East Palestine, Ohio, who experienced a similar event earlier this year. It was helpful to gather all these resources together to make a plan of action, in case this type of situation ever occurs. City Manager Brandt thanked Emergency Manager Sam Olshinski, for organizing this event, and all of the participants who attended.

The pool had a very successful first season. Weekday swimming was over for the summer, because many of the lifeguards and staff had to return to school. However, a "Dive-In" Movie featuring "Buzz Lightyear" was scheduled for Saturday, and weekend swimming would remain open on weekends thru Labor Day.

City Manager Brandt expressed his gratitude to Priscilla Oldaker for planning the "Piano's on Main" Event. On August 11, Thomasville had hundreds of people Downtown playing the pianos, listening to pianists, and watching artists paint and sketch. He also thanked the former Miss Thomasvilles who came back to celebrate the Miss Thomasville pageant along with the current Miss Thomasville Queen and her court and the reigning Miss North Carolina.

He announced that September would bring more events to community, including Everybody's Night and Day on September 29 and 30th. Contact the Chamber of Commerce to reserve your craft booth.

<u>City Attorney Misti Whitman</u> reminded people to watch out for children walking and school buses stopping.

She also thanked City staff for all the time and effort they put into creating a Strategic Plan. She said, "I had the opportunity to go through it from top to bottom, and it's a lot of information there, and it was very valuable information."

Assistant City Manager Eddie Bowling thanked the City's MIS department for all they do. He said this division is only comprised of three people, but while their numbers are small, they are mighty! Justin, Damon and Jay ensure that the City's networks are safe and secure. Over the last few weeks, they enabled multi-factor authentication for all user accounts. This was a huge project with 300+ employees and over 200 email addresses. He said, "I am thankful for their willingness to take on this challenge on top of their normal day-to-day operations. You might see them on the side of the road climbing a pole just to fix a camera, or they'll be managing all of the devices in this room...We're very thankful for them."

Secondly, he recognized the work of the Thomasville Police Department. He had the privilege to participate in an event where the TPD hosted a cookout for Kids with Cops. This is the result of a great partnership between our Police Department and Recreation Department. He thanked everyone who made this great event possible.

8. Closed Session – Attorney/Client

Council Member Thrift moved that Council go into closed session for an attorney/client matter. Council Member Hunt seconded. Motion unanimously approved 6-0. Open session resumed, and Mayor York announced that no action was taken in closed session.

9. <u>Additional Items</u> – City Manager Brandt announced that an information session regarding a <u>proposed solar farm</u> on the Baptist Children's Home property would be held on August 23rd & 30th from 5:30 – 6:30 at the BCH Family Resource Center for anyone who is interested in attending.

\$76,000 of fund balance in the Police Restitution/Forfeiture Fund is appropriated for the purchase of a night vision devices and lithium battery-powered illuminator/lasers for the Thomasville PD SWAT team. \$3,500 is appropriated for payment to Martin Starnes & Associates on behalf of the Thomasville Tourism Commission for agreed-upon procedures applied to hotel occupancy taxes remitted to the city in FY 2023.

The amendment appropriates \$4,411 of insurance proceeds in the Police Department for a vehicle accident involving a 2020 Dodge Charger and \$44,440 for hail damage to multiple vehicles. The amendment also appropriates trade-in revenue for Winding Creek's current golf cart fleet to be applied to the purchasing cost of the new fleet.

At the request of our auditors, we are transferring \$595,578 of unspent ARPA grant funds budgeted in the Water/Sewer Capital Project Fund back to the grant Special Revenue Fund to close out FY 2023.

INTERLOCAL AGREEMENT FOR WASTEWATER COLLECTION AND TREATMENT SERVICES BETWEEN DAVIDSON COUNTY, NORTH CAROLINA AND CITY OF THOMASVILLE, NORTH CAROLINA

THIS AGREEMENT, made and entered into this ___th day of September ______, 2023 by and between Davidson County, a North Carolina body corporate and politic, hereinafter referred to as "County," and the City of Thomasville, a North Carolina municipal corporation, hereinafter referred to as "City," for wastewater collection and treatment services;

WITNESSETH:

WHEREAS, North Carolina General Statute §160A-461 authorizes interlocal contracts or agreements between units of local government in this state of reasonable duration as determined by the participating units; and

WHEREAS, pursuant to the laws of the State of North Carolina the City currently operates a public enterprise whereby wastewater is collected, treated, and discharged by permit into the environment for the benefit of Thomasville; and

WHEREAS, pursuant to law, City is authorized to sell wastewater service to County customers that do not reside within the municipal boundaries of the City, hereinafter referred to as "Outside customers," and the City has determined it has adequate wastewater treatment capacity to allocate a portion of this wastewater treatment capacity to new Outside customers, and that such an allocation would be in the best interest of both the City and County, particularly to meet needs for economic development; and.

WHEREAS, the parties agree that the scope of this project contemplates the construction of a sewer line to serve commercial and industrial development along Highway 64 in eastern Davidson County, a growth corridor identified in the Davidson County Land Development Plan; and

WHEREAS, State and Federal regulatory authorities are promoting regionalization of wastewater treatment as a means of improving regional water quality and both Thomasville and Davidson County see this project as mutually beneficial for promotion of economic growth for the citizens of Thomasville and Davidson County; and

WHEREAS, with the excess capacity at its sewer treatment plant City believes that it can treat the needs of industrial, commercial and development customers in the Highway 64 corridor; and

WHEREAS, the City and County desire a long-term wastewater service partnership

which facilitates orderly growth and development within the County in proximity to the City of Thomasville.

NOW, THEREFORE, in consideration of the respective rights, power, duties and obligations hereinafter set forth to be performed by City and County and in consideration of the reservation of wastewater treatment capacity of 1,000,000 gallons per day to the County, the parties mutually agree as follows:

- 1. **Wastewater Capacity Allocation** The City of Thomasville's Wastewater Treatment Plant (WWTP) currently has an approved National Pollution Discharge Elimination System (NPDES) permit for treatment of 6.0 million gallons per day (MGD). The City will allocate one million gallons per day (1.0 MGD) wastewater capacity of its wastewater collection and treatment system for new County Customers.
- 2. **Request for Additional Capacity** It is the intent of the parties hereto to develop a long-term partnership for wastewater treatment and collection services. As such, the allocated wastewater capacity included herein may be increased upon mutual agreement by the parties. When the County's actual monthly wastewater volume reaches eighty percent (80%) of the County's allocation, and should additional wastewater treatment capacity be available at the City's wastewater treatment plant, the parties agree to negotiate in good faith, to increase the allocation of wastewater capacity to the County.
- 3. **Sewer Line Construction** In exchange for the (1.0 MGD) of wastewater capacity allocation referenced above, the County agrees to construct a sewer line within the Hwy 64 corridor connecting to the City's treatment plant located in the Hamby Creek area. A map reflecting the anticipated location of the area to be served by this line is attached to this Agreement as Exhibit "A".
- County Assumption of Trinity Wastewater Allocation The parties acknowledge that City has previously allocated up to one million gallons per day (1.0 MGD) of its wastewater treatment capacity to the City of Trinity, hereinafter referred to as the "Trinity Allocation. The City acknowledges the County's desire to purchase the Trinity Allocation from the City of Trinity. City agrees to approve the transfer of the Trinity Allocation to the County, with the understanding that all outstanding debt owed by the City of Trinity shall be paid in full. As of September 12, 2023, the outstanding debt is \$2,989,005.13, payable in equal payments of \$498,167.52 through the end of Fiscal Year 2029 (June 30, 2029). City may purchase a minimum of 200,000 gpd from the Trinity Allocation acquired by County, within ten years of such acquisition by County, with the purchase price being established as the price per gallon paid by the County to the City of Trinity. Should the County actually allocate or commit (1.2 MGD) within the ten-year timeframe mentioned above, the City will have 120 days to make the request for purchase of wastewater capacity from the County or forfeit such purchase rights. If the City wishes to purchase wastewater capacity beyond the ten-year timeframe, the right to sell and price per gallon will be negotiated between the two parties at the time of the request.

5. Ownership, Operations and Maintenance - The City shall retain ownership, operations, and maintenance responsibility of the wastewater collection system, including wastewater pipelines and pumping stations that convey wastewater to the WWTP under the terms of this Agreement. The County shall transfer ownership of the collection system infrastructure after issuance of an Engineer's Certification of Substantial Completion. The County shall at that time assign all rights, title and interest to the City subject to the terms of any financing requirements for funding of the infrastructure. In order to assist the City with the cost of operating the new County sewer system, both the County and City have agreed that the County will provide interim funding to the City for annual maintenance. Once operational, the system will have a one-year warranty period and therefore, excludes the County from paying the City for maintenance cost.

The parties stipulate and agree that for purposes of this section the annual maintenance cost shall be established as the total sewer installation cost paid by the county multiplied by 4.375 percent. For example, if the total sewer installation cost is \$35,765,750 then the annual maintenance cost would be \$1,564,752. In years two through four of this Agreement the County will pay to City a sum equal to twenty percent (20%) of the annual maintenance cost provided, however, that such payment by County will be reduced by service provided to outside customers. The calculation and "maximum" gpd required (51,902 gpd) to meet the "break-even" threshold for the County to cease payment to the City for maintenance cost is listed within the table below:

In year five and beyond, if the "break-even" threshold is not achieved by the County, the County's maximum obligation for annual maintenance costs increases from twenty percent (20%) to twenty five percent (25%), or \$391,188. This figure is the maximum cost the County will share, as any actual use / fees collected by Outside customers will be deducted from the above-mentioned totals. Should the City re-allocate wastewater gallons from the current system (Hwy 109 area) to the new regional system, the wastewater gallons transferred will be deducted from the City's wastewater allocation and not the County's.

- 6. Should the County construct future sewer infrastructure, the County will transfer ownership, all rights, title and interest to the City. In addition, the two parties will utilize the maintenance formula above to charge the County for related maintenance cost.
 - 7. Wastewater Quality Considerations and Wastewater Requirements All

wastewater quality requirements shall comply with the City of Thomasville's sewer use ordinance in the City's Code of Ordinances as such may be amended from time to time. The County acknowledges the City's right to monitor and enforce the requirements of this ordinance, including the City's pretreatment program for all wastewater customers subject to this Agreement.

- 8. **Wastewater Collection and Treatment Operations** The wastewater collection and treatment system services being allocated to the County shall at all times meet the standards for collection and treatment of wastewater pursuant to Federal, State, and local regulations, under which standards the City treats wastewater at its wastewater treatment plant.
- 9. **Collection System Extensions** The City and County shall cooperate in any proposed collection system (sewer) line extensions, according to the following:
 - 9.1 The County's allocated capacity must be used within the proposed service areas included in this document. However, the County may elect to re-prioritize the implementation of the sewer system within these service areas. Should the County desire to allocate capacity beyond these service areas, this Agreement must be amended, by action of the City and County. The service areas include those areas as delineated in Exhibit A to this Agreement.
 - 9.2 For the purposes of this agreement, the Nucor Corporation facility's initial (2023) sewer allocation will be allocated and deducted from the City's portion of their wastewater treatment system capacity. Additional wastewater treatment capacity needed by Nucor for future expansion (beyond initial 2023) amount, will be shared by the County and City (50% / 50%). For example, if the initial 2023 gallons per day amount totals 55,000 and Nucor proposes an expansion to 110,000 gallons per day, the County will provide the City with 27,500 gallons per day (55,000 / 2 = 27,500) in wastewater capacity from the County's allocation.
 - 9.3 It is anticipated that certain property owners from whom easements are needed for the construction of the County sewer line may require access to the new sewer line in exchange for their granting of such an easement. In these instances, if the business is an already existing establishment, the City will provide wastewater allocation. If the business is considered "new" or is an "expansion" of an "existing" business, the County will provide wastewater allocation.
 - 9.4 The County shall have the right to prioritize and utilize the allocated capacity within the service areas designated in Exhibit A of this Agreement. It is recognized that the County wastewater system expansion will likely be driven by one or more of the following: economic development; Board of Education school needs, both existing and future; communities requesting wastewater service by petition; public health necessities (e.g. failing septic systems or package plants); and requests by privately financed development. However, it is also recognized the system

- expansions under this agreement are intended to be in the best interest of both the City and County; therefore, the City reserves the right to determine whether or not the City will accept the lines and appurtenances based on the impact of maintenance, upkeep, and other associated costs that come with such acceptance.
- 9.5 The County and City shall have the right to mutually determine collection system capacity needs and line sizes based on their determination of future flows, economic development opportunities, and expected growth within the area identified in Exhibit A.
- 9.6 For those requesting wastewater service extensions, the City and County will evaluate whether the service extension should be oversized beyond the needs of the requesting party to better serve the entire public system. If both the City and County agree to the oversizing of the line extensions, the project may be completed with the agreed to line sizes dependent of funding.
- 9.7 The County Manager or his designee shall answer questions and inquiries about service within the County's wastewater service areas covered by this Agreement. Further, the County Manager or his designee shall review and approve all wastewater service prior to submitting requests for use of the wastewater allocation to the City for consideration.
- 9.8 The County shall require landowners requesting private extensions having the capability to be further extended beyond the applicant's property to grant an easement to continue the extension across the entire width of the property prior to approval of the plans. The County shall cause all wastewater collection extensions to be constructed across the entire frontage width of an applicant property whenever it is feasible to extend future service beyond said applicant property.
- 9.9 Neither the County nor the City shall be responsible for the construction, operation, repair, or maintenance of any collection system main, outfall, pumping station, force main, service lateral or other appurtenance outside of the right-of-way or any easements obtained as part of a collection system project.
- 9.10 The County will be responsible for condemnation efforts as required to obtain property or property easements for projects subject to this Agreement.
- 9.11 The County shall pay all easement and right-of-way acquisition costs for wastewater line extensions pursuant to this Agreement beyond the City's municipal boundaries.
- 9.12 In order to ensure that extensions of the wastewater collection system under this agreement will meet City of Thomasville standards and specifications for acceptance by the City, plans and specifications to be used in bidding and awarding construction contracts are subject to review and approval by the City. The City

- will utilize similar criteria for review and approval of the collection system as that applied within the City's current service area, and subject to the same sewer system policies, standards, and details. Both City and County approval must be granted prior to advertisement of the project for bids for construction.
- 9.13 The City will coordinate with the County and will participate in the public bidding of all wastewater collection system projects.
- 9.14 The City will coordinate with the County and will participate in all construction administration efforts including resident field representation associated with these projects and the review of pay requests.
- 9.15 For all projects pursuant to this Agreement, the County shall coordinate payment for engineering and construction costs of collection system extensions into County service areas.
- 9.16 The City shall have the right of approval for the Final Completion of all collection system line extensions and collection system expansion projects within the service areas subject to this Agreement. Upon City approval, the ownership, operation, and maintenance shall pass from County to City in accordance with the provisions of Article 5 herein.
- 10. **System Development Fees for Wastewater Service** The City may approve system development fees for wastewater service that are calculated as required by Article 8 of Chapter 162A of the North Carolina General Statutes. The City will collect system development fees from new wastewater customers, including Outside customers. System development fee revenues will be accounted for by means of a capital reserve fund established pursuant to Part 2 of Article 3 of Chapter 159 of the North Carolina General Statutes. Expenditure of system development fee revenues will be limited to those purposes authorized by Article 8 of Chapter 162A of the General Statutes.
 - 10.1 In addition to any future approved system development fee, Outside customers shall be subject to the standard fees and other charges paid by wastewater customers according to the most current fee schedule as approved by Thomasville City Council.
 - 10.2 The City shall collect all system development fees and tap fees prior to the issuance of a building permit.
 - 10.3 The City will not increase "annually adjusted" sewer rates on Outside customers beyond 225% of the current sewer rates paid by customers within the City of Thomasville.
- 11. **Annexation Impact to Costs of Service** Should any Outside customers that fall under the terms and conditions of this Agreement be subsequently annexed by the City of

Thomasville, the following provisions shall govern:

- 11.1 The wastewater service rate paid by Outside customers annexed into the City will immediately be reduced to the prevailing service rate inside the City.
- Should the City annex property within the County, the City will pay the County a price per gallon (gpd) for wastewater that is transferred from the County to the City. The price per gallon shall equal the cost of the County system divided by the total County wastewater allocation (\$35,765,750 / 1,000,000 gpd = \$35.76 per gallon).
- 11.3 The change in County capacity allocation will be reflected on the annual summary report.
- 12. **Flow Determination for Billing** Flow determination for County customers will be based on one of the following:
 - 12.1 Individual metering of City-supplied potable water.
 - 12.2 Individual metering of Davidson Water Company supplied potable water. The City will coordinate with Davidson Water for meter reading results for the purposes of billing of Outside residents.
- 13. Flow Determination for Benchmarking Capacity Allocation Used by the County It is important to keep current the County's capacity allocation commitments to new customers within the service area. The County shall maintain a record of these commitments and provide an annual report to the City regarding capacity utilized to date and remaining available capacity. The annual report may take the form of a brief letter summarizing this information and an Excel spreadsheet or other similar computer spreadsheet program shall be due annually on or before the effective date of this Agreement. Capacity utilized shall be calculated as follows:
 - 13.1 Based on the underlying assumptions on daily flows per Equivalent Residential Unit (ERU) used in the current City System Development fee calculation referred to in Article 7.
 - 13.2 The City and County may from time to time, increase the overall allocation of wastewater flow to the County, but the allocation shall not be less than the flows outlined herein for the service areas of this Agreement.
- 14. **Force Majeure** In case either Party to this Agreement by reason of Force Majeure shall be rendered unable wholly or in part to carry out its obligations under this Agreement, then if such Party shall give notice and full particulars of such Force Majeure in writing to the other Party within five (5) days of the existence of such Force Majeure, the obligation of the Party giving notice so far as it is effected by such Force Majeure shall be suspended during the continuance of the inability then claimed, but for no longer period, and such Party shall be required to resume performance of its obligation under this Agreement upon the termination of the aforementioned Force Majeure; provided, however, that the Party unable to perform shall use

its best efforts and act in good faith to overcome the impediment. No Force Majeure that renders any of the Parties unable to perform under this Agreement shall relieve a Party hereto of its obligation to make payments for wastewater services. The term Force Majeure as used herein shall mean acts of God, strikes, lockouts, or other industrial disturbances; acts of public enemy, orders of any kind of the Government of the United States or the State of North Carolina or any civil or military authority; insurrections; riots; epidemics; landslides; lightning; earthquake; fires; hurricanes; storms; floods; washouts; arrests; restraint of government and people; civil disturbances; explosions; breakage or accident to machinery, pipelines, or canals; or any other cause not reasonably within the discretion of the party having the difficulty.

15. **Dispute / Attorney's Fees -** If a dispute arises between the parties regarding breach of this Agreement or interpretation of any term hereof, the parties shall first attempt to resolve the dispute by negotiation followed by mediation if negotiation fails to resolve the dispute.

First, the City Manager and County Manager or other persons designated by each of the parties hereto will negotiate on behalf of the entities they represent. The nature of the dispute shall be reduced to writing and shall be presented to each designated representative who shall then meet and attempt to resolve the issue. If the dispute is resolved at this stage, there shall be a written determination of such resolution, signed by each authorized representative and ratified by the governing board of each party hereto, which resolution shall be binding upon the parties.

Second, if negotiation does not resolve the dispute within ten days of the reduction of issues to writing, the parties shall submit the matter to non-binding mediation. The parties shall attempt to agree on a mediator. If they cannot agree, the parties shall request a list of five mediators from an entity or firm providing mediation services or information. The parties will attempt to mutually agree on a mediator from the list provided; but, if they cannot agree, each party shall select one name and the selected mediators shall select a third name. The dispute shall be heard by the agreed mediator, or by a panel of three mediators if the parties have not agreed on a single mediator. Any cost of mediation shall be borne equally by the parties, who shall bear their own costs and fees therefore. If the disputed issues are resolved by mediation, a written determination of such resolution shall be signed by the duly authorized representative of each party, and approved by the respective governing boards.

Third, if disputes have not been resolved by negotiation or mediation, either party may proceed in the general courts of justice of the State of North Carolina, with the County of Davidson being the appropriate venue. In such an event, the prevailing party shall be entitled to its reasonable attorneys' fees as may be awarded in a legal proceeding, as well as all other recoverable costs, including costs of discovery.

- 16. **Information** The County shall, upon reasonable notice in writing given to it by the City, provide any information desired to assist the City in planning its wastewater collection and treatment system needs and necessary improvements.
- 17. **Invalid Terms** Should any one or more of the provisions contained in this Agreement be held invalid, illegal, or unenforceable in any respect, the validity, legality, and

enforceability of the remaining provisions contained in this Agreement shall not in any way be affected or impaired thereby, and this Agreement shall otherwise remain in full force and effect.

- Controlling Law / Successors Bound This Agreement and the rights and obligations of the parties hereunder shall be construed and interpreted in accordance with the laws of the State of North Carolina and shall be binding upon and inure to the benefit of the successors and, with consent of the other party, the assigns of either party hereto.
- 19. Counterparts This Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original.
- 20. Notices Any notices required or permitted in this Agreement, including address changes, shall be made in writing and shall be made either by mailing by registered or certified mail, return receipt requested, and postage prepaid, to the other party at the address shown herein for that party or at such different address for that party, notice of which has been properly given hereunder, or by personally delivering such a notice to an officer or other party. The notice, if mailed as provided for herein, shall be deemed given on the day of receipt or refusal to accept receipt, and if personally delivered, on the date of delivery. - 21. **Effective Date** Notwithstanding, anything herein to the contrary the parties hereto agree that the effective date of this Agreement shall be , 2023.
- 22. **Term of Agreement** The parties agree that this Agreement shall be for a fifty (50) year term with an option to extend the agreement for an additional fifty (50) years at the end of the initial fifty-year period, subject to the terms agreed to by the parties at that time. At the end of any term, in the absence of prior notice or negotiated renewal terms, this Agreement shall automatically renew each year on the anniversary date of its original execution or any such amendments until such notice is given by either party as described herein. The parties agree and stipulate that this agreement is of reasonable duration as required by N.C.G.S. §160A-461. Either party, 36 months prior to the end of the fifty-year term may give the other in writing notice of intent to terminate the agreement at the end of the fifty-year term.
- 23. City Right to Acquire County Allocation If, County choses to give up its wastewater allocation, the City may regain such wastewater allocation for use by City or for sale to another party. The County may not sell its wastewater allocation to another party without the

express approval of the City. In addition, if after 15 years of this agreement (beginning when wastewater system is operational), if the County has not allocated at least 50% of its wastewater capacity, the City reserves the right to enter into negotiations for acquisition of unallocated wastewater capacity. Thereafter, the City reserves the right to enter into negotiations to acquire unallocated wastewater capacity every 7 years. For negotiation purposes, the cost to purchase will equal the original County system purchase price of \$35,765,750 x current inflation rate / 1 MGD (to achieve a price per gallon which would be the selling price).

- **24. Entire Agreement** This Agreement reflects and contains the entire and only agreement between the parties relating to the subject matter herein, and as such supersedes all negotiations, commitments, and other agreements, whether oral or otherwise, including without limitation the Original Wastewater Agreement.
- 25. Amendments This Agreement may be amended only by an instrument in writing executed by both parties.
