COMMUNICATIONS:

Director Akers announced RACER Trust will be holding a public information session Thursday, May 18th regarding the water well restriction ordinance. If the ordinance passes the prohibition would only be subject to potable water.

Commissioner Ross stated he called in to report a “yucky” smell near the High School. Director Akers and Lockett when by and did not smell anything. There is an odor complaint hotline that notifies the County and State. Director Akers will forward the information to the Commission.

Director Akers shared an email he received from the Huron River Watershed Council (HRWC) from their aquatic ecologist. There has been growing interest in the last 10 years to deal with

lakeshore erosion through vegetative and soft engineering. Areas on Belleville Lake with erosion concern: Quirk and Denton and the backside of Van Buren Park Beach.

UNFINISHED BUSINESS:

Commissioner Ross asked about the “don’t eat the fish” signs. Director Akers will follow up with the HRWC to find out where the signs can be purchased.

NEW BUSINESS:

Hazardous Waste

Director Akers thanked the Commission members who were able to attend the Hazardous Waste Townhall meeting at WCCC. Representatives from Norfolk Southern, EPA, EGLE, and Republic were at the meeting. The Commission discussed tipping fees.

Solid Waste

The Township is working to transition solid waste collection. The Township Board approved the second reading of the ordinance. The Township is working with Waste Management on a draft contract.

Denton Road Bridge

The Township awarded the design bid for the Denton Rd Bridge to Fishbeck. The Township will meet with Fishbeck Thursday, May 18th to continue the process.

RACER Trust

As a part of the remediation work, RACER asked the Township to adopt a water well restriction ordinance for the area near Ecorse and Michigan Ave. No drinking wells were identified in this area.

ADW

There was an alliance of Downriver Watershed meeting they discussed outreach and testing efforts. This information will be forwarded to the commission.

ANNOUNCEMENTS/COMMENTS:

Commissioner Gibson asked how residents will be billed for trash collection. Trash collection will be split between the summer and winter tax bills.

Commissioner Merritt thanked Director Akers and Lockett for their work with Wayne County on mott/dirt roads.

Commissioner Gibson asked when the summer chloride applications start for the dirt roads. This depends on the weather conditions.
