#### **NEW BUSINESS:**

- Update the Recreation Committee By-laws:
   Director Zaenglein reviewed the by-laws from 2019, citing Article 3 Section 2 terms of
   the Student Representive, committee discussed and agree that the term should run
   concurrently with the school year which is September through August. Committee
   also discussed to change by-law wording to student representive applicant should be
   a local high school student. Article 4 Officers; correct typo Vic should be Vice.
   Committee agreed that the remaining wording in the current by-laws is acceptable
   as is.
- 2. Discuss draft 2021 Parks and Recreation update: Director Renaud provided members via email a draft Parks and Recreation Master Plan 2022-2026 requesting committee members to review and submit to her through email. Michigan Department of Natural Resources requires a 30 public comment period which will run from December 13, 2021 through January 11, 2022. The draft plan is available in the Community Services Department located at Township Hall and on the Township website <a href="https://cms9files.revize.com/vanburentwp/VB\_2022-2026-Parks-and-Recreation-Plan\_2021-1210.pdf">https://cms9files.revize.com/vanburentwp/VB\_2022-2026-Parks-and-Recreation-Plan\_2021-1210.pdf</a> after the public hearing is over proposed changes will be made and sent to the planning commission on January 12th and 18th. The master plan is a document that is required through the Michigan Department of Natural Resources for applying for grants.

#### **GENERAL DISCUSSION:**

### PARKS AND RECREATION UPDATES:

Director Zaenglein indicated all parks will be getting new eye-catching signage in 2022. Van Buren Park light poles were replaced through a light pole replacement program through DTE.

2022 budget was approved which includes replacing pavilion #1 and #3 at Van Buren Park. Pavilion rentals will be online through RecDesk software starting January 4, 2022. French Landing Phase one is complete walkways, perennial gardens and shade structure will be completed in the Spring of 2022. \$500,000 grant for the saddle project at Van Buren Park is complete with beautiful asphalt walkway, Director Zaenglein invited all committee members to check it out.
