**WAYNE COUNTY PROPOSITION J- TO RENEW THE MILLAGE AUTHORIZED IN 2012, SHALL WAYNE COUNTY BE AUTHORIZED TO CONTINUE TO LEVY THIS MILLAGE AT THE 2021 ROLLBACK RATE OF 9.358 MILS (ABOUT 94 CENTS PER THOUSAND DOLLARS OF TAXABLE VALUATION) FOR TEN MORE YEARS (2022 THROUGH 2031)**

**DISTRICT LIBRARY OPERATING MILLAGE PROPOSAL- THIS PROPOSAL WILL ALLOW THE DISTRICT LIBRARY TO LEVY ADDITIONAL MILLAGE IN THE CITY OF BELLEVILLE, CHARTER TOWNSHIP OF VAN BUREN, AND TOWNSHIP OF SUMPTER FOR LIBRARY OPERATING PURPOSES. SHALL THE LIMITATION ON THE AMOUNT OF TAXES WHICH MAY BE ASSESSED AGAINST ALL TAXABLE PROPERTY WITHIN THE GEOGRAPHIC BOUNDARIES OF THE BELLEVILLE AREA DISTRICT LIBRARY, WAYNE COUNTY, MICHIGAN BE INCREASED BY \$0.6864 ON EACH \$1000 OF TAXABLE VALUATION) FOR A PERIOD OF 15 YEARS, 2022 TO 2036.**
