Governor Abbott issue a proclamation on March 16, 2020 suspending various provisions of Chapter 551, Government Code, relating to Open Meetings.

A temporary suspension of the Open Meetings Act to allow telephone or videoconference public meetings has been granted by Governor Greg Abbott.
