Candidates must complete the application process must submit clean, clear copies of following documents by the closing date of the application. Unless otherwise prohibited by law must be presented at time of exam:

MINIMUM ELIGIBILITY REQUIREMENTS: Applicant must be a U.S. Citizen by birth or naturalization;
 Be at least 18 years of age and not more than 35 years of age at the time of hire;
 Be a graduate of an accredited high school or have an equivalency certificate;
 Valid Texas Driver's License;
 Be able to read, write, and speak the English language.

PREFERRED REQUIREMENTS: Texas Commission on Fire Protection Certificate or certifiable; National Registry and Texas Department of Health Certificate for Emergency Medical Technician/Paramedic, Emergency Medical Technician-Intermediate, or Emergency Medical Technician. *Among those who successfully pass the examination, interview and hiring preference will be given to candidates who meet the preferred requirements first and secondly by rank. *(Approved by Civil Service Commission on August 5, 2013.)*

- Military Discharge Papers (DD-214 form) which shows; (1) showing a minimum of 180 total days of active military service, and (2) an honorable discharge, in order to receive five (5) points in addition to his passing score on the written examination. General discharges under honorable conditions or any other discharges are ineligible to receive military points.
- Valid Texas Driver's license;
- Birth certificate;
- Social security card;
- High School Diploma, official transcript or Equivalency Certificate (G.E.D.) certified by the issuing Agency (TEA). College diplomas or transcripts will not substitute;
- College transcript, if applicable;
- Certification issued by the Texas Commission on Fire Protection, or certifiable
 - **Or** evidence of eligibility for certification (i.e. grading sheet from Texas Commission on Fire Protection indicating a passing score on written and practical examinations for basic firefighter certification).
 - **Or** evidence of current enrollment in a basic recruit fire training academy approved by the Texas Commission on Fire Protection.
- An EMT Basic/Paramedic, EMT Intermediate, or Emergency Medical Technician certificate issued by the Texas Department of State Health Services,
 - **Or**, National Registry
