

ORDINANCE NO. 2014-19
ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD,
IN THE COUNTY OF GLOUCESTER, NEW JERSEY, APPROPRIATING THE SUM OF
\$758,000 TO PROVIDE FOR VARIOUS CAPITAL IMPROVEMENTS AND RELATED
EXPENSES IN AND FOR THE TOWNSHIP

WHEREAS, the Governing Body desires to authorize various capital improvements and related expenses within the Township of West Deptford: and

WHEREAS, sufficient funds are available for said purpose from Capital Outlay, Capital Fund Balance and Capital Improvement Fund:

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey, that:

SECTION 1: There is hereby appropriated from the following sources the sum of \$758,000 to be used for the following capital improvements and related expenses within the Township of West Deptford:

Water & Sewer Operating Fund

SECTION 2: In connection with the amounts authorized in Section 1, the Township makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget of the Township is hereby amended.

SECTION 3: All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.
