

ORDINANCE #2015-02

AN ORDINANCE ESTABLISHING AN ATTENDANCE POLICY FOR ALL NON-ELECTED MEMBERS OF ANY BOARDS, COMMISSIONS AND/OR COMMITTEES FOR THE TOWNSHIP OF WEST DEPTFORD

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey that an Attendance Policy is hereby adopted in the Township of West Deptford applicable to all non-elected members of the various boards, commissions and/or committees.

14.1 Establishment

It is resolved by the Township Committee of the Township of West Deptford, County of Gloucester, and State of New Jersey that an Attendance Policy is hereby adopted in the Township of West Deptford applicable to all non-elected members of the various boards, commissions and/or committees.

14.2 Attendance at meetings required; removal

In the event that any non-elected member shall fail to attend three consecutive, regular, scheduled meetings, then that member(s) shall be automatically removed from said board, commission and/or committee without further notice, and the member's seat shall become vacant until a replacement is appointed as required by state or local law.

14.3 Medical absences exempted

Only significant medical absences/hospitalization shall be accepted in lieu of attendance on regular meeting dates. Such absences shall not be considered in a determination for removal as outlined above. Notification of any such medical absence must be provided to the board, commission and/or committee.

14.4 Employment absences exempted

A bona fide employment obligation may be accepted in lieu of attendance on regular meeting dates. Such absences may not be considered in a determination for removal as outlined above. Notification of any such employment absence must be provided to the board, commission and/or committee.


14.5 Applicability

Upon adoption of this policy, any other existing policy or procedure for attendance/removal as a non-elected member of any board, commission and/or committee


heretofore established, shall be declared null and void and only the provisions of this policy will apply to any non-elected members of any board, commission and/or committee for the Township of West Deptford unless removal and replacement is otherwise controlled by any state law applicable to said board, commission and/or committee.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
