

ORDINANCE No. 2015-09
ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD
AMENDING CHAPTER 163, "WATER" OF THE CODE OF THE TOWNSHIP OF
WEST DEPTFORD

BE IT ORDAINED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester, and the State of New Jersey, that Water Ordinance Chapter 163 of the Code of the Township of West Deptford is hereby amended as follows:

§ 163-5 Discontinuance of service.

- A. A turnoff charge of twelve dollars (\$12.) shall be made for discontinuing the service. A turn-on charge of twelve dollars (\$12.) shall be made when the service is restored.....
- D. Discontinuance by Township.
 - (2) A fee of twelve (\$12.) must be paid to cover the cost of shutting off water service and a twelve (\$12.) service charge must be paid for turning water service on.

§ 163-9 Charges and billings.

- A. Minimum rates. There shall be a minimum quarterly charge for all water passing through meters installed pursuant to the provisions of this chapter as follows:



R-Residential
C-Commercial

- B. Unmetered residential rate schedule. There shall be a quarterly charge of seven dollars and sixty-five cents (\$7.65) per one thousand (1,000) gallons for all water provided to residential units, which are unmetered. Unmetered residential units shall include but not be limited to apartments, condominiums, townhouses, and other multi-tenant dwellings, which are not individually metered, but where the entire building or complex has been metered.
- E. In all cases, there shall be a charge of twelve dollars (\$12.) for shutting off water service and a twelve (\$12.) charge for turning water service on.

BE IT FURTHER ORDAINED, that the above rates shall be effective July 1, 2015.


