

WEST DEPTFORD TOWNSHIP

ORDINANCE #2016-24

AN ORDINANCE AMENDING CHAPTER 160, ARTICLE X, SCHEDULES, SECTION 24, SCHEDULE I AND SECTION 31, SCHEDULE VIII OF THE CODE OF THE TOWNSHIP OF WEST DEPTFORD (VEHICLES AND TRAFFIC)

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey as follows:

Section 1: Chapter 160, Article X, Schedules, Section 24, Schedule 1: "No Parking Here to Corner", of the Code of the Township of West Deptford is hereby amended by adding the following streets:

Name of Street	Sides	Location
Grove Street	East	25' From corner of 102 Grove Street to intersection of Jessup Road
Evergreen Avenue	West	25' From corner of Evergreen to Grove Street
Grove Street	West	25" From corner of Woodland Avenue to Grove Street

Section 2: Chapter 160, Article X, Schedules, Section 24, Schedule 1: "No Parking", of the Code of the Township of West Deptford is hereby amended by adding the following streets:

Name of Street	Sides	Location
Grove Street	East	Between the properties known as 77, 82 and 102 Grove Street
Metropolitan Avenue and Mid-Atlantic Parkway	All	On each side to corner 25' from corner and East bound lane from the railroad to Metropolitan Avenue
Eagle Point Road	North	Between the intersection of Eagle Point Road and Peregrine Road to the Cul-De-Sac at Eagle Point Road-also referred to as "The Pointe"

Section 3. Chapter 160, Article X, Schedules, Section 31, Schedule VIII: "Stop" Intersection, of the Code of the Township of West Deptford is hereby amended by adding the following streets:

Name of Street	Location
Queen Street and Myrtle Avenue	Stop sign on both sides of Queen Street at intersection with Myrtle Avenue
Queen Street and Myrtle Avenue	Myrtle Avenue

Section 3. Repealer


All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 4. Severability:

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law
