

TOWNSHIP OF WEST DEPTFORD

ORDINANCE NO. 2018-10

AN ORDINANCE PROVIDING FUNDING FOR CAPITAL IMPROVEMENTS TO RIVERWINDS COMMUNITY CENTER LEISURE POOL AND LAP POOL FOR THE TOWNSHIP OF WEST DEPTFORD AND APPROPRIATING \$250,000 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST DEPTFORD, IN THE COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. The Township of West Deptford, in the County of Gloucester, New Jersey, authorizes capital improvements for the RiverWinds Community Center leisure pool and lap pool, including all work and materials necessary therefor and incidental thereto for the Township of West Deptford to be funded from the sources specified in Section 2 of the Ordinance.

Section 2. The amount of \$250,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the General Capital Improvement Fund in the amount of \$250,000.


Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Township determines the purpose described in Section 1 hereof is not a Current Expense and is a capital purchase which the Township of West Deptford may lawfully make as a general improvement.

Section 4. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.


BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
