

WEST DEPTFORD TOWNSHIP

ORDINANCE #2019-13

AN ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD VACATING A PORTION OF FIFTH STREET BETWEEN CENTER STREET AND MIFFLIN STREET

BE IT ORDAINED by the Mayor and Committee of the Township of West Deptford, in the County of Gloucester, and State of New Jersey as follows:

Section 1. The Township of West Deptford does hereby vacate any right, title, or interest in and to that portion of Fifth Street between Center Street and Mifflin Street situated in the Township of West Deptford, County of Gloucester, and State of New Jersey more particularly described and identified in the legal description attached as Exhibit A.

Section 2. Pursuant to N.J.S.A. 40:67-1(b), all rights and privileges, if any, presently possessed by the Township of West Deptford, and/or Water & Sewer Department, any public utilities and any cable television company to maintain, repair, and replace their existing facilities in, adjacent to, over or under the public streets herein vacated, are hereby expressly reserved and excepted from vacation.

Section 3. Pursuant to N.J.S.A. 40:67-21, a certified copy of the within Ordinance shall be filed with the Gloucester County Clerk and recorded in the Book of Vacations in the office of said Gloucester County Clerk within sixty (60) days after the within ordinance is finally adopted and becomes effective.

Section 4. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 5 Severability:

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

Section 6

Effective Date: This Ordinance shall take effect immediately upon final

passage and publication as required by law.
