ORDINANCE 2023-15

ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD AMENDING CHAPTER 118, PARKS AND RECREATION, OF THE CODE BOOK OF THE TOWNSHIP OF WEST DEPTFORD, BY ADDING A NEW ARTICLE TO BE ENTITLED "FIELD, EVENT AND FACILITY USE APPLICATION"

WHEREAS, the Township of West Deptford has various fields and facilities for use by the Township and public; and

WHEREAS, the Township has events and/or approves other non-Township sponsored events at various fields and facilities; and

WHEREAS, any organization, group and/or individual requesting use of the Township fields or facilities or wanting to hold an event, must first obtain approval from the Township for such use and/or event; and

WHEREAS, the Township has a Field, Event and Facility Use Application that must be completed and submitted to the Township for approval for any such use or event.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester, State of New Jersey, that Chapter 118, Parks and Recreation, is hereby amended by adding a new Article as follows:

Section 1. Title. The new Article shall be entitled "Field, Event and Facility Use Application."

Section 2. Purpose. A Township Field, Event and Facility Use Application must be completed by any group, organization, and/or individual requesting use of the Township's fields and facilities and/or for any event which must first be approved by the Township.

Section 3. Violations and penalties. Any organization, group and/or person violating any of the provisions of this Article shall, upon conviction, be subject to the penalty in § 1-15, Violations and penalties, of the Code of the Township of West Deptford.

Section 4. Repealer.

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 5. Severability.

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
