**Meeting**

1. Public Hearing on a proposed rezoning of 99999 North Merrimon Avenue from R-43 to C-S zoning. Proposed rezoning was recommended unanimously by the Planning and Zoning Board and has staff's support. Public Hearing opened at 7:07 and closed at 7:08 with no comment.
2. Consideration of a proposed rezoning of 99999 North Merrimon Avenue from R-43 to C-S zoning. Alderman Lunsford made a motion to approve the rezoning. Alderman Honeycutt seconded and all voted unanimously.
3. Public Hearing on a proposed Major Subdivision known commonly as Olivette. Proposed Major Subdivision was recommended unanimously by the Planning and Zoning Board and has staff's support. Public Hearing opened at 7:11 and closed at 7:12 with no comment.
4. Consideration of a recommendation on a proposed Major Subdivision known commonly as Olivette. Alderman Angel made a motion to approve the subdivision. Board Member Honeycutt seconded and all voted unanimously.
5. Consideration of a modification to Chapter 152: Outdoor Lighting. Proposed modification would allow for gas lamps to be used as street lighting provided that they are not deemed by the Board of Alderman to be a burden to adjacent property owners or the motoring public. Alderman Lunsford made a motion to approve the modification. Alderman Angle seconded and all voted unanimously.
