In the event the balance of the license fee is not paid on or before July 1 of the license year, the license shall be deemed to have terminated on July 2 of the license year, without further action by the Village.

If a completed license application is not submitted together with the required license fee prior to January 1 in a given year, the license fee shall be increased by an additional twenty percent (20%); and further, the base license fee shall be increased by an additional twenty percent (20%) on the first of each subsequent month, until such time as a complete license application and the required license fee is paid.
