

# DuPage County Tax Code Comparison

## Taxing Body Comparison

This document includes a comparison of the Woodridge Taxing Bodies to their counterparts within DuPage County for the 2007 tax levy year. The Village Board's focus on reducing the tax rate over the past 22 years has allowed Woodridge to remain in the lowest quartile of the DuPage community tax rates in 2007 with its ranking at 7th lowest of the 35 communities.

The progress since 1990, when Woodridge was ranked 20th lowest for Tax Code 8048 and 17th lowest for both Tax Codes 9148 and 9342, shows that the tax rate decreased \$.34 and \$.33 respectively, over the last seventeen years.

The current Woodridge tax rate of 0.2342 is 50% of the average municipal tax rate of 0.4710. When comparing level of change, Woodridge ranks 5th and 6th.

## Did you Know There are Tax Exemptions for Senior Citizens?

In fact, there are three (3) real estate tax exemptions that may be available to senior citizens who own and occupy their property.

The following is a brief description of each exemption, followed by contact information to request additional information on these exemptions:

- 1) Senior Citizens' Homestead Exemption provides for a maximum of a \$3,500 reduction in the equalized assed valuation.
- 2) Senior Citizens' Assessment Freeze Homestead Exemption provides seniors with limited income, protection against real estate taxes due to rising property values (not tax rates).
- 3) Senior Citizens' Real Estate Tax Deferral Program allows seniors with limited income and who meet other qualifications to defer payment of real estate taxes.
